UPDATES ON NYC 311 and NYC.GOV

The Department of Information Technology and Telecommunication (DOITT) have made many improvements and introduced initiatives to improve customer services. On NYC.gov you can now look up the status of a 311 service complaint within 45 days of the initial complaint. Go to the right navigation column of the screen for the 311 Service Request Look-up link. Also, new to the City website is the Citywide Performance Reporting Data (CPR). This online tool lets you access and review data, review statistics on how well City agencies are performing. You can also access “My Neighborhood Statistics” from this site which allows you to see data by Community Board.

The City has also initiated a pilot program not yet available in our area which will allow you to register to receive e-mail from the Office of Emergency Management on various conditions throughout the City.

The Mayor’s Scout Program is in full operation. Agency reps are identifying quality of life problems throughout the City and reporting them to 311 operators. By the summer, they will have data available by Community Board of locations that have been reported. This information will help us track problems and further help the community resolve complaints.
