**NYPD Community Affairs Summer Youth Police Academy Applications April 2015**

The Youth Police Academy will provide those participating in the program with lunch and uniform shirts. The Academy is a six (6) week program that will hold sessions four (4) days a week. From 8:30 am - 2:00 pm. Students will attend classroom sessions with lectures, role-plays and topical demonstrations by police officers in the areas of law, behavioral science, drug prevention and gang resistance. Field trips to a Police Department facility or a City park are also part of the curriculum. Transportation to and from the field trips will be provided. **Parks Special Event Permit**

From the smallest birthday party to the largest concert, special events take place every day in New York City parks. If you want to have any activity in a City park with more than 20 people, or where you would like to reserve a specific area within a park, you need to apply for a special event permit.

**Things to Know Before You Apply**  
Special Events permits cost \$25 to process, and the fee cannot be waived. We will do our best to give you what you request, but this money is not refundable. Also, we need 21-30 days to process a permit request, so make sure you plan ahead. We are not able to issue permits for major holiday weekends, as we keep spaces clear for public use on a first-come, first-served basis on those days.
