



New Kosciuszko Bridge Construction

NOTICE

▶ TEMPORARY CLOSURE OF 56th ROAD, between Laurel Hill Boulevard and 43rd Street

Thursday, July 21st and Friday, July 22nd

7:00 a.m. – 4:00 p.m.

(weather permitting)

Please look for and observe all construction signs and barriers so that work can proceed in a timely manner.

The New York State Department of Transportation (NYSDOT) has awarded a \$555 million contract to construct Phase 1 of the new Kosciuszko Bridge. On July 21st and 22nd, from 7:00 a.m. to 4:00 p.m. each day (weather permitting), NYSDOT will:

- close 56th Road in both directions, between Laurel Hill Boulevard and 43rd Street, for installation of utilities and work on the new bridge deck. Variable message signs and traffic enforcement agents (TEAs) will be used to manage traffic during this operation. In addition, parking will be restricted on 43rd Street, 56th Road and Laurel Hill Boulevard, as shown on the accompanying map.


Detours:

- 1) Motorists traveling westbound on 56th Road should turn right onto 43rd Street, left onto 54th Road and left onto Laurel Hill Boulevard to 56th Road.
- 2) Motorists traveling eastbound on 56th Road should turn left onto Laurel Hill Boulevard, right onto 54th Road and right onto 43rd Street to 56th Road.

The new Kosciuszko Bridge will improve traffic safety, reduce congestion and improve travel speeds. Enhancements to the roadway will include extra lanes, wider lanes and a reduced incline creating longer sight lines and increased visibility. The project will also include a new bikeway/walkway on the bridge; new parks and open spaces; improved access to the waterfront; and enhancements to local streets. The project is part of the New York Works Program, created to generate jobs and increase economic development.

The project team will make every effort to minimize impacts during this large construction project. However, some disruption and inconvenience typically occur on any construction project, including changes to vehicular and pedestrian traffic patterns, loss of parking, noise, vibrations, and dust. To promptly and proactively address community concerns, NYSDOT has hired a full-time **community liaison, Christine Holowacz**.
