INTRODUCTION

The annual Statements of Community District Needs (CD Needs Statements) and the Community Board Budget Requests (Budget Requests) are Charter requirements and an integral part of the City's budget process. When developed through informed planning and careful consideration, CD Needs Statements and Budget Requests can play an important role in consultations of community boards with agencies, elected officials and other key stakeholders on a broad range of local planning and budget priorities. These tools also provide a valuable public resource for neighborhood planning and research purposes, and are used by a wide audience seeking information about New York City's diverse communities.

This year, for the first time, community boards electronically submitted a CD Needs Statement combined with their Budget Requests. The goal of these improvements is to simplify preparation of both documents for the community boards and to make the information community boards provide more easily accessible for City agencies and other stakeholders. Simplified and more efficient processes will allow all parties involved in the budget process to consider budget decisions more thoroughly, with better results for all New Yorkers.

2. OVERVIEW OF COMMUNITY DISTRICT

Queens Community Board 4 provided the following overview of their district:

Community Board # 4Q (CB#4Q) is a culturally diverse community that encompasses the areas of Corona (south of Roosevelt Avenue) and Elmhurst with a total land area 2.4 square miles, bounded by Roosevelt Avenue to the North, Flushing Meadow Corona Park to the East, Horace Harding Expressway to the South, and New York Connecting Railroad (CSX) to the West. According to the 2010 Census, at the time the population of CB #4Q was 172,598 a 3.3% increase from the 2000 Census. With the steady growth in population over the past twenty years and the vast amount of new building permits issued, the actual population has more than likely exceeded the 200,000 mark. Due to the fact that service levels are based in part on Census information, it is imperative that adequate funding be provided to the residents of CB#4Q. Service agency budgets must be increased to keep pace with our growing population. The ongoing problem of over development continues to grow within CB#4Q. It is not uncommon that older housing stock, (one and two family homes) are demolished and replaced with new buildings that house three and four family homes. The current levels of service and infrastructure can no longer absorb the additional housing units. In order to secure the future stability of CB#4Q, careful consideration must be given to the rezoning of our community. The over-usage of already limited City Services will only continue to have a detrimental effect on our youth population. Overcrowded schools are common ground, after school programs are limited, and the few libraries within our vicinity are used far beyond capacity. Our youth cannot become responsible adults without the proper resources provided to them. We cannot turn a blind eye, and will continue to advocate for a safe, affordable, and well balanced environment for our residents.

3. MAIN ISSUES

As part of this year's process, community boards were asked to select from a list the three most pressing issues facing their district. Queens Community Board 4 identified the following three issues:

- *Schools*
- *Quality of life issues and neighborhood preservation*
- *Traffic*

Queens Community Board 4 provided the following explanation for their choices:

The ongoing problem of overdevelopment continues to grow within CB#4Q. It is not uncommon that older housing stock, (one and two family homes) are demolished and replaced with new buildings that house three and four family homes. The current levels of service and infrastructure can no longer absorb the additional housing units. In order to secure the future stability of CB4Q, careful consideration must be given to the rezoning of our community. The over-usage of already limited City services will only continue to have a detrimental effect on our youth population. Overcrowded schools are common ground, after school programs are overcrowded, and the few libraries within our vicinity are used far beyond capacity. Issues pertaining to traffic, education, pollution, and health care are all a result of the severity of the overdevelopment of the district.

4.1. Health Care and Human Services Needs and Requests

Main Issue

New or renovated health facilities

The Community Board provided the following explanation for the above issue:

The utter lack of medical facilities within the district is cause for major concern. With the closing of St. John's hospital, Elmhurst Hospital despite potential expansions is operating well over full capacity. The feasibility of another major hospital is indeed far-fetched, but if nothing else, a medical facility of any kind to alleviate the constant influx of patients at Elmhurst hospital would be a very welcome addition to the District.

Community District Needs and Requests

4.1.1. Community District Needs and Requests Related to Health Care Facilities and Programming

The Community Board provided the following high level comments and background on the District's needs:

With Queens' continued rise in popularity and of course population, health concerns become an issue. The lack of medical facilities within the district continues to be a cause for major concern. St. John's Hospital has now been closed for half a decade, and the property has been sold and repurchased numerous times with no real progress. An all too common practice has surfaced within our district specifically in Elmhurst, in which foreign-based developers with no knowledge of the surrounding community will buy, flip, and resell much needed land within our district. The former St. John's is one such example. Elmhurst Hospital despite expansions is operating over full capacity, and while we welcome the notion of urgent care facilities on a local level, the necessity of a proper hospital cannot be undermined. With the support of our elected officials, CB4 will be at the forefront of bringing these property owners to light, and to be sure that the community's voices are heard.

Main Issue

Capacity of educational facilities

The Community Board provided the following explanation for the above issue:

Although New York City as a whole will experience a downward trend in school enrollment in the next ten years, the school district encompassing CB#4Q will see an upward trend in enrollment. Schools cannot be built fast enough. We will continue to support the Department of Education and the School Construction Authority in their efforts to identify additional new sites for schools.

In addition to additional schools, CB4Q is in dire need of inter-generational programs. After school centers are virtually non-existent. In a day when social media smart phones and video games reign above all else, the majority of our youth today lack basic social skills that can only be obtained through communal activities and physical social interaction with each other. A new accepted practice to the district is the implementation of a senior center with a pre-kindergarten/day care center in its vicinity.

Community District Needs and Requests

4.3.1. Community District Needs and Requests Related to Policing and Crime

The Community Board provided the following high level comments and background on the District's needs:

Currently the 110th Precinct is housed in an antiquated building with no facilities for parking of police vehicles. A new Precinct house along with adequate parking is a necessity. We will continue to support the relocation and building of a new precinct house for the 110th Precinct, which should be located as close as possible to the geographic center of Community Board #4Q. After the opening of the new Precinct, the existing Precinct house could be utilized for NYPD special operations. With the limited resources allotted to the 110th Precinct, the agency is doing a great job protecting the public. The population of CB #4Q is growing daily, and so additional funding is necessary in order to increase staffing levels in the 110th Precinct to keep pace with our rapidly growing population. The 110th Precinct is not coterminous with CB # 4Q; the precinct covers Willets Point (CB # 7Q) and Flushing Meadows Corona Park which is home to the NY METS at Citifield, the USTA National Tennis Center, Queens Theater In The Park, The Hall of Science, The Queens Zoo, The Queens Museum, and the Aquatic Center. The Park is also host to many large cultural events and it is used by the residents of Queens on a daily basis, with weekends seeing the largest concentration of park visitors. In order to protect New York City's investment in this park permanent Police presence must be established to serve Flushing Meadows-Corona Park and Willets Point exclusively.

4.4. Core Infrastructure and City Services Needs and Requests

Main Issue

Sewer capacity

The Community Board provided the following explanation for the above issue:

Over the past years Queens Boulevard has experienced an inordinate amount of development. High rise commercial and residential developments have replaced the typical low rise development along Queens Boulevard and many new high rise developments are in the planning stages. Business owners, residents, and the now closed St. Johns Queens Hospital have reported flooding that is progressively worsening each year. The sewer drainage system currently in place is not able to process the demand placed on it. A complete study, reconstruction, and upgrade of the existing sewer infrastructure should be implemented. Our residents and business owners must be relieved of the stress and economic loss caused by the constant flooding.
