# Quarterly Report on Homeless Deaths # 11 New York City Department of Health and Mental Hygiene Bureau of Vital Statistics Local Law 63 of 2005 January 1, 2008 – March 31, 2008

**Introduction.** This report has been prepared and submitted pursuant to Local Law 63 of 2005 (LL63) amending the Administrative Code of the City of New York to track and report deaths of homeless persons in the City of New York. Data contained in this report are for the quarter period of January 1, 2008 – March 31, 2008 and were provided by the NYC Office of Chief Medical Examiner (OCME), the NYC Department of Homeless Services (DHS), the NYC Department of Housing Preservation and Development (HPD) and the NYC Human Resources Administration (HRA) to the NYC Department of Health and Mental Hygiene (DOHMH).

DHS, HPD and HRA maintain records on the homeless individuals for whom they provide temporary housing in New York City. OCME, through its responsibilities investigating NYC deaths, investigates the deaths of some homeless individuals. Data from these agencies were compiled, matched against NYC death certificates and analyzed by the DOHMH Office of Vital Statistics and are presented herein.


**Definitions.** As defined in LL63, a "homeless person" is a person who at the time of death did not have a known street address of a residence at which he or she was known or reasonably believed to have resided. A "homeless shelter resident" is "a person who at the time of death lived in a homeless shelter. A "homeless shelter" is "(i) a residence operated by or on behalf of the department of homeless services; (ii) an emergency residence operated by or on behalf of the department of social services/human resources administration which is available primarily for homeless persons with HIV or AIDS related illness; or (iii) a residence operated by or on behalf of the department of housing preservation and development to the extent that such residence houses clients of the department of homeless services; provided, however that such term shall not include any residence that is available primarily for battered women."

**Methods.** Based on definitions above, incident reports were provided by OCME, DHS and HPD. Information from corresponding NYC death certificates were used to validate agency reports and remove any duplicates among them (i.e. when DHS cases are also OCME cases). HRA did not disclose any identifiable information on HRA homeless residents, per Article 27-F of the New York State Public Health Law, which prohibits disclosure of information that could reasonably identify someone as having an HIV-related illness or AIDS. As a result, HRA homeless deaths cannot be combined with DHS, HPD and OCME deaths and total NYC homeless deaths cannot be ascertained.

## DEATHS OF HOMELESS PERSONS AND HOMELESS SHELTER RESIDENTS Reported Homeless Deaths

OCME, DHS and HPD reported a total of 61 homeless deaths between January 1 and March 31, 2008. This quarter's total is the highest since this report was initiated. Of the total reported this quarter, 56 were investigated by OCME. On average, over the previous 10 quarters, 38 deaths have been reported per quarter. Deaths have ranged from 22 to 57 during the previous 10 quarters. There were 51 deaths last quarter.

The trend chart below looks at deaths over all 11 quarters. Quarters 1-4 were included in the first annual report, and quarters 5-8 were included in the second annual report. The data for quarters 9, 10, and 11 are preliminary, and the numbers may change with late reporting. Any changes in these and future quarters will be reflected in the annual report.



Twenty-three of the 61 deaths occurred in Manhattan, 13 in the Bronx, 16 in Brooklyn, 8 in Queens, and 1 in Staten Island.

HRA reported 9 homeless deaths this quarter; 9 were also reported in the previous quarter (Table 1). Among the 9 HRA deaths reported, 2 were in Manhattan, 2 in the Bronx, 4 in Brooklyn, 1 in Queens, and none in Staten Island.

#### Decedent Shelter Residency Status and Shelter Location

Among the 61 OCME, DHS and HPD-reported homeless deaths, 21 (34%) were reported to have been a resident of a shelter system at the time of death, and 40 (66%) were not sheltered (Table 1). Of the 21 sheltered, 8 died in Manhattan, 4 in the Bronx, 7 in Brooklyn, 2 in Queens, and none in Staten Island. Of the 40 unsheltered, 15 died in Manhattan, 9 in the Bronx, 9 in Brooklyn, 6 in Queens, and 1 in Staten Island.

The percent of sheltered decedents over total decedents has ranged from 35% to 86% during the previous 10 quarters. Of the 21 sheltered homeless decedents identified by OCME, DHS and HPD this quarter, 5 were sheltered in Manhattan, 6 in the Bronx, 8 in Brooklyn, 2 in Queens, and none in Staten Island (Table 2).

Please note that HRA reports residents living in Single Room Occupancies (SROs) as homeless sheltered residents. SROs are not homeless shelters. These decedents had been provided with temporary emergency housing and, according to LL63 definition, are classified as homeless sheltered residents.

#### Homeless Decedents Investigated by OCME

Among the 61 homeless deaths reported by OCME, DHS and HPD, 56 (92%) were investigated by OCME (Table 1). The OCME investigated 81% of the sheltered homeless deaths, and 98% of the unsheltered homeless deaths. The 1 unsheltered homeless death that was not investigated occurred in a hospital while the decedent was undergoing DHS housing placement. While the percent of deaths investigated by the OCME fluctuates, communication amongst OCME, DHS, and DOHMH has improved. As a result of the initiatives discussed in the first annual report, a Memorandum of Understanding between DHS and DOHMH was signed to permit detailed data sharing. OCME also notifies DHS in real time of every suspected homeless death.

#### Homeless Decedent Location of Death by Borough and Community District

The location of OCME, DHS and HPD-reported deaths (i.e. in shelter, in a hospital, outdoors or other), disaggregated by borough, community district and shelter residency status, are shown in Table 3. HRA homeless deaths by location of death are presented separately in Table 4 by borough only, as required by LL63.

Among the 61 OCME, DHS and HPD deaths, 7 (11%) occurred at a shelter, 30 (48%) in a hospital, 6 (8%) outdoors and 18 (33%) in an "other" location. The number of homeless decedents who died outdoors has ranged from 3 to 20 decedents per quarter over the previous 10 quarterly reports. Those who died in "other" locations have ranged from 1 to 11 decedents per quarter. Among the 6 outdoor deaths reported this quarter, 1 was in Manhattan, 1 in the Bronx, 1 in Brooklyn, and 3 were in Queens. Among the 18 "other" location deaths, 4 died in Manhattan, 6 in the Bronx, 5 in Brooklyn, 2 in Queens, and 1 died in Staten Island.

The distribution of location of death among the 21 sheltered homeless decedents was as follows: 12 died in the hospital, 7 died at the homeless shelter, 1 died outdoors, and 1 in an "other" location (Table 3). The 1 sheltered outdoor death was found on the street. The 1 "other" death was found on subway tracks.

The distribution of location of death among the 40 non-sheltered was as follows: 18 died in a hospital, 5 outdoors and 17 in "other" locations. Among the 5 non-sheltered outdoor deaths, 1 was found in a trailer, 1 in an outdoor stairwell, 1 below a bridge, 1 on a concrete porch, and 1 in an encampment. Among the 17 "other" deaths, 7 were found in a friend's apartment, 2 in abandoned buildings, 2 in subway stations, 2 in subway trains, 1 in a building stairwell, 1 in a drop-in center, 1 in a store basement, and 1 in a building vestibule.

All 9 of the HRA-reported homeless persons' deaths were residents of SRO housing and as such defined as sheltered, when they died. Four were reported as dying in the hospital, 3 in an HRA

emergency housing facility (shelter), 1 in an "other" location (struck by a subway train), and 1 in an unknown location (Table 4).

Deaths reported by OCME, DHS and HPD cannot be added to deaths reported by HRA. As stated above, death certificates for HRA-reported homeless persons' deaths may not be identified by law and may duplicate reports from OCME.

#### Homeless Decedents' Age and Gender by Borough and Community District

Of the 61 OCME, DHS and HPD deaths, 44 (72%) were male and 17 (28%) were female (Table 5). Four (7%) were infants, between 2 and 5 months of age. All were sheltered residents and were investigated by OCME. In each of the previous 3 quarters, 1 infant death was reported, with 6 infant deaths in the April 1 – June 30, 2006 quarter being the highest reported.

Eleven (18%, 6 male and 5 female) were between the ages of 25 and 44 years. Another 33 (54%, 26 male and 7 female) were between the ages of 45 and 64 years, and 13 (21%, 10 male and 3 female) were older than 65 years of age.

Of the 9 HRA homeless decedents, 7 (78%) were male and 2 (22%) were female. All were between 25 and 64 years of age. The age and gender distribution by borough is shown in Table 6.

#### **Comments**

The 61 OCME, DHS and HPD deaths in this quarter is the highest reported of any quarter. Last quarter (October 1 – December 31, 2007), 51 OCME, DHS and HPD deaths were reported. That was the highest reported since the October 1 – December 31, 2005 quarter (57). 34 percent of decedents were sheltered this quarter, which is the lowest reported of any quarter. Agency investigation and future reports will help determine whether these trends reflect true trends or more accurate reporting based on improved communication amongst OCME, DHS, and DOHMH.

This quarter also reported the highest number of deaths in "other" locations (18). This category may need to be further refined, since many in this category are found in friends' apartments or subway stations/tracks/cars.

HRA homeless sheltered deaths are reported separately and should not be added to other homeless sheltered deaths as there may be duplication. To comply with Article 27-F of the New York state Public Health Law which prohibits disclosure of any information that could reasonably identify someone having an HIV related illness or AIDS, personal identifiers on HRA homeless deaths were not provided; hence corresponding death certificates could not be reviewed to determine whether deaths were also reported by OCME.
