Job Description

DoITT is responsible for modernizing, unlocking, and innovating to improve IT infrastructure and service delivery in New York City government. Modernizing by implementing state-of-the-art information technology to improve services to New Yorkers. Unlocking by making government more transparent and accountable to New Yorkers. Innovating by employing cutting-edge tools, methods, and relationships to empower New Yorkers.

The successful candidate will serve as an Application DBA Manager reporting to the Enterprise Application Services division.

Responsibilities will include: Manage and oversee the implementation of database designs; oversee the creation of database objects (tables, indexes, etc.); oversee the development of database procedures, functions and triggers; assist developers with database activities; tune/optimize database queries for enhancements; oversee the establishment of documentation and standards; plan growth and changes (capacity planning); provide consultation to development teams; interface with Oracle Corporation for technical expertise; oversee Patch Management and Version Control; oversee application related jobs and data replication activities; build and run data cleanup routines; build and run data load process management; oversee the creation and execution of adhoc queries and reports for users; coordinate execution of break fixes in the production and non-production environments; deploy releases in different environments (TST, STG and PRD); oversee the provisioning of users; oversee the creation of usage reports; engage with the development teams to provide management expertise for the design of new applications; ensure deliverables from the development teams have proper information for deployment; work with development team to ensure application code matches server software stacks and specifications; work with development and QA teams; prepare senior level technical reports for executive management; and manage special technology projects and initiatives as assigned. The position's responsibilities include commitment to and compliance with the City's EEO policy.

Minimum Qualification Requirements

A master's degree in computer science from an accredited college and three years of progressively more responsible, full-time, satisfactory experience using information technology in computer applications programming, systems programming, computer systems development, data telecommunications, database administration, planning of data/information processing, user services, or area networks at least 18 months of this experience must have been in an administrative, managerial or executive capacity in the areas of computer applications programming, systems programming, systems development, data telecommunications, data base administration, or planning of data processing or in the supervision of staff performing these duties; or 2. A baccalaureate degree from an accredited college and four years of experience as described in "1" above; or

3. A four-year high school diploma or its educational equivalent approved by a State's department of education or recognized accrediting organization and six years of experience as described in "1" above; or

4. A satisfactory combination of education and experience equivalent to "1", "2" or "3" above. However, all candidates must have at least a four-year high school diploma or its educational equivalent approved by a State's department of education or recognized accrediting organization and must possess at least three years of experience as described in "1" above, including the 18 months of administrative, managerial, executive or supervisory experience as described in "1" above.

NOTE: The following types of experience are not acceptable: superficial use of preprogrammed software without complex programming, design, implementation or management of the product; use of word processing packages; use of a hand held calculator; primarily the entering or updating of data in a system; the operation of data processing hardware or consoles.

The preferred candidate should possess the following: A Bachelor's degree in a related IT field; 5+ years of experience in a DBA role that includes implementation of large scale n-tier web applications; database experience with Oracle 9i/10g or MySQL Server 2005/2008 or MySQL (Oracle preferred); strong knowledge of Unix scripting; understanding of complex systems; excellent attention to detail; should be highly self-motivated and flexible; strong customer and quality-focus is required; sound problem resolution, judgment, and decision-making skills required; experience with object oriented development using UML; vignette Portal 7.3, 7.4 development experience; web development experience in .NET or Java; experience with Sun Web Server and other J2EE application server such as Oracle WebLogic, Tomcat, JBOSS, WebSphere; MS Office; demonstrated experience working with technical and non-technical staff; exceptional knowledge of Microsoft Office programs; outstanding collaboration and team building skills; strong written and verbal communication skills; excellent analytic, organization, presentation and facilitation skills; ability to manage multiple tasks under tight deadlines; and the ability to interface with executive level management and give senior level presentations.
