<u>JOB DESCRIPTION</u>		
<p>The Office of the Actuary (OA) is a small agency with fifty workstations networked to clustered file servers. The Certified Local Area Network (LAN) Administrator Level II will serve as the OA's network systems administrator and will report to the Director of Administration. Responsibilities include providing certified technical support in all areas of LAN management and maintenance. This comprises performance monitoring of all network operating systems, troubleshooting and resolving network and workstation software application and hardware problems, checking, testing and installing updates and patches for all applications, ensuring backup of network files. The position will be responsible for providing operational and administrative support to end-users and will interface with the OA's data management partners (e.g., the New York City Retirement Systems, City University of New York and NYC Department of Information Technology and Telecommunications). Will research and assist in implementation of special data management projects as directed.</p>		
<u>PREFERRED SKILLS</u>		
<p>The preferred candidate will have: solid technical knowledge of Windows 2000 Server or later, Exchange 2000 Server or later, Microsoft Office Professional 2000 or later, Active Directory, Group Policy, TCP/IP, DHCP, WINS and DNS. Familiarity with LAN/WAN Internet working principles important. Must be attentive to details. Must have ability to articulate to end-user community in clear, concise and understandable terms.</p>

A baccalaureate degree, from an accredited college or university and two (2) years of satisfactory full-time (not classroom-based) experience in local area network planning, design, configuration, installation, troubleshooting, integration, performance monitoring, maintenance, enhancement and security management, or 2. A four-year high school diploma or its educational equivalent and six (6) years of satisfactory full-time (not classroom-based) information technology experience of which at least 2 years must have been described in "1" above; or 3. A masters degree in computer science or a related field from an accredited college may substitute for 1 year of satisfactory full-time (not classroom based) information technology experience as described in "1" above.
