**JOB DESCRIPTION**

The Information Technology Division is seeking an Assistant Commissioner of Software Architecture Applications who will be a key member of the IT management team, reporting to the CIO and managing a staff of approximately 30 staff and consultants engaged in the development and support of software applications. The existing application environment includes systems developed using J2EE, DB2, Cognos, as well as legacy applications developed using ADMINS, C, and VB. Besides web-based applications, the Department develops systems using video surveillance, IVR, and biometrics. The ideal candidate will be an experienced hands-on leader who can manage a team, provide strategic direction, and manage independent technical consultants as well as complex vendor development engagements. Demonstrated experience with any software development process and working knowledge of criminal justice systems is highly desirable.

**QUALIFICATION REQUIREMENTS**

1. Six (6) years of progressively responsible full-time paid experience supervising or administering computer operations involving a large-scale third generation computer at least 18 months of which shall have been in a managerial capacity.
2. Education at an accredited college or university may be substituted for the general experience described above (but not for the 18 months of managerial experience described above) at the rate of one year of college for 6 months of experience up to a maximum of 4 years college for 2 years or experience. In addition a Master of Business Administration, Master of Public Administration or any other Master's Degree in Management of Administration may be substituted for an additional year of general work experience. However, all candidates must possess the 18 months of administrative or managerial experience or managerial experience described above.
