JOB DESCRIPTION

Under direction from the Deputy Director of Information Technology and other supervision, the candidate will install, maintain and repair the fiber and copper cable and line network, and all related items, for all Department of Correction facilities. This work includes installing, splicing, terminating, testing and troubleshooting Cat3 through Cat6, Coax, and Fiber optic cable; working as a team and performing assignments with other technicians in the setup, maintenance and operation of all network and telephone systems; working on daily "trouble tickets", as well as project plans of varying complexity, under the supervision of a project manager; keep records and make reports based on direction from supervisor; Current projects include the installation of an IP Security Camera system in all Jail Facilities for the Department of Correction, and the ongoing maintenance of this project. Some of the physical activities performed by the candidate and the environmental conditions experienced are: Walking to and from sites, climbing and descending ladders and stairs, standing and stooping for extended periods of time, working in confined areas, distinguishing colors, communicating orally, carrying various tools and equipment weighing 50 Lbs or more, lifting and lowering 70lbs or more of various items, climbing over various objects, working underneath trailers, working outdoors in all types of weather, working aerial or underground jobs, driving vehicles to and from sites, working nights and weekends, working an on call schedule that requires 24/7 access. Knowledge of Cat3 through Cat6 cable and Fiber Optic technology required. Knowledge in Cisco Networking (Technology, Switches, Routers, POE, etc) preferable. Knowledge of PBX systems, POTS technology, and T1 circuits preferable. Familiarity with Copper and Fiber testing equipment preferable. Familiarity of IP Video/Camera and related technology is desirable.

QUALIFICATION REQUIREMENTS

1. Five years of full-time, satisfactory journey-level experience, acquired within the last ten years, in the maintenance, installation, or repair of telephone communications systems and equipment; or
2. Four years of full-time experience as described in "1" above, plus graduation from a recognized vocational or trade high school, with a major sequence of courses in electrical or electronic technology; or
3. Three years of full-time experience as described in "1" above, plus as A.A.S. degree from a community college or 60 college credits in a major sequence or courses in electrical or electronic technology.
4. Education and/or experience equivalent "1" "2" or "3" above.
