JOB DESCRIPTION: The Finance Information Technology Division is seeking an individual to serve as the Director of Billing for Accounting Systems, a leader accountable for producing flawless bills (Statement of Account (SOA), which is critical in helping people pay the right amount on time. The selected candidate will be responsible for managing a 14-person production support and development team, handling many of our most critical applications and processing forms for the Department of Finance; Managing payment processing, generating Statements of Account (SOA) for property payments and financial reconciliation; Lock Box processing; Tax Policies, Refunds, Rent Stabilization, External Agency Charges, Senior Citizens Rent Increase Exemption (SCRIE) offsets, Disabled Rent Increase Exemption (DRIE) offsets, and Common Modules. The Director will also balance managerial responsibilities with technical involvement, work well with the application development leadership team and business users; bring new ideas to the group, as the agency moves toward modernizing the legacy systems.

However, all candidates must have at least a four—year high school diploma or its educational equivalent approved by a State's department of education or recognized accrediting organization and must possess at least three years of experience as described in "1" above, including the 18 months of administrative, managerial, executive or supervisory experience as described in "1" above.
