TLC (in addition to its mainframe) runs a number of SQL Server and Access databases (in a Windows environment) to both conduct and monitor operations, as well as make policy decisions.</p> <p>TLC is seeking an experienced Database Analyst/Developer with systems analysis and programming skills. The candidate would be working on data analysis and program development. More specifically the selected candidate shall be required to:</p> <ul style="list-style-type: none"> <li>• Code, test, and implement data analysis programs (Database Application Development).</li> <li>• Provide and design tools to assist in data mining automation and reporting.</li> <li>• Create user friendly front end database driven applications for business needs.</li> </ul>	
<b>Qualification Requirements</b>	
<p>1. A baccalaureate degree from an accredited college, including or supplemented by twenty- four (24) semester credits in computer science or a related computer field; or</p> <p>2. A four-year high school diploma or its educational equivalent and three years of satisfactory full-time computer programming experience; or</p> <p>3. Education and/or experience equivalent to "1" or "2" above. College education may be substituted for up to two years of the required experience in "2" above on the basis that sixty (60) semester credits from an accredited college is equated to one year of experience. In addition, twenty-four (24) credits from an accredited college or graduate school in computer science or a related computer field, or a certificate of at least 625 hours in computer programming from an accredited technical school (post high school), may be substituted for one year of experience. However, all candidates must have at least a four- year high school diploma or its educational equivalent.</p>
