Alex Crandon Sentenced to 53 1/3 Years to Life in Prison for Role in "GS9" Gang Warfare

Bridget G. Brennan, New York City's Special Narcotics Prosecutor, announced today the sentencing of ALEX CRANDON, 22, to 53 1/3 years to life in prison for his role in gang warfare that extended from New York City to Miami, and involved murder and multiple attempted murders between January 2013 and October 2014.

On April 15, 2016, CRANDON was convicted at trial on 19 counts, including Conspiracy in the Second and Fourth Degrees, Murder in the Second Degree, Attempted Murder in the Second Degree, Reckless Endangerment in the First Degree, Assault in the First Degree, Attempted Assault in the First Degree, Criminal Possession of a Weapon in the Second Degree and Criminal Use of a Firearm in the First Degree.

Under the sentence imposed by Manhattan Supreme Court Justice Abraham J. Clott, penalties for Conspiracy in the Second Degree, Murder in the Second Degree and Attempted Murder in the Second Degree are to run consecutively, for an effective prison term of 53 1/3 years to life in prison. Sentences on all other counts are to run concurrently.

Special Narcotics Prosecutor Bridget G. Brennan stated, "As the judge emphasized today, his primary purpose in imposing sentence was to protect the community. The residents of East Flatbush should feel safer, because the defendant will no longer be able to terrorize their streets. These residents lived in a state of perpetual fear as the defendant and his cohorts were continually escalating violence in their quest to settle scores with any perceived enemy."

As proven at trial, CRANDON, aka "A-Rod," was a member of "GS9" or "G Stone Crips," a street crew based in East Flatbush Brooklyn, and conspired to engage in a pattern of gang-related violence, much of it stemming from an ongoing dispute with members of the rival gang "Brooklyn's Most Wanted" or "BMW." The conspiracy began with crack dealing in Brooklyn, and spanned nearly two years.

As the violence escalated, members of GS9 sought to shoot members of rival crews. Retaliatory shootings took place in New York City and Miami, where the gang members recklessly shot into crowds of innocent bystanders. Evidence included testimony from law enforcement officers and experts, medical examiners, and eye-witnesses, as well as surveillance video, recorded phone conversations, social media postings, DNA and ballistics evidence, and 11 firearms seized during the course of the investigation.

The evidence demonstrated CRANDON and co-defendant RASHID DERISSANT, aka "Rasha" aka "Jordan 23," together carried out the February 8, 2013 murder of a 19-year-old rival gang member in a bodega in East Flatbush, Brooklyn, and the attempted murder of three other rivals who were present. DERISSANT acted as the gunman while CRANDON stood guard outside. On July 12, 2014, CRANDON and DERISSANT fired bullets wildly across East 52nd Street in Brooklyn. A 22-year-old innocent bystander was shot in the neck and hip outside her family's home. DERISSANT also shot CRANDON in the arm during this incident.

On May 17, 2016, DERISSANT was sentenced to 98 1/3 years to life in prison. DERISSANT stood trial with CRANDON and was convicted on 22 counts, including Conspiracy in the Second and Fourth Degrees, Murder in the Second Degree, Attempted Murder in the Second Degree, Reckless Endangerment in the First Degree, Assault in the First and Second Degrees, Attempted Assault in the First Degree, Criminal Possession of a Weapon in the Second Degree and Criminal Use of a Firearm in the First Degree. Charges are pending against 19 other members and associates of GS9 named in the same indictment.

Special Narcotics Prosecutor Bridget G. Brennan commended Assistant District Attorneys Nigel Farinha, Susan Lanzatella and Thomas Wright for their work on the case. Special Narcotics Prosecutor Brennan also thanked the New York City Police Department's (NYPD) Brooklyn South Violence Reduction Task Force, the Miami Beach Police Department and the Kings County District Attorney's Office.
