The New York City Taxi and Limousine Commission (TLC) today announced that, due to the overwhelming success of the recent Technology Vendor Expo, which featured representatives from each of the four approved technology enhancement providers, **another** Expo has been scheduled for Tuesday, July 10, from 2 p.m. to 6 p.m. As before, the vendors will be on hand to answer any and all questions you may have. TLC representatives will also be on hand to assist you, and to answer questions.

The vendors will also be “taking their show on the road” and setting up shop at the JFK Airport Central Taxi Hold. Their appearance schedule is as follows:

- ***Week One- Wed. 6/27 & Thurs. 6/28***
- ***Week Two- Tues. 7/3 & Thurs. 7/5***
- ***Week Three- Wed. 7/11***
- ***Week Four- Tues. 7/17 & Wed. 7/18 & Thurs. 7/19***
- ***Week Five- Tues. 7/24 & Wed. 7/25 & Thurs. 7/26***
- ***Week Six – Tues. 7/31***

Each vendor may arrive as early as 10 a.m. and leave as late as 2 p.m.

The TLC had previously announced that AUGUST 1, 2007, is the SIGN-UP DEADLINE by which OWNERS of all MEDALLION TAXICABS must enter into CONTRACTS with Authorized Contractors (contractors approved by the TLC to solicit OWNERS/AGENTS to sell, rent, lease or permit use of technology enhancement systems and services and to install technology enhancement systems in New York City Taxicabs) under the Taxicab Technology Program. The TLC also announced that the

COMPLIANCE DATE by which the installation of taxicab technology service enhancements must be completed in all MEDALLION TAXICABS is the FIRST SCHEDULED INSPECTION DATE for each such medallion taxicab ON OR AFTER OCTOBER 1, 2007.
