4 'Injury B' includes injuries treatable by a layperson with over-the-counter products such as ibuprofen, antibiotic ointment, etc. Categorization is made by medical staff.

5 Mechanical restraints refer to restraints involving the use of handcuffs, shackles, and flex-cuffs.

In the interim, the data reported here reflect the number of accidents in detention, which often, though not always, result in youth needing medical treatment. Accidents most commonly refer to sports-related injuries and other routine minor accidents that occur both in detention and non-incarcerative environments.
