



Overview and Definitions

#### Introduction

The Administration for Children's Services (ACS) is pleased to release the FY20 Foster Care Scorecard. Under oversight from the New York State Office of Children and Families (OCFS), ACS contracts with nonprofit organizations to provide foster care services to children and families in New York City. The Scorecard is the annual performance review of the array of foster care providers who deliver one of four program types:

- Family Foster Care: for youth who are living in homes with foster parents
- <u>Treatment Family Foster Care</u>: for youth who are living in foster homes and receiving additional supportive services, most often behavioral health services
- <u>Specialized Family Foster Care</u>: for youth who are living in homes with foster parents and receiving support for medical issues or developmental disabilities
- <u>Residential Services</u>: facilities where groups of foster children live together and receive support from on-site staff

The Scorecard is primarily intended as a tool ACS uses to conduct its Continuous Quality Improvement (CQI) activities in collaboration with providers. The Scorecard includes more than 30 data elements, drawn from administrative and case review data to evaluate programs across child safety, permanency, and well-being domains. ACS uses the Scorecard to monitor strengths and weaknesses at the system and individual agency levels. It helps ACS identify areas of progress and concern, set goals, and track compliance with program requirements. It is one of several monitoring tools ACS uses to ensure the system is keeping children safe and achieving policy and programmatic goals. It is also a tool for agencies to self-monitor and develop their capacity for quality management. Provider agencies receive disaggregated Scorecard data on a quarterly basis to guide internal monitoring and promote data quality. ACS and providers meet on a monthly basis to discuss accountability-related concerns and requirements.

#### FY20 Scorecard and COVID-19

The onset of the COVID-19 pandemic coincided with the last four months of FY20. For this reason, comparisons between FY20 and prior years are imperfect. The pandemic impacted provider agency practice in various ways, such as the limited availability of community-based services; sharply reduced access to family court; and an overall shift of staff to remote telework. To acknowledge the impact of shifting circumstances on the March-June 2020 period, ACS adjusted several of its performance measures. These adjustments are described in the definitions below.

Given the pandemic, the FY20 Scorecard is considered For Your Information (FYI) and providers are not ranked against one another. Nonetheless, the Scorecard remains a valuable tool for ACS's quality improvement efforts and for providers as they assess their strengths and challenges.

In addition to the ongoing sharing of Scorecard data throughout the pandemic, ACS continued its array of monitoring and accountability practices, including:

- Monthly safety checks of each provider agency
- Monthly performance data reports on key indicators for each provider agency
- Child-specific safety and risk alerts by ACS monitors that must be addressed immediately by provider agencies
- Twice-yearly audit of a statistically valid sample of cases for each provider agency
- Year-round communication with providers to set quality improvement goals and monitor progress
- Continued heightened monitoring or corrective action status monitoring for programs identified as having past and current substandard performance on Scorecard

Overall, the FY2020 Foster Care Scorecard shows strong system-wide performance, including in regard to the safety of children in foster care.

#### It is important to note that:

- Whenever ACS identifies possible neglect or abuse in a foster home, Child Protective Specialists complete a full investigation. In such cases, if concerns are identified, they are addressed, and the children are confirmed to be safe. Sometimes, this requires moving a child to a new home or excluding a specific adult from a home. Systemwide, across all types of foster care, foster care placements are safe and healthy for nearly 100% of children.
- In nearly all cases across all types of foster care, nonprofit agencies' caseworkers have frequent face-to-face contact with children. This is critical for ensuring that children are safe and fully supported in foster care.
- During ACS audits and safety checks, if a reviewer finds case contacts are not fully
  documented, the reviewer issues an alert and the provider must immediately respond
  to confirm the child has been seen and is safe. In most cases, these concerns turn out to
  be problems with documentation, which will reduce a provider agency's score on
  Scorecard.

#### **FY 2020 Foster Care Scorecard Definitions**

The Foster Care Scorecard is an annual summary of the performance foster care programs serving New York City's children and families. The Foster Care Scorecard distinguishes four types of foster care programs. These include Family Foster Care (FFC), Treatment Family Foster Care (TFFC), Specialized Family Foster Care (Special Medical and Developmentally Disabled Foster Care, or (SFFC), and Residential Services (RES). The Scorecard evaluates outcome measures and case practice in the domains of safety, permanency and well-being of some of the city's most vulnerable young people. Below are brief definitions of the Foster Care Scorecard measures. For each of the measures below, a higher rate indicates better performance. <sup>1</sup> Please note that not all measures are applicable to all programs. Red text below identifies methodology adjustments related to the COVID pandemic.

#### **SAFETY – Practice Measures<sup>2</sup>**

- Safety of Current Placement This measure evaluates whether the current foster care placements are a safe and healthy setting for each child.<sup>3</sup>
- **Risk Assessment** This measure evaluates if the program's Family Strength, Need and Risk assessments are consistent with the case circumstances.<sup>3</sup>
- Frequency of Casework Contacts with Child This measures the frequency of face-to-face contacts between the caseworker and the child.<sup>3</sup>
- Frequency of Casework Contacts with Caretaker This measures the frequency of face-to-face contacts between the caseworker and the person/people responsible for the child's day-to-day care (e.g., foster parent or child care worker).<sup>3</sup>
- Frequency of Individual Therapist Contacts (TFCO only) This measures the frequency of faceto-face contacts between the Individual Therapist and the child.<sup>3</sup>

#### **SAFETY – Process Measures**

- Timeliness of Foster Home Certification This measure evaluates the timeliness of initial
  certifications for kinship emergency homes and the re-certification of foster homes with a
  child placed from July 2019 through February 2020.
- Frequency of AWOL This measure reports the rate at which youth in care did <u>not</u> experience any AWOL episode during the year.<sup>4</sup>
- Responsiveness to OSI Corrective Action Plan This measure evaluates the timeliness and completeness of provider responses to OSI corrective action plans involving indicated SCR cases.

#### **SAFETY – Outcome Measures**

- Safe Homes This measure represents the percent of foster homes that did <u>not</u> have an indicated SCR investigation involving a foster parent. The cohort for this measure includes foster homes in active status for at least 30 days during the fiscal year.
- **Subsequent Maltreatment** This measures the rate at which children did <u>not</u> experience an indicated maltreatment investigation within one year of a permanency discharge.

#### **PERMANENCY – Practice Measures**

- Parent Child Visitation This measures the appropriate progression of the parent-child visiting plan.<sup>3</sup>
- Family Team Conferencing This measure evaluates the appropriateness of the permanency plan discussed at family team conferences and the degree to which the agency took concrete steps toward implementation.<sup>3</sup>
- **Service Planning** This measure evaluates the degree to which Family Assessment and Service Plans (FASP) accurately capture the improvements and changes that need to be made to achieve permanency, improve child wellbeing and address the identified service needs.<sup>3</sup>
- **Permanency Planning** This measure evaluates the degree to which the child's Permanency Planning Goal is consistent with case circumstances. <sup>3</sup>
- Frequency of Casework Contacts with Parent/Discharge Resource This measure evaluates the frequency of face-to-face contacts between the caseworker and the child's discharge resource (e.g., parent or relative).<sup>3</sup>
- Frequency of Parent and Child Visits This measure evaluates the frequency of face-to-face visits between child and his/her discharge resource (e.g., parent or relative).<sup>3</sup>
- Timeliness of FASP Approval This measures the rate of timely approval of the Family Assessment and Service Plans (FASP) during the fiscal year. FASPs due in March and April 2020 were taken out of the cohort to account for necessary adjustments due to the pandemic.

#### **PERMANENCY – Process Measures**

- Length of Trial Discharge This measures the percent of children on trial discharge who are final discharged within 6 months. It consists of trial discharges that began from January through August 2019.
- Freeing for Adoption This cumulative measure represents the rate at which children who were
  in foster care on the first day of the fiscal year, and who had either a TPR or a KinGap agreement
  filed (prior to the FY), were freed for adoption, had a KinGap agreement finalized, had a
  compelling reason, or were discharged to permanency (reunification, KinGap or adoption) by
  February 2020.

#### **PERMANENCY – Outcome Measures**

With the exception of Re-entry, target based Permanency Outcome measures were scored on a curve, where a performance rate of 75% is equal to 100%, to compensate for restrictions on court access during the final quarter of FY 2020.

- Adoption Target This measures the achievement of adoption targets set by ACS.
- KinGap Target This measures the achievement of KinGap targets set by ACS.
- **Reunification-** This measure represents the achievement of reunification within one year. Targets are set using the number of children who entered foster care during the prior fiscal year. The permanency discharge target is set at 50% of the specified cohort.
- **Permanency for children in care 12 to 24 months** This measure represents the achievement of permanency within one year for children who were in foster care for 12 to 24 months on the first day of FY 19. The percent reported is out of a permanency discharge target of 42%. (Target set by OCFS for NYC to avoid Performance Improvement Plan).
- **Permanency for children in pare for over 24 months** This measure represents the achievement of permanency within one year for children who were in foster care for more than

- 24 months on the first day of FY 19. The percent reported is out of a permanency discharge target of 36%. (Target set by OCFS for NYC to avoid Performance Improvement Plan).
- **Re-entry** This measure represents the rate at which children who were discharged to reunification or KinGap did <u>not</u> re-enter foster care within one year of their discharge.

#### **Wellbeing – Practice Measures<sup>2</sup>**

- Physical and Emotional Well-being (reflected as individual indicators) These measures
  evaluate the degree to which the child's physical health, emotional/ psychological well-being,
  developmental functioning and social/behavioral well-being were assessed.<sup>3</sup>
- **Educational Well-being** This measures enrollment in a school or educational/vocational program/day treatment program; ongoing communication between the child's teacher and the caseworker; receipt of remedial assistance as needed; and parental involvement in educational decision-making.<sup>3</sup>
- Recreational Well-being This measures the child's participation in recreational and leisure activities.<sup>3</sup>
- Frequency of Sibling Visits This measures the rate of face-to-face visits between the child and siblings, when applicable, who are in foster care but who have been placed in separate foster care settings. <sup>3</sup>
- Frequency of Sociotherapist Contacts (TFFC only) This measures the frequency of face-to-face contacts between the Sociotherapist and the child.<sup>3</sup>
- Frequency of Skills Coach Contacts (TFCO only) This measures the frequency of face-to-face contacts between the Skills Coach and the child.<sup>3</sup>

#### Wellbeing – Process Measures

- **Medical Review** This measure evaluates documentation of medical and mental health services provided based on the needs of the children in the review.
- Preparing Youth for Adulthood (PYA) Checklist This measures the timely submission of PYA
   Checklists. PYA Checklists due in March and April 2020 were taken out of the cohort to account
   for necessary adjustments due to the pandemic.
- **Sibling Placements** This measures the rate at which sibling groups who enter foster care together are placed in the same foster home.

#### **Wellbeing – Outcome Measures**

- **Placement Stability** This measures the rate at which children did not experience a placement transfer from July 2019 through February 2020.
- Step-Ups This measures the rate at which children in family-based foster care remained in a family-based setting and did not move into a higher level of care from July 2019 through February 2020.
