To thoughtfully and safely transition the prevention services system between contract periods, ACS has been gradually reducing caseloads and adjusting intake of programs that will close or reduce in size by June 30, 2020. This has been done carefully in phases to ensure continuous high quality support for children and families currently in services. The estimated slots available identified in this report does not account for these adjustments. Additionally, New York City began experiencing widespread community transmission of the novel coronavirus/COVID-19 in March 2020. Public health concerns, social distancing measures, and ACS and prevention providers' focus on emergency response may have contributed to fewer enrollments.
