1) Rate definitions: rates are calculated by dividing the program counts by the by the total population of children in a specific community district, multiplied by 1,000. The population of children under 18 years old is used for for children in indicated investigations, prevention and foster care and for for detention youth 11-18 is used. The program counts are defined as follows: children in indicated investigations are unique children in investigations with confirmed abuse and/or neglect; children receiving prevention are
