# CENTRAL INSURANCE PROGRAM: FOLLOW-UP

As you know, the insurance coverage provided through the New York City Central Insurance Program (CIP) will no longer be available beginning November 1, 2013.

Contractors must obtain their own Commercial General Liability, Workers' Compensation and Disability, and Fidelity Bond (crime) coverage – sites cannot provide services to children without this insurance coverage.

Upon obtaining insurance, but no later than November 8, 2013, providers are required to submit a proof of insurance to the attention of Jean Sheil at jean.sheil@acs.nyc.gov.

# ERSEA: Eligibility, Recruitment, Selection, Enrollment, Attendance

#### RECRUITMENT UPDATE

Thank you to the programs who have already completed the **Recruitment & Marketing Survey**. To date, we have only received 33 responses. **If you have not yet completed this mandatory survey - https://www.surveymonkey.com/s/L75C6PF - please do so immediately**.

We may be using the results of this survey to help determine the possibility for continued funding for marketing materials produced by ACS – as such, your feedback is vital and crucial for helping ACS ascertain the effectiveness of the marketing campaign and materials. As a reminder, please ensure that your intake questionnaires are inquiring how families are learning of your program – particularly if it was through the EarlyLearn campaign materials. We will be conducting another survey in early fall and will be comparing the results from this survey.

#### UPK ENROLLMENT

All EarlyLearn sites awarded preschool slots have UPK funding incorporated in their preschool daily rate; UPK services are integrated directly within the EarlyLearn service day.

In order to maximize the number of EarlyLearn children participating in UPK and support the full drawdown of ACS' UPK funding stream, it is imperative that programs recruit and enroll as many four-year old children in EarlyLearn and in DOE's PreKIDS as possible up until ACS notifies you otherwise.

UPK packages must be submitted to the DOE Field Offices by 4pm on October 2, 2013.

Programs should aim to submit their Child Care applications to ACS Resource Areas by September 17, 2013 to allow ACS staff time to process the paperwork; ACS will process past this date as well.

For Child Care and Dual Eligible programs, please also see attached for the special submission log for use when submitting cases of children born in 2009 to ACS Resource Areas. (ERSEA\_Special\_Submission\_Log)

#### **PARENT FEES**

Families receiving a Child Care subsidy from NYC ACS are required to pay a weekly parent fee. These fees are collected by EarlyLearn contractors; ACS deducts these fees from the contractors' payments. Effective September 09, 2013, families with children enrolled in EarlyLearn are required to pay a weekly parent fee without regard to the daily attendance of the child.

# AFFORDABLE HEALTH CARE IS COMING...

The NYS Health Benefit Exchange is a marketplace where New Yorkers, both individuals and small businesses, can shop for, compare and enroll in new, affordable health insurance options. Exchanges are being administered in every state as part of President Obama's federal health care reform law. Over 1 million New Yorkers are estimated to receive coverage through the Exchange.



You will have a choice of health plans; help finding the plan that best meets your needs; and, for eligible persons, financial assistance to help pay for coverage. Health insurance offered on the Exchange will include a comprehensive set of benefits, including equal coverage of mental health and substance abuse benefits.

You will be eligible to purchase a health plan through the Exchange if you:

- \* Live in New York
- \* Are a citizen or lawfully present immigrant (different immigration rules may apply if you are eligible for Child Health Plus or Medicaid)
- \* Own or work for a small business with 50 or fewer eligible employees

# **IMMUNIZATION**

The New York City Department of Health and Mental Hygiene has issued School Admission Immunization Requirements. The law requires that all new students must show proof of having received a complete medical evaluation.

Keep yourself up-to-date on current requirements by using the Citywide Immunization Registry.

What is the Citywide Immunization Registry (CIR), you ask? The CIR is a computerized filing system that keeps immunization records of people vaccinated in New York City (NYC). The CIR started in 1997 when a NYC Health Code amendment went into effect requiring health care—providers to report immunizations given to all children under 8 years of age. As of August 18, 2005, the NYC Health Code required providers to report immunizations given to all people under 19 years of age, and allowed for reporting of immunizations given to people 19 years of age and over, with written consent from the patient.

CIR information is kept confidential and is disclosed only to providers, parents, legal guardians or custodians, individuals, or agencies concerned with health for the purpose of protecting the health of the individual or others.
