**DECISION OF THE BUSINESS INTEGRITY COMMISSION DENYING THE
APPLICATION OF ROCK E SMALL PLUMBING & HEATING INC FOR A
REGISTRATION TO OPERATE AS A TRADE WASTE BUSINESS**

I. INTRODUCTION

Rock E Small Plumbing & Heating Inc (“Rock E Small” or the “Applicant”) applied to the New York City Business Integrity Commission (the “Commission”) for an exemption from licensing requirements and a registration to operate a trade waste business “solely engaged in the removal of waste materials resulting from building demolition, construction, alteration or excavation”. (the “Application”). Local Law 42 of 1996 (“Local Law 42”) authorizes the Commission to review and make determinations on such exemption applications. *See* Title 16-A, New York City Administrative Code (“Administrative Code” or Admin. Code”) § 16-505(a).

After a review of a trade waste registration application, if the Commission grants an exemption from the Commission’s licensing requirements, the applicant will be issued a registration. *See id.* at 16-505(a)-(b). The Commission’s review of a registration application focuses on determining whether the applicant possesses business integrity, *i.e.*, good character, honesty and integrity. *See* Title 17, Rules of the City of New York (“RCNY”) § 1-09 (prohibiting numerous types of conduct reflecting lack of business integrity, including violations of law, knowing association with organized crime figures, false or misleading statements to the Commission, and deceptive trade practices); Admin. Code § 16-504(a) (empowering the Commission to issue and establish standards for issuance, suspension, and revocation of licenses and registrations); Admin. Code § 16-509(a) (authorizing the Commission to refuse to issue licenses or registrations to applicants lacking “good character, honesty and integrity”).

On March 31, 2026, the Commission staff issued and served on the Applicant a 53-page Notice to the Applicant of the Ground to Deny the Application of Rock E Small Plumbing & Heating Inc to Operate as a Trade Waste Business (the “Notice of Denial”). The Applicant was given 10 business days to respond. The Applicant did not respond to the Notice of Denial.

The Commission’s staff has completed its review of the Application. Based on the record in this matter, as detailed below, the Commission now denies the Application based on the following independently sufficient grounds:

1. **The Applicant has failed to pay taxes, fines, penalties, or fees that are related to the Applicant's business for which judgment has been entered by a court or administrative tribunal of competent jurisdiction;**
2. **The Applicant has knowingly failed to provide information and/or documentation required by the Commission; and**
3. **The Applicant has repeatedly engaged in unregistered trade waste removal activity and has breached the terms of a Stipulation of Settlement entered into with the Commission regarding three instances of unlicensed or unregistered trade waste removal activity.**

II. BACKGROUND AND STATUTORY FRAMEWORK

Every commercial business establishment in New York City must contract with a private carting company to remove and dispose of the waste it generates, known as trade waste. Local Law 42 created the Commission and granted it the power and duty to license and regulate the trade waste removal industry in New York City. Admin. Code § 16-505(a). This regulatory framework continues to be the primary means of ensuring that an industry once overrun by corruption remains free from organized crime and other criminality, and that commercial businesses that use private carters can be ensured of a fair, competitive market.

A company "solely engaged in the removal of waste materials resulting from building demolition, construction, alteration or excavation," also known as construction and demolition debris, must apply to the Commission for an exemption from the licensing requirement. *Id.* If, upon review of an application, the Commission grants an exemption from the licensing requirement, the Commission must evaluate the "good character, honesty and integrity of the applicant." *Id.* at § 16-508(b); *see also id.* at § 16-504(a). An "applicant" for a license or registration means both the business entity and each principal thereof. *Id.* at § 16-501(a).

The Administrative Code provides an illustrative list of relevant factors for the Commission to consider in making a decision on an application for a license or registration:

1. failure by such applicant to provide truthful information in connection with the application;
2. a pending indictment or criminal action against such applicant for a crime which under this subdivision would provide a basis for the refusal of such license, or a pending civil or administrative action to which such applicant is a party and which directly relates to the fitness to conduct the business or perform the work for which the license is sought, in which cases the commission may defer consideration of an application until a decision has been reached by the court or administrative tribunal before which such action is pending;

3. conviction of such applicant for a crime which, considering the factors set forth in section seven hundred fifty-three of the correction law, would provide a basis under such law for the refusal of such license;
4. a finding of liability in a civil or administrative action that bears a direct relationship to the fitness of the applicant to conduct the business for which the license is sought;
5. commission of a racketeering activity or knowing association with a person who has been convicted of a racketeering activity, including but not limited to the offenses listed in subdivision one of section nineteen hundred sixty-one of the Racketeer Influenced and Corrupt Organizations statute (18 U.S.C. § 1961 *et seq.*) or of an offense listed in subdivision one of section 460.10 of the penal law, as such statutes may be amended from time to time, or the equivalent offense under the laws of any other jurisdiction;
6. association with any member or associate of an organized crime group as identified by a federal, state or city law enforcement or investigative agency when the applicant knew or should have known of the organized crime associations of such person;
7. having been a principal in a predecessor trade waste business as such term is defined in subdivision a of section 16-508 of this chapter where the commission would be authorized to deny a license to such predecessor business pursuant to this subdivision;
8. current membership in a trade association where such membership would be prohibited to a licensee pursuant to subdivision j of section 16-520 of this chapter unless the commission has determined, pursuant to such subdivision, that such association does not operate in a manner inconsistent with the purposes of this chapter;
9. the holding of a position in a trade association where membership or the holding of such position would be prohibited to a licensee pursuant to subdivision j of section 16-520 of this chapter;
10. failure to pay any tax, fine, penalty, or fee related to the applicant's business for which liability has been admitted by the person liable therefor, or for which judgment has been entered by a court or administrative tribunal of competent jurisdiction; and
11. failure to comply with any city, state or federal law, rule or regulation relating to traffic safety or the collection, removal, transportation or disposal of trade waste in a safe manner.

Id. at § 16-509(a)(i)-(xi). *See also id.* at § 16-504(a).

The Commission also may refuse to issue a license or registration to any applicant who has “knowingly failed to provide information or documentation required by the Commission . . . or who has otherwise failed to demonstrate eligibility for a license.” *Id.* at § 16-509(b). *See also Elite Demolition Contracting Corp. v. The City of New York*, 125 A.D.3d 576 (1st Dep’t 2015); *Breeze Carting Corp. v. The City of New York*, 52 A.D.3d 424 (1st Dep’t 2008); *Attonito v. Maldonado*, 3 A.D.3d 415 (1st Dep’t) (Commission may deny an application for an exemption “where the applicant fails to provide the necessary information or knowingly provides false information”); leave denied 2 N.Y.3d 705 (N.Y. 2004). *See also* Admin. Code § 16-509(a)(i) (failure to provide truthful information in connection with application as a consideration for denial). In addition, the Commission may refuse to issue a license or registration to an applicant that “has been determined to have committed any of the acts which would be a basis for the suspension or revocation of a license.” *Id.* at § 16-509(c). *See also id.* at § 16-504(a). Finally, the Commission may refuse to issue a license or registration to any applicant where the applicant or its principals have previously had their license or registration revoked. *Id.* at § 16-509(d); *see also id.* at § 16-504(a).

An applicant for a trade waste license or registration is not entitled to, and has no property interest in, a license or registration, and the Commission is vested with broad discretion to grant or deny a license or registration application. *Sanitation & Recycling Industry, Inc.*, 107 F.3d at 995. *See also Daxor Corp. v. New York Dep’t of Health*, 90 N.Y.2d 89, 98-100, 681 N.E.2d 356, 659 N.Y.S.2d 189 (1997).

III. STATEMENT OF FACTS

On April 5, 2023, the Applicant applied to the Commission for a registration to operate a trade waste business that solely removes construction and demolition debris.

Unlicensed or unregistered trade waste activity

The Applicant has been operating a trade waste business without authorization to do so since at least August 2020. On September 9, 2022, the Commission charged the Applicant with four separate counts of operating an unlicensed or unregistered trade waste removal business based on observations occurring between August 1, 2020 and May 5, 2022, in violation of Administrative Code section 16-505(a). *See* Notices of Violation (“NOV”) TWC-219844, 223778, 223791, and 223954.

On September 12, 2022, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation occurring on May 13, 2021, in violation of Administrative Code section 16-505(a). *See* NOV TWC-221731. On March 28, 2023, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on September 22, 2022, in violation of Administrative Code section 16-505(a). *See* NOV TWC-224937. On April 17, 2023, the Applicant entered into a Stipulation of Settlement with the Commission regarding NOV’s TWC-219844, 223778, 223791, 223954, 221731, and 224937, in which it admitted culpability, and agreed to pay a penalty of \$6,000.00. *See* Stipulation of Settlement, Master Settlement TWC-226357.

On July 12, 2023, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on April 24, 2023, in violation of Administrative Code section 16-505(a). This observation occurred a mere seven days after the Applicant admitted culpability for the same charge on 6 prior occasions. *See* NOV TWC-226533. On August 11, 2023, the Applicant entered into a Stipulation of Settlement with the Commission regarding NOV TWC-226533, in which it admitted culpability, and agreed to pay a penalty of \$1,000.00. *See* Stipulation of Settlement TWC-226533.

On December 19, 2023, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on October 23, 2023, in violation of Administrative Code section 16-505(a). *See* NOV TWC-227860. On March 20, 2024, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on January 2, 2024, in violation of Administrative Code section 16-505(a). *See* NOV TWC-228213. On May 7, 2024, the Applicant entered into a Stipulation of Settlement with the Commission regarding these administrative violations, in which it admitted culpability, and agreed to pay a penalty of \$3,000.00. *See* Stipulation of Settlement, Master Settlement TWC-229168.

On November 18, 2024 the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on October 31, 2024, in violation of Administrative Code section 16-505(a). *See* NOV TWC-230461. On February 19, 2025, a hearing regarding NOV number TWC-230461 took place at the Office for Administrative Trials and Hearings (“OATH”). The Applicant failed to appear at this hearing. As a result, Hearing Officer Andrea Pfeiffer found the Applicant to be in violation and imposed a \$5,000 penalty. *See* Default Decision TWC-230461 by Hearing Officer Pfeiffer April 8, 2025.

On December 6, 2024 the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on November 20, 2024, in violation of Administrative Code section 16-505(a). *See* NOV TWC-230586. On March 4, 2025, a hearing regarding NOV number TWC-230586 took place at OATH. The Applicant failed to appear at this hearing. As a result, Hearing Officer Andrea Pfeiffer found the Applicant to be in violation and imposed a \$5,000 penalty. *See* Default Decision TWC-230586 by Hearing Officer Pfeiffer April 8, 2025.

On January 14, 2025 the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on January 8, 2025, in violation of Administrative Code section 16-505(a). *See* NOV TWC-230806. On March 24, 2025, a hearing regarding NOV number TWC-230806 took place at OATH. The Applicant failed to appear at the hearing. As a result, Hearing Officer Andrea Pfeiffer found the Applicant to be in violation and imposed another \$5,000 penalty. *See* Default Decision TWC-230806 by Hearing Officer Pfeiffer April 10, 2025.

On May 21, 2025 the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business based on an observation on May 13, 2025, in violation of Administrative Code section 16-505(a). *See* NOV TWC-231830.

On July 30, 2025, the Applicant entered into a Stipulation of Settlement with the Commission regarding NOV's TWC-230461, TWC-230586, TWC-230806, and TWC-231830, in which it admitted culpability, and agreed to pay a penalty of \$6,000.00 by November 29, 2025. See Stipulation of Settlement, Master Settlement TWC-232549. Although the Applicant agreed to pay the \$6,000 fine, to date, the Applicant has failed to do so.

Failure to pay taxes, fines, penalties, or fees and failure to provide the Commission with information and/or documentation required by the Commission.

On or about June 6, 2023, a member of the Commission's staff contacted the Applicant via telephone and informed the Applicant, among other things, of numerous outstanding judgements, warrants and administrative violations filed against the Applicant. After the call, the Commission staff member sent the Applicant an email memorializing the telephone conversation. See June 6, 2023 email from Commission staff member to the Applicant. The email provided the Applicant with a list of all the outstanding taxes, fines, penalties, or fees owed by the Applicant. See *id.* The Commission staff member asked the Applicant to provide proof of payments and/or satisfaction of the debts by June 8, 2023. *Id.* The debts were as follows:

On June 8, 2023, a member of the Commission's staff followed up with the Applicant and reminded the Applicant of the deadline to submit proof of payment and/or satisfaction of the debts. *See* June 8, 2023 email from Commission staff member to the Applicant. The same day, the Applicant sent an email in reply to the Commission staff member. The email included attachments purporting to be proof of payments for the ECB debts. The Applicant also requested an extension of time to provide the Commission with the required information and/or documentation because the Applicant claimed to be working to resolve the debts. *See* June 8, 2023 email from the Applicant to Commission staff member. On June 9, 2023, a member of the Commission's staff responded and informed the Applicant that the ECB violations that the Applicant represented to have been paid did not correspond with the ECB violations listed by the Commission's staff in the June 6, 2023 email to the Applicant. *See* June 9, 2023 email from Commission staff member to the Applicant. The Commission extended the deadline for the submission of proof of payment and/or satisfaction of the various debts to June 22, 2023. *Id.*

On June 14, 2023, the Applicant provided the Commission with a copy of a violation payment agreement between the Applicant and the City of New York Department of Finance for approximately 265 ECB violations. *See* June 14, 2023 email from the Applicant to a Commission staff member.

On October 31, 2023, a member of the Commission staff followed up with the Applicant via telephone to again demand proof of payments made in resolution of the outstanding judgements, warrants and administrative violations. The Applicant was informed that the violation payment agreement submitted by the Applicant on June 14, 2023 did not include more than 100 of the ECB violations filed against the Applicant. The Applicant was informed that the application could be denied for failure to provide proof of payments or proof of satisfaction of the debts, including the ECB violations, the tax warrants and other judgments. The Commission staff member sent an email to the Applicant memorializing the phone conversation. *See* October 31, 2023 email from a Commission staff member to the Applicant. No response was received from the Applicant.

On July 29, 2025, a member of the Commission staff followed up with the Applicant to again demand proof of payments to resolve the ECB violations, the tax warrants and other judgments. *See* July 29, 2025 email from a Commission staff member to the Applicant. The Applicant was given until August 30, 2025 to respond and was informed that failure to provide the information and/or documentation could be the basis for denial of the application. *See id.* No response was received from the Applicant.

On August 19, 2025, a member of the Commission staff followed up with the Applicant to again demand proof of payments to resolve the ECB violations, the tax warrants and other judgments. *See* August 19, 2025 email and demand letter from a Commission staff member to the Applicant. The Applicant was warned that, pursuant to Section 16-509(b) of the Administrative Code, failure to provide the information and/or documentation “may be a premise to deny an application [for a] registration.” *See id.* This letter established a deadline of September 19, 2025 for the Applicant to respond. The Applicant did not respond to this letter.

IV. BASIS FOR DENIAL

- 1. The Applicant has failed to pay taxes, fines, penalties, or fees that are related to the Applicant’s business for which judgment has been entered by a court or administrative tribunal of competent jurisdiction.**

The Commission may refuse to issue a license or registration to an applicant who lacks good character, honesty and integrity. *See* Admin. Code § 16-509(a). One factor the Commission may consider in making this determination is whether there is a “failure of the applicant to pay any tax, fine, penalty, or fee related to the applicant’s business... for which judgment has been entered by a[n] ... administrative tribunal of competent jurisdiction...” *See* Admin. Code § 16-509(a)(x); *see also* 16-513(a)(iv).

On or about March 17, 2026, a judgment and lien search found that the following judgments issued against the Applicant remain outstanding:

On several occasions the Applicant was warned that it must address these judgments and that the failure to address these judgments could be a ground to deny its registration application. Nevertheless, the Applicant has still failed to address these judgments. Based on this independently sufficient ground, the Commission denies the Application.

2. The Applicant knowingly failed to provide information and documentation required by the Commission.

“The Commission may refuse to issue a license or registration to an Applicant for such license or an Applicant for registration who has knowingly failed to provide the information and/or documentation required by the Commission pursuant to this chapter or any rules promulgated pursuant hereto...” See Admin. Code. §16-509(b).

Here, despite the Commission’s numerous communications notifying the Applicant of \$382,354 in debts owed to the City and State of New York, ultimately the Applicant did not satisfactorily respond to the Commission’s communications despite the Commission staff’s repeated attempts. The Applicant has "knowingly failed to provide the information" required by the Commission by failing to respond to the Commission's repeated requests for information and/or documentation. Based on this independently sufficient ground, the Commission denies the Application.

- 3. The Applicant has repeatedly engaged in unregistered trade waste removal activity and has breached the terms of a Stipulation of Settlement entered into with the Commission regarding three instances of unlicensed or unregistered trade waste removal activity.**

The Applicant has repeatedly violated the Commission's rules and regulations by operating a trade waste removal business without a registration. On thirteen separate occasions, the Commission charged the Applicant with operating an unlicensed or unregistered trade waste removal business, in violation of § 16-505(a) of the Administrative Code. *See* NOV's TWC-8451, 8452, 8905, 8959.

The Applicant settled some of the Commission issued administrative violations and failed to appear for hearings regarding other Commission issued administrative violations. After failing to appear for three Commission issued administrative violations on three different dates, an OATH Hearing Officer ordered the Applicant to pay penalties of \$15,000. The Applicant and the Commission's staff subsequently agreed to settle each of these administrative violations for a total penalty of \$6,000.00. Despite admitting culpability and agreeing to pay the reduced penalty of \$6,000, to date the Applicant has failed to pay the penalty. Those persistent violations and the failure to pay agreed upon penalties by the Applicant demonstrate the Applicant's disregard for the Commission's rules. This behavior establishes the Applicant's lack of good character, honesty and integrity. *See* Admin. Code §16-509(a)(x). Based on this independently sufficient ground, the denies the Application.

V. CONCLUSION

The Commission is vested with broad discretion to refuse to issue a license or registration to any applicant that it determines lacks good character, honesty and integrity. Based on the reasons stated above, the Commission finds that Rock E Small Plumbing & Heating Inc lacks those characteristics and denies its registration application.

This denial is effective immediately. Rock E Small Plumbing & Heating Inc may not operate as a trade waste business in the City of New York.


