#### **COMMISSION DIRECTIVE**

To all licensees and registrants:

The Annual Macy's Thanksgiving Day Parade will be held on Thursday, November 28, 2019 from 9:00 a.m. to 12:00 p.m. The parade will temporarily close various streets and avenues within Manhattan to all motor vehicles, including trade waste collection vehicles. A list of the affected roadways is set attached hereto.

All licensees and registrants are hereby directed to complete waste collection and remove all containers in the affected areas before 12:00 a.m. on November 27, 2019. You may resume collection at 2:00 p.m. on November 28, 2019. Moreover, all licensees and registrants must notify all customers along the event route that no waste or containers may be placed on the curbside during the aforementioned dates and times.

Commission enforcement agents will be on the event route to ensure compliance with this directive. Please be aware that the City's Department of Transportation ("DOT") issued an event construction embargo along the event route from 12:01 a.m. on Tuesday, November 19 through 11:59 p.m. on Thursday, November 28, 2019. DOT will strictly enforce this embargo and violators are subject to be summonsed. - 86th Street to 82nd Street between Columbus Avenue and Central Park West
- 75th Street to 72nd Street between Columbus Avenue and Central Park West
- 70th Street to 69th Street between Columbus Avenue and Central Park West
- 67<sup>th</sup> Street to 63<sup>rd</sup> Street between Columbus Avenue and Central Park West
- 61<sup>st</sup> Street to 60<sup>th</sup> Street between Columbus Avenue and Central Park West
- 59th Street between 6th Avenue and Grand Army Plaza
- 58th Street to 52<sup>nd</sup> Street between 7th Avenue and 5th Avenue
- 51<sup>st</sup> Street to 48<sup>th</sup> Street between 7<sup>th</sup> Avenue and Rockefeller Plaza
- 47<sup>th</sup> Street to 46<sup>th</sup> Street between 7<sup>th</sup> Avenue and 5<sup>th</sup> Avenue
- 45<sup>th</sup> Street to 42<sup>nd</sup> Street between Broadway and 5<sup>th</sup> Avenue
- 41<sup>st</sup> Street between Broadway and 6<sup>th</sup> Avenue
- 40<sup>th</sup> Street to 35<sup>th</sup> Street between 6<sup>th</sup> Avenue and 5<sup>th</sup> Avenue
- 33<sup>rd</sup> Street between 6<sup>th</sup> and 5<sup>th</sup> Avenue
- Columbus Avenue between 77th Street and 58th Street
- Columbus Avenue between 86th Street and 81st Street
