COMMISSION DIRECTIVE

To all licensees and registrants:

New York City's annual Summer Streets program will be held on the first three Saturdays in August: August 6, August 13, and August 20, 2022, from 7:00 a.m. to 1:00 p.m. each Saturday. Summer Streets will temporarily close multiple streets and locations in Manhattan to all motor vehicles, including trade waste collection vehicles. A list of the affected roadways is attached hereto.

All licensees and registrants are hereby directed to complete waste collection and remove all containers in the affected areas before 10:00 p.m. on Fridays August 5, August 12, and August 19, 2022. Collection may resume at 6:00 p.m. each Saturday. Business Integrity Commission (BIC) enforcement agents will be on the event route each Saturday to ensure compliance with this Directive. A map of the Summer Streets route showing closed streets is annexed hereto and available on the BIC website and at [summer-streets-embmap-2022.pdf \(nyc.gov\)](https://www.bic.nyc.gov/summer-streets-embmap-2022.pdf).

Please be aware that the City's Department of Transportation (DOT) issued a construction embargo along the event route from 12:01 a.m. on Monday July 25, 2022, through 6:00 p.m. on Saturday August 20, 2022. DOT will strictly enforce this embargo; violators are subject to summons. A map showing the DOT embargo area is annexed hereto and more information about Summer Streets is available on DOT's website [here](#).

Failure to comply with this Directive may result in administrative penalties and/or fines up to \$10,000. *See* 17 RCNY § 1-09. Failure to comply with this Directive may also affect your company's licensing or registration status before BIC.
