## **COMMISSION DIRECTIVE**

Dear Licensees and Registrants:

On Sunday 7, 2019, the USA Women's National Team ("USWNT") won the Women's World Cup. Accordingly, a celebratory ticker-tape parade will be held Wednesday, July 10, 2019 at 9:30 a.m. In anticipation of the parade, the New York City Police Department will temporarily close streets and avenues in lower Manhattan, from West Street to FDR Drive and Worth Street to Bowling Green.

All Licensees and Registrants are hereby directed to complete waste collection in the affected areas before 9:00 p.m. on July 9, 2019. Furthermore, you are directed to remove your respective containers along the event route before 5:00 p.m. on July 9, 2019. Collection may resume at 1:00 p.m. on July 10, 2019. Moreover, all licenses and registrants must notify all customers along the event route that no waste or containers may be placed on the curbside between 6:00 p.m. July 9, 2019 to 1:00 p.m. on July 10, 2019.

Business Integrity Commission enforcement agents will be on the event route to ensure compliance with this directive. Please be aware that the City's Department of Transportation ("DOT") issued a festival construction embargo along the event route from 12:01 a.m. to 9:00 p.m. on Wednesday, July 10, 2019. DOT will strictly enforce this embargo and violators are subject to be summonsed.
