COMMISSION DIRECTIVE

To all licensees and registrants:

The Annual Macy's Thanksgiving Day Parade will be held on Thursday, November 25, 2021 from 9:00 a.m. to 12:00 p.m. The parade will temporarily close various streets and avenues within Manhattan to all motor vehicles, including trade waste collection vehicles. A list of the affected roadways is attached hereto.

All licensees and registrants are hereby directed to complete waste collection and remove all containers in the affected areas before 11:59 p.m. on November 24, 2021. You may resume collection at 2:00 p.m. on November 25, 2021. Moreover, all licensees and registrants must notify all customers along the event route that no waste or containers may be placed on the curbside during the aforementioned dates and times.

Commission enforcement agents will be present on the event route to ensure compliance with this directive. A map of the parade route showing the affected roadways is attached, and is available on BIC's website and at: [macys-thanksgiving-parade-embmap.pdf \(nyc.gov\)](http://macys-thanksgiving-parade-embmap.nyc.gov).

Please be aware that the NYC Department of Transportation ("DOT") issued an event construction embargo along the event route from 12:01 a.m. on Tuesday, November 16 through 11:59 p.m. on Thursday, November 25, 2021. DOT will strictly enforce this embargo and violators are subject to being summonsed. For information regarding the DOT embargo area please visit:

- Grand Army Plaza between 59th Street and 58th Street
- 41st Street through 58th Street between 7th Avenue and 6th Avenue
- 35th Street through 40th Street between 6th Avenue and 5th Avenue
- 33rd Street between 6th Avenue and 5th Avenue
- Broadway between 33rd Street and 34th Street
- 6th Avenue between 33rd Street and 32nd Street
- Columbus Avenue between 72nd Street and 58th Street
- Columbus Avenue between 86th Street and 83rd Street
