MS. AHMED: Good morning and welcome to today's public hearing. Today's date is Wednesday, February 22, 2023 and the time is 11:38.

My name is -- one second. Okay. My name is Shormina Ahmed, Executive Agency Counsel of the New York City Business Integrity Commission and thank you for attending today's hearing.

A court reporter is present today and will transcribe the hearing. To avoid any background noise during this hearing, we ask everyone, please mute yourself until we start calling on speakers.

The Commission is conducting today's remote hearing in accordance with the City Administrative Procedure Act. The

purpose of today's hearing is to receive comments from the public on the Commission's proposed rules governing adjudicating trade waste violations in OATH Hearings.

The Commission published the proposed rules in The City Record on January 18, 2023. The Commission also emailed copies of the rules to all New York City local-elected officials, the City's 59 Community Boards, media, and interested parties, and posted the proposed rules on both the Commission's and New York City Rules' website.

The proposed rule changes would allow the Commission to issue summonses to be adjudicated in the Office of Administrative Trials and Hearings or "OATH" Hearings Division. The proposed rule change adds a trade waste penalty schedule to Title 17 of the Rules of the City of New York, or RCNY, which will detail the different penalties and the amounts for trade waste violations.

The proposed rule changes also amend

Section 1-101 of 17 RCNY to include new terms, such as "Administrative Law Judge", "Default Penalty", "First Violation Penalty", "Mitigated Penalty", "Penalty Schedule", "Repeat Violation Penalty", "Respondent", and "Summons".

That concludes the summary of the proposed rule changes at issue at this hearing.

You may present an oral statement for the record or submit written comments concerning the proposed rule changes. Additionally, the Commission has been accepting written comments on the proposed rules since the publication in The City Record and as of February 21, 2023.

The Commission will make available a copy of any written comments that are received in connection with today's hearing on the website. The Commission will carefully review and consider all comments and submissions and make changes if the Commission deems that necessary. The proposed rule will go
