Vice Chair Richards called for a motion and conducted a roll call vote, and the Board unanimously approved the existing conditions and proposal to renew the variance for two months, 8-0 (Chair Jones Austin, Vice-Chair Richards and Members Carrion, Cohen, Franco, Perrino, Safyer, and Sherman).

Vice Chair Richards called for a motion to vote on the two-month variance with conditions. After the item was moved and seconded, the Board approved the variance with conditions, with seven votes in favor (Chair Jones Austin, Vice Chair Richards and Members Carrion, Franco, Perrino, Safyer, and Sherman) and one vote in opposition (Member Cohen).
