

Increase in Confirmed Cases

- The number of people in custody with confirmed COVID infections began to rise in December 2020 following a 7-month period of steady decline.
- On January 1<sup>st</sup>, 6% (n=306) of people in custody had confirmed COVID infections.
- As of January 10<sup>th</sup>, CHS reports 37 people in custody with an active infection.

Each day shows new cases reported since the previous day



- As of January 1st, 2021, the cumulative case count for DOC staff was 1,631; for CHS is was 234.
- In December 2020 DOC reported 123 new staff cases, accounting for 22% of all new cases reported since May 2020.
- CHS reported an additional 15 new staff cases in December 2020.

Each day shows new cases reported since the previous day





NOTE: CHS began reporting positive staff cases to the Board on March 18th, 2020. DOC began reporting positive staff cases to the Board on March 21st, 2021.

Jail Population & Decarceration

- On April 29<sup>th</sup>, there were 3,832 people in jail, a historic low.
- Since April 29th, the number of people in jail has increased by 30%, reaching 4,967 on January 1st, 2021.

## **Key Demographics January 1**<sup>st</sup>, 2020

As of Friday January 1<sup>st</sup>, 2021, New York City's jails held:

- 4,509 people in pre-trial detention
- 133 people serving a city sentence
- 197 people held on technical parole violations with no open case
- 128 people in custody for other reasons (e.g., state sentenced, state ready)
- 726 people age 50 and over, including 44 held solely on a technical parole violation


## Jail Population & Decarceration Discussion

Housing Area Density

- The proportion of people housed in units above 50% capacity declined steadily from March to early-June 2020 and increased from early-June to October 2020.
- Since October 2020, the proportion of people in units above 50% capacity has decreased by 15%: from 82% on October 31<sup>st</sup>, 2020 to 70% on January 1<sup>st</sup>, 2021.

### Percentage of Jail Population Housed in Units Above 50% Capacity March 16, 2020 - January 1, 2021





• Between December 25<sup>th</sup>, 2020 and January 1<sup>st</sup>, 2020 the average daily population in housing areas above 50% capacity was 3,339, 70% of the average daily population in custody.

## Rehousing Estimates December 30<sup>th</sup>, 2020

As of December 30<sup>th</sup>, 2020, and without accounting for operational or individual/specific security factors, Board staff estimate that to achieve 50% capacity level across all **General Population** housing areas the Department would need to:

- Rehouse ~858 people in GP units that exceed 50% capacity: 420 in cell units and 438 in dorm units.
- Open a minimum of 19 general population units,

An additional ~50 people in **Mental Observation** units and ~65 people in **Protective Custody** housing would need to be rehoused to achieve 50% capacity in those units.

## Housing Area Density Discussion

Testing Strategy & Mask Use

- Between late-June and late-November 2020, CHS administered an average of 131 tests per day; the rate of tests administered per 100
  people in custody ranged between 0 and 1.
- This rate increased in December 2020 when the tests administered per 100 people in custody ranged between 2 and 3.
- As of December 20th, 2020, roughly 3 tests were administered for every 100 people in custody.
