

COVID-related Grievances

COIVD-related Grievances: Key Findings

- From May 1st to December 31, 2020:
 - DOC received a total of 21,336 grievances (including concerns and requests for information), six percent (6%, n=1,327) of which OCGS categorized as COVID-related
 - the jail population increased by 29% from a census of 3,824 on May 1st to a census of 4,940 on December 31st
 - the monthly total number of grievances received by OCGS increased by 111%, from a total of 1,728 in month of May to 3,644 in December, and
 - the number of COVID-related concerns increased by 197% from 92 in May to 273 in December

COIVD-related Grievances: Key Findings (cont.)

- Concerns about the lack of Social Distancing in the jails were the most frequent kind of COVID-related grievance received by OCGS (42%, n=561).
- COVID-related grievances showed a repeated pattern of concerns from people in custody
 about being housed with individuals who could potentially be COVID-19 positive, with sixteen
 percent (16%, n=208) of grievances about people concerned with COVID-19 Exposure Safety
 and 6% (n=80) about a lack of COVID preventive measures.
- The Board's review of DOC investigations into 38 COVID-related grievances found that in 84% (n=32) the Department completed detailed investigations which addressed all concerns in the grievance filed.

COIVD-related Grievances: Recommendations


- 1. The city should prioritize decarceration and the Department should reduce housing area capacity.
- 2. DOC and CHS should continue to work together with the Department of Health and Mental Hygiene on their COVID-19 public health campaign to communicate health risks and what actions people in custody and staff can take to protect their health and the health of those around them.
- 3. CHS should provide COVID test results to people in custody in writing.

Confirmed Cases

- The number of people in custody with confirmed COVID-19 (active and recovered) began to rise in November.
- As of March 1st, 10% of the population, a total of 539 patients in jail had confirmed COVID-19 (active and recovered); with 1% of the population, 59 patients having an active COVID infection.

Each day shows new cases reported since the previous day



- CHS and DOC reported fewer new staff cases in February compared to January.
 - CHS reported a total of 30 new cases in January and 19 in February.
 - DOC reported a total of 153 new cases in January and 95 in February.
- As of March 1st, the cumulative case count for DOC staff was 1,872; for CHS it was 284.

Each day shows new cases reported since the previous day




NOTE: CHS began reporting positive staff cases to the Board on March 18th, 2020. DOC began reporting positive staff cases to the Board on March 21st, 2021.

Jail Population & Decarceration

- On April 29th, there were 3,832 people in jail, a historic low.
- Since April 29th, the number of people in jail has increased by 46%, reaching 5,577 on March 1st and exceeding the jail population pre-pandemic.

DOC population by Custody Status and Key Demographics as of March 5th, 2021

As of Friday March 5th, New York City's jails held:


- 4,878 people in pre-trial detention
- 180 people serving a city sentence
- 254 people held on technical parole violations with no open case
- 255 people in custody for other reasons (e.g., state sentenced, state ready)
- 808 people age 50 and over, including 59 held solely on a technical parole violation

Housing Area Density

- The proportion of people housed in units above 50% capacity began to decrease in November, as COVID cases in the jails began to rise.
- Since November, the proportion of the jail population in units above 50% capacity has decreased by 18%: from 82% on November 1st to 67% on March 1st.

Figures are presented as a 7-day moving average





Between February 27th and March 5th, the average daily population in housing areas above 50% capacity was 3,601, 70% of the average daily population in custody.

Rehousing Estimates March 1st, 2021

As of March 1st, 2021, and without accounting for operational or individual/specific security factors, Board staff estimate that to achieve 50% capacity level across all **General Population** housing areas the Department would need to:

- Rehouse ~972 people in GP units that exceed 50% capacity: 479 in cell units and 493 in dorm units.
- Open a minimum of 31 general population units.


An additional ~72 people in **Mental Health** units and ~86 people in **Protective Custody** housing units would need to be rehoused to achieve 50% capacity across those specialized units.

Testing Strategy

The COVID-19 testing rate increased from November to December. Since December, there have been 2 to 3 tests administered for every 100 people in custody.


Daily COVID-19 Tests Per Hundred People in Custody¹ June 29, 2020 – February 21, 2021

¹ BOC calculates the rate of testing as the proportion of (a) the daily number of tests administered to individuals per (b) the daily jail census count: (a) is derived from metric # 4 in CHS's Local Law 59 reports and (b) is derived from DOC's Inmates in Custody files.

As of Sunday, March 7th, there were 32 active infections among people in custody and a 7-day average daily positivity rate of 1.70%.
