Table 2	<p>Number of injury reports by determination.</p> <p>Confirmed injury is defined as an injury by history only, injury with physical evidence, or injury that resulted in urgent care or hospital transfer.</p> <p>Serious injury is defined as any one of the following: laceration requiring sutures; staples or glue, fracture, clinical nasal fracture, initial dislocation reduced in clinic or hospital, tendon tear, amputation, structural injury to organ, post-concussive syndrome or head injury requiring imaging, blistering burn involving face or >9% of total body surface.</p>
