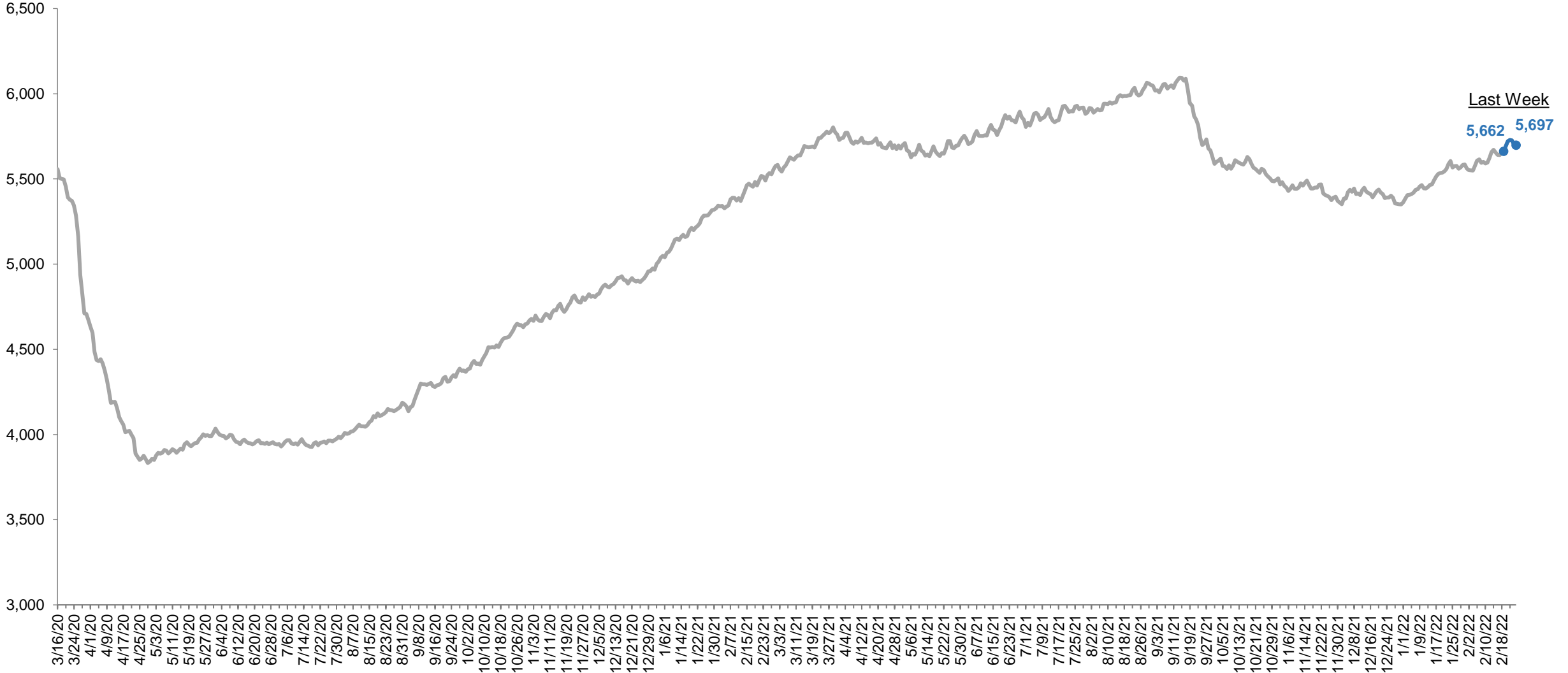

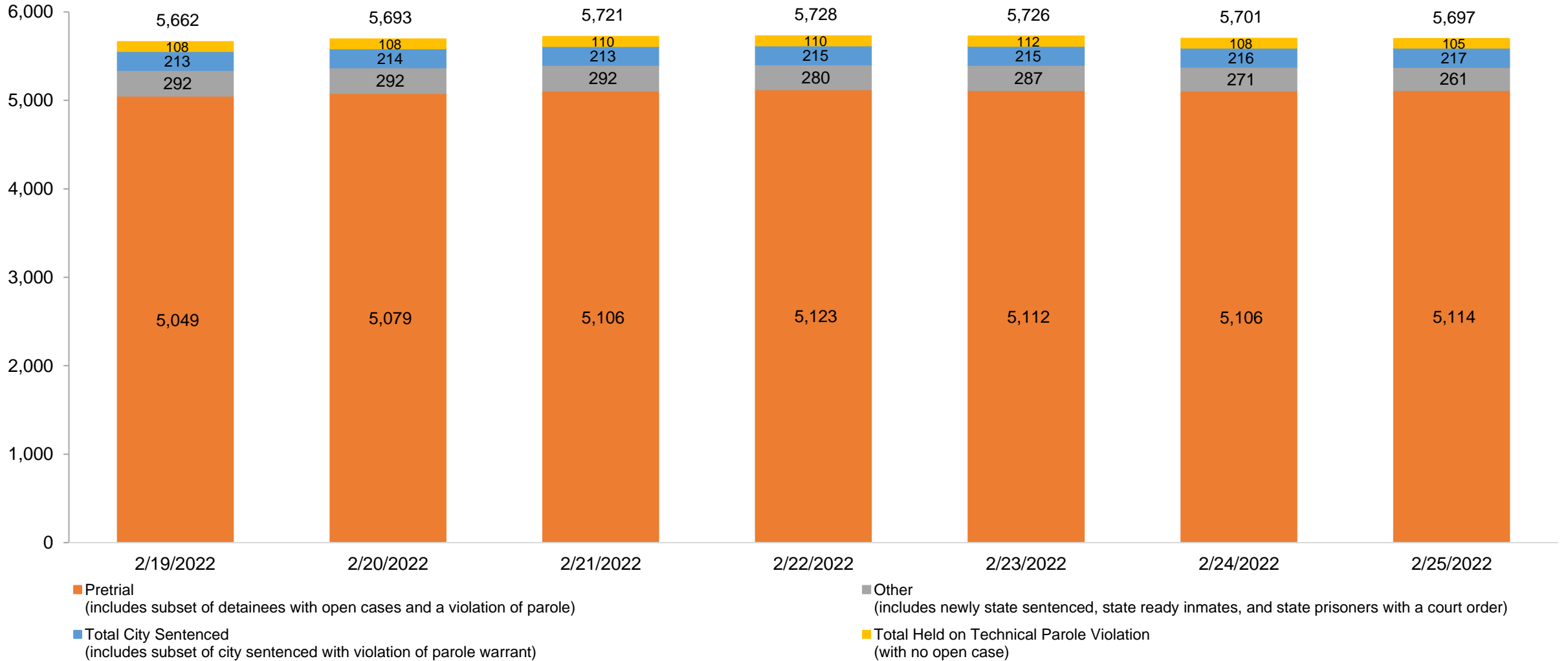

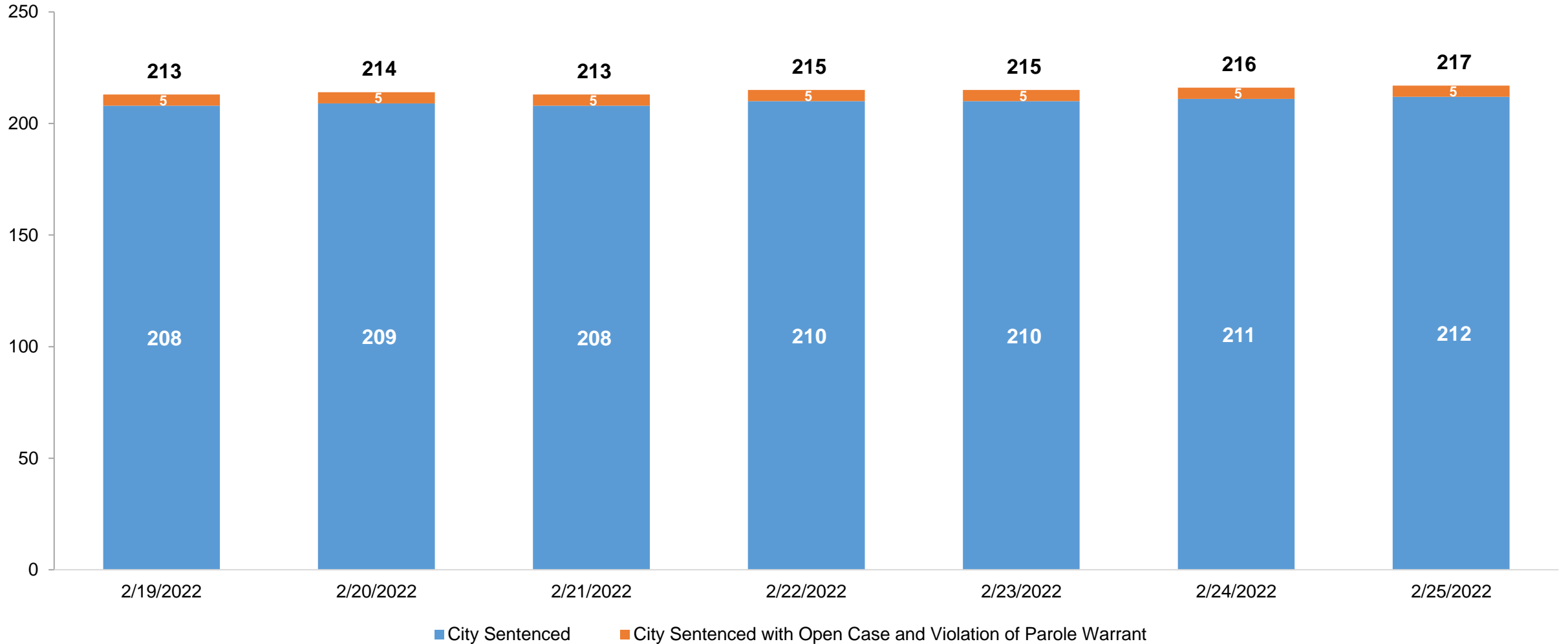

February 19, 2022 – February 25, 2022**

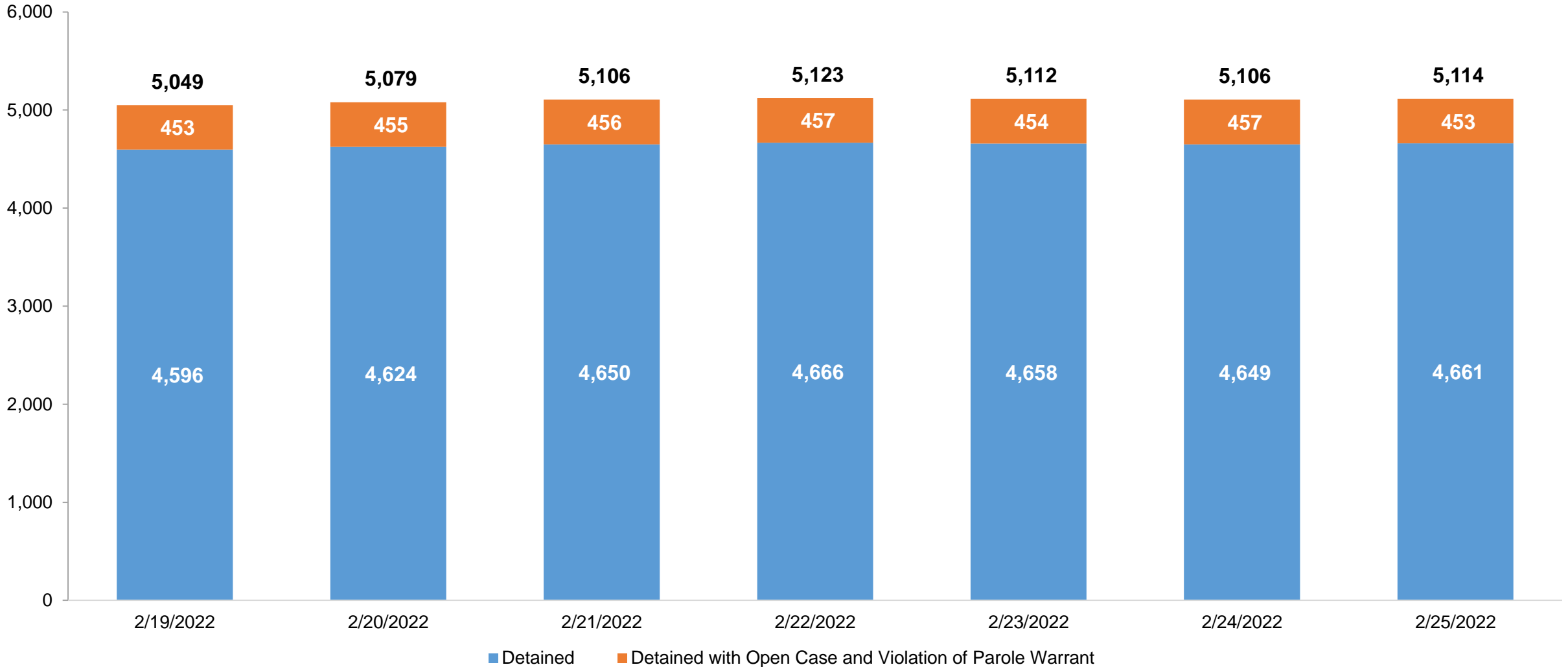

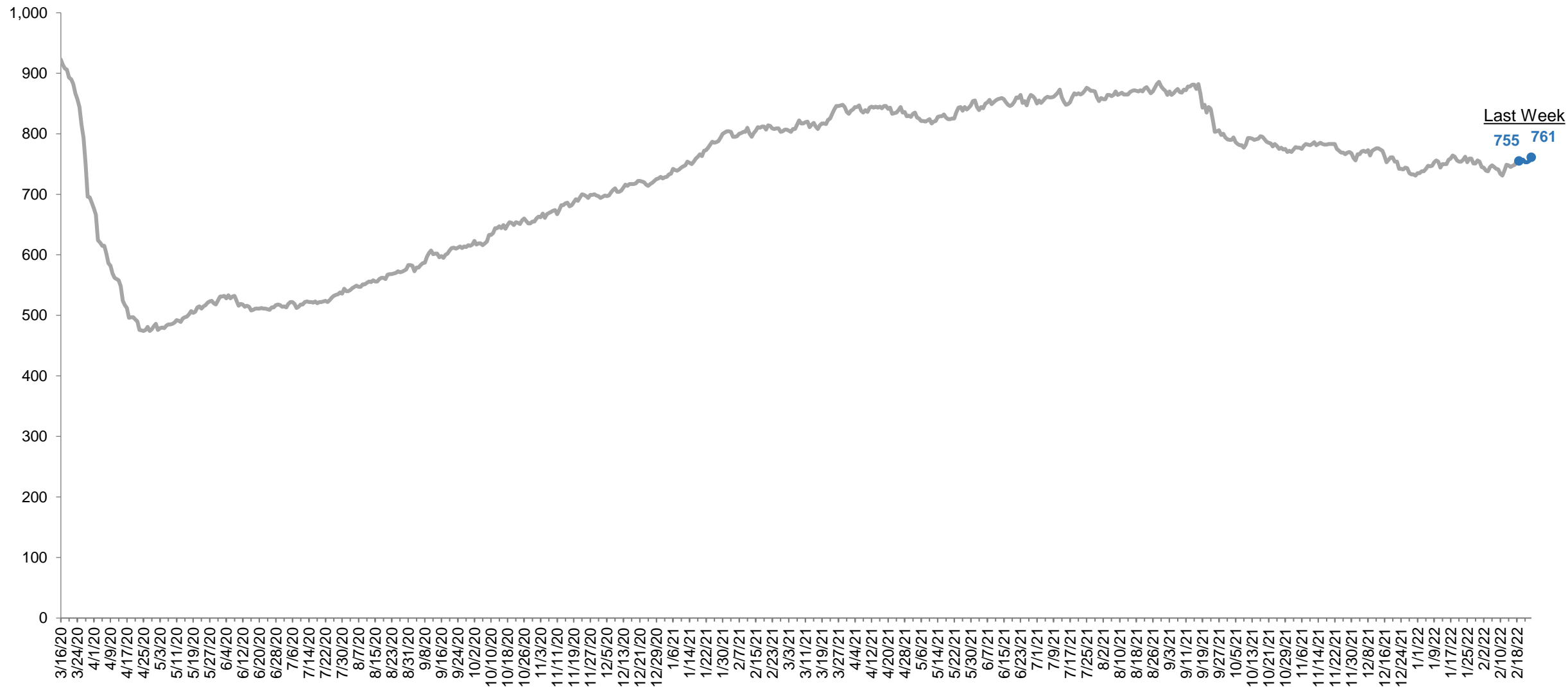

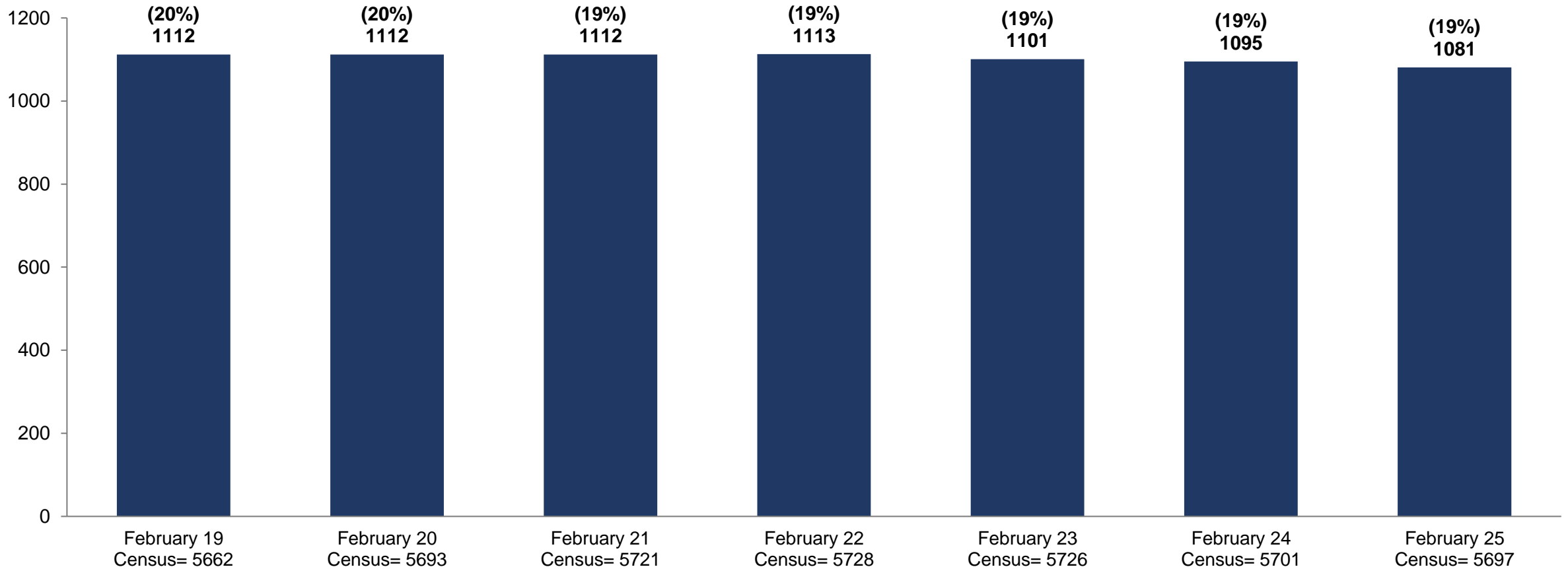

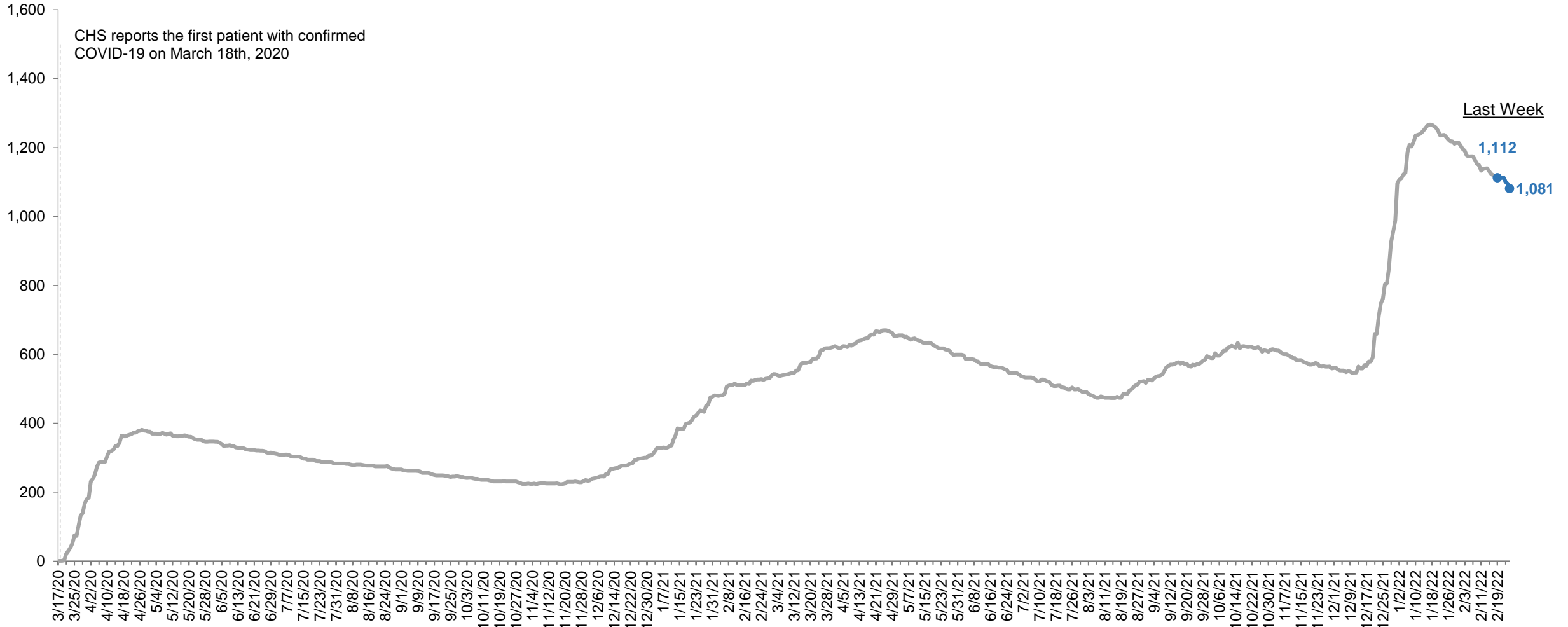
**Number and Percent of Patients Ever Confirmed Positive for COVID-19 While in Custody

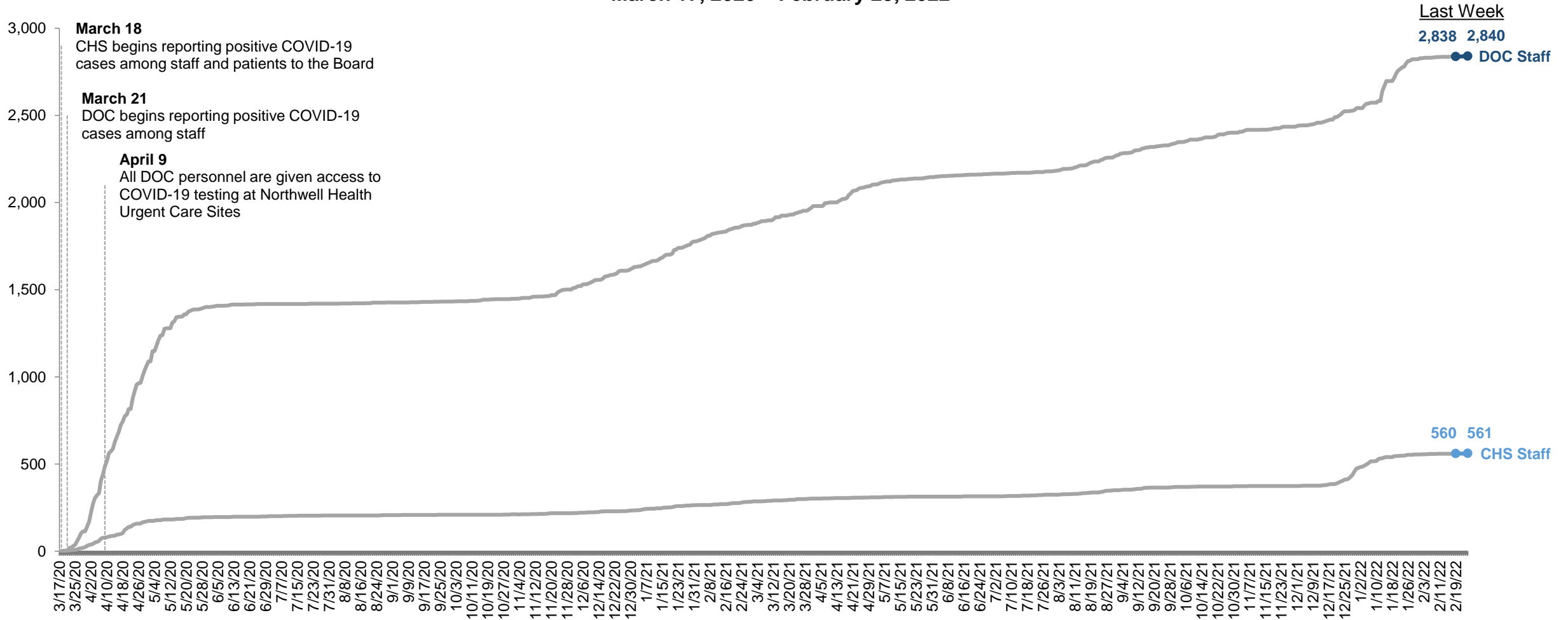

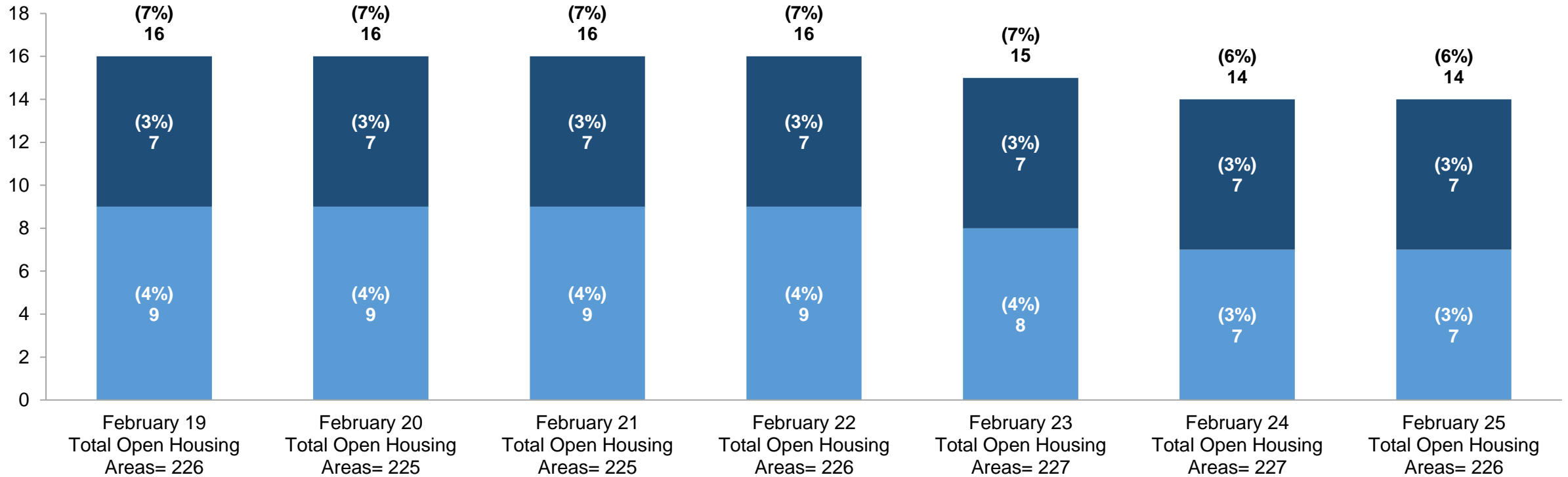

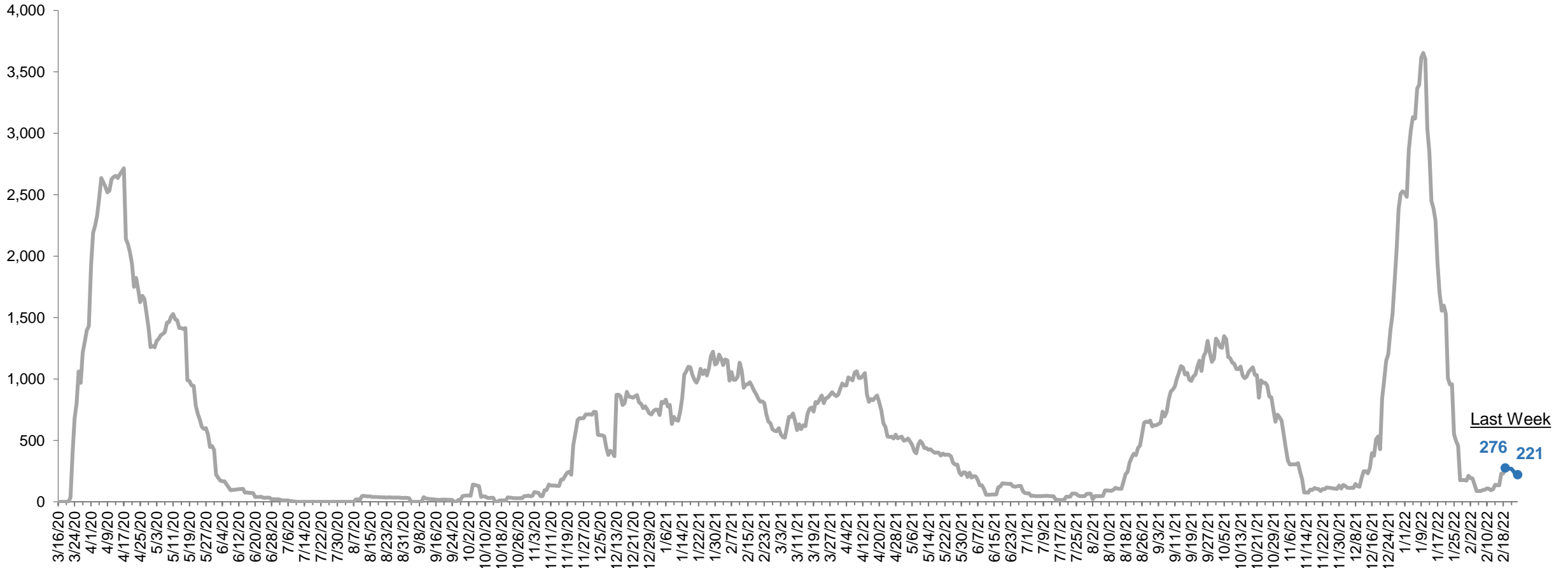

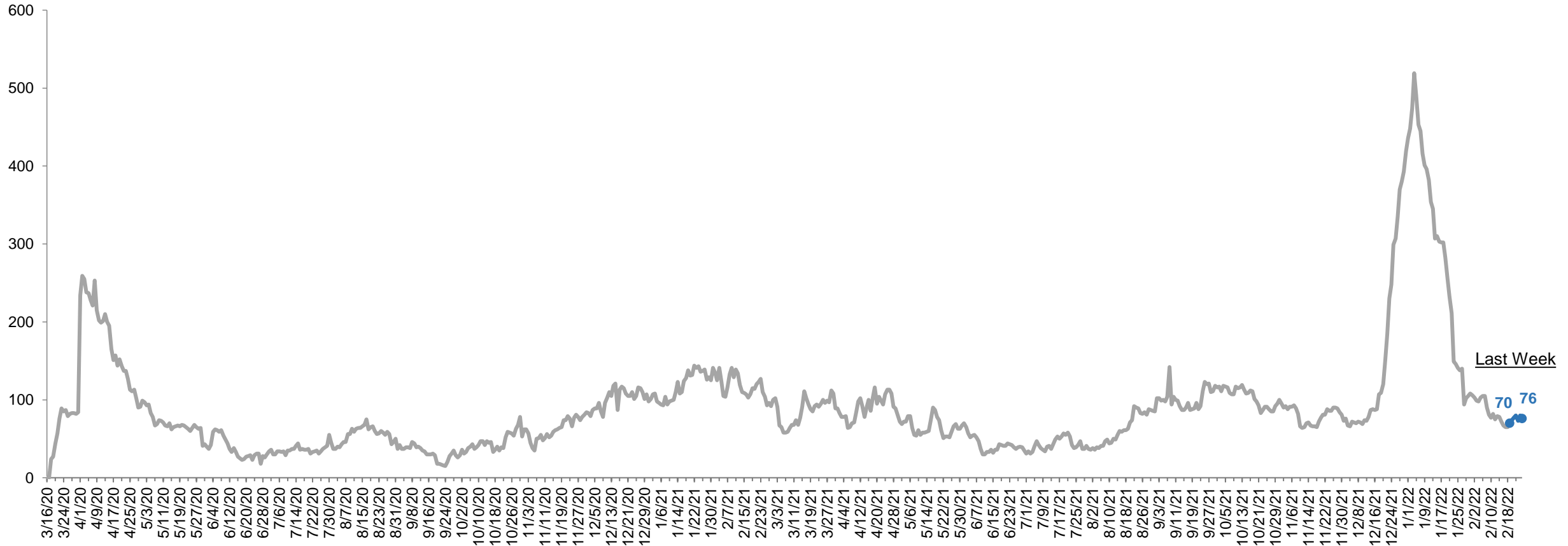

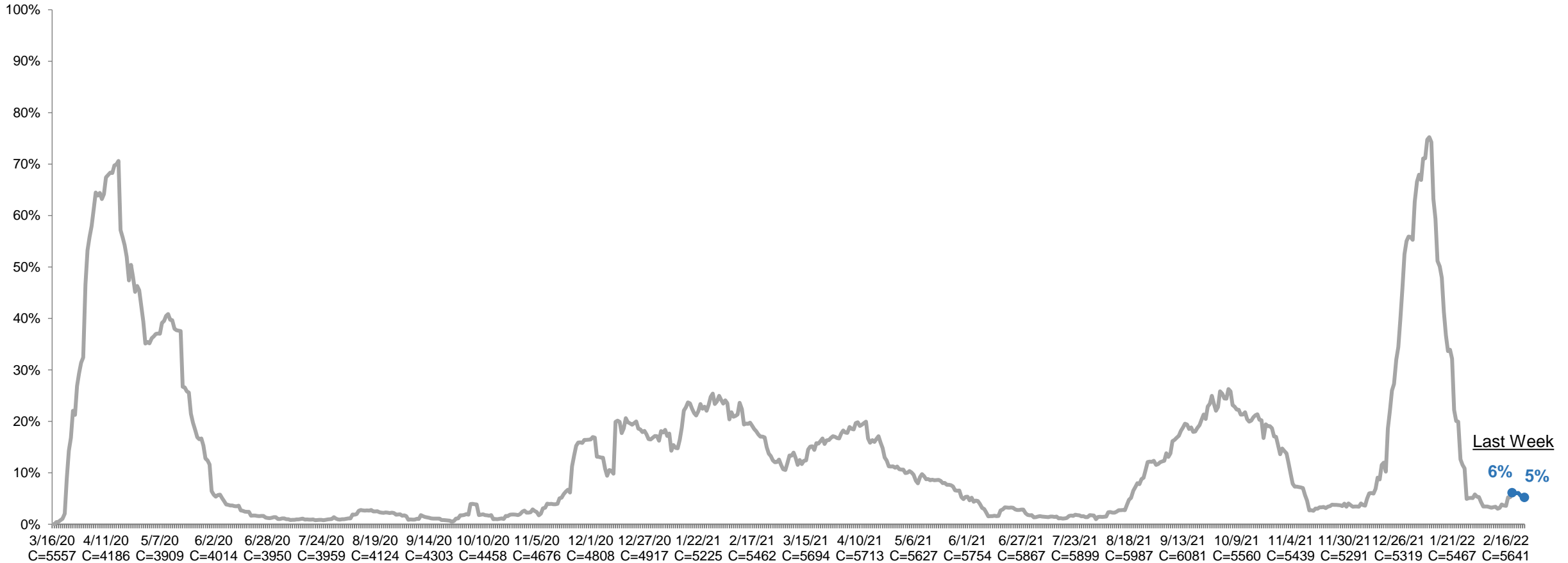

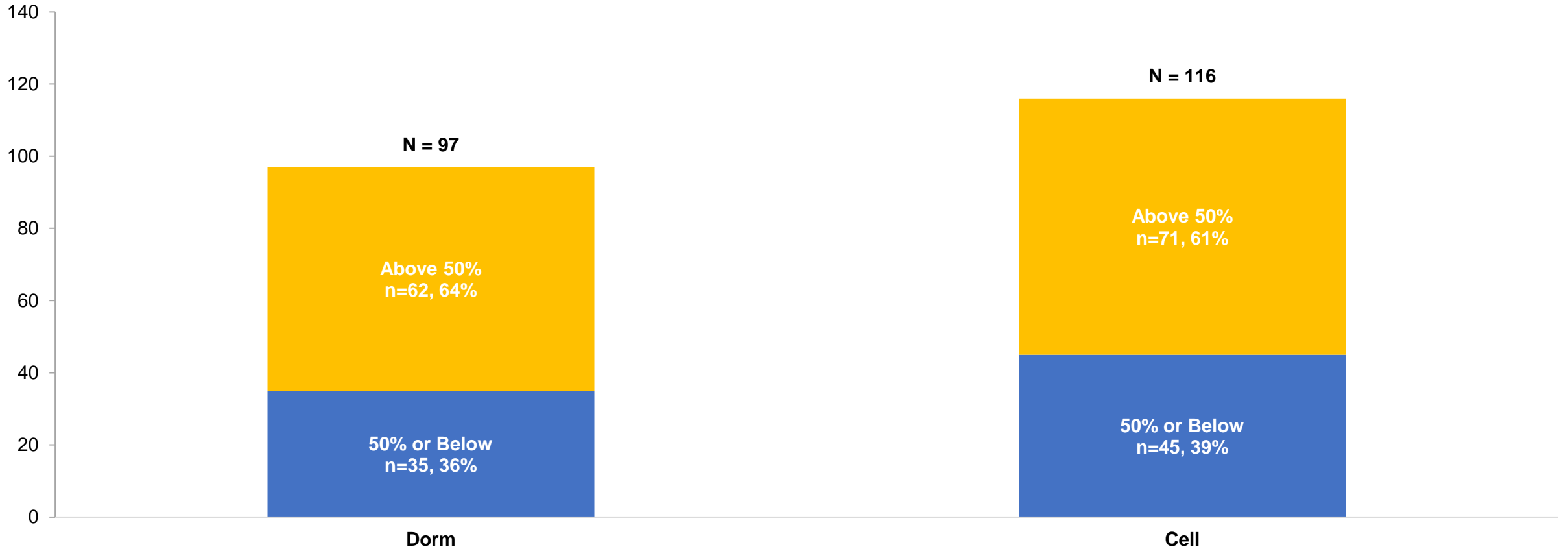

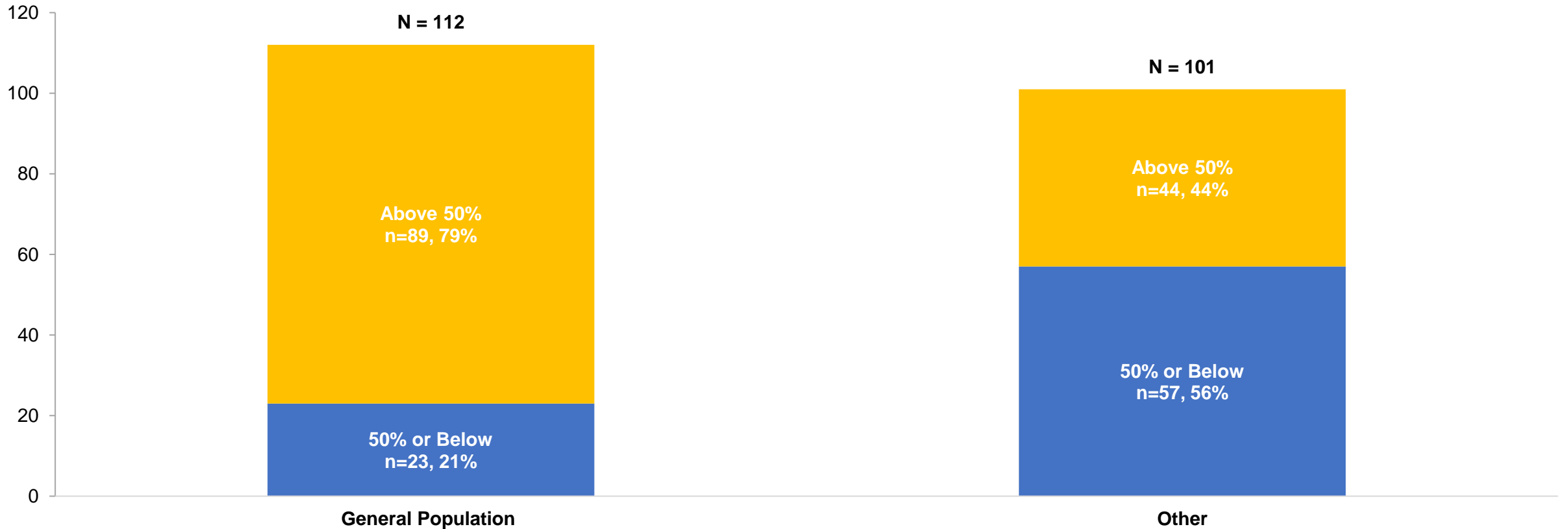

February 24, 2022



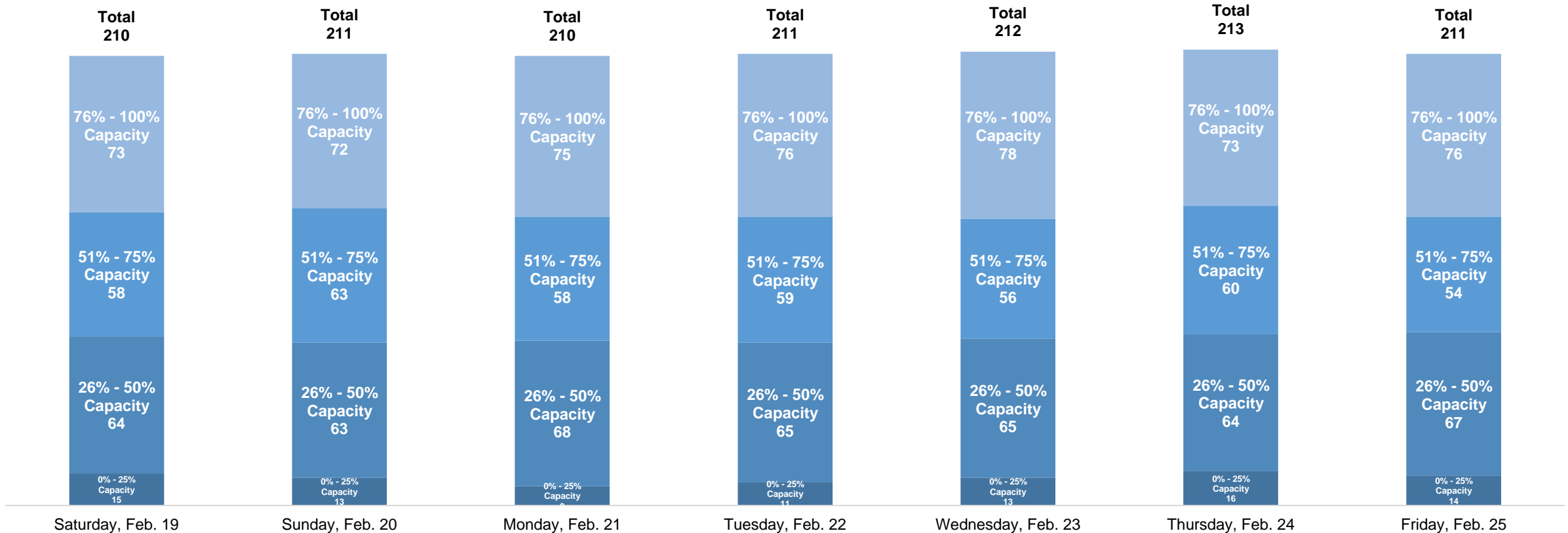
