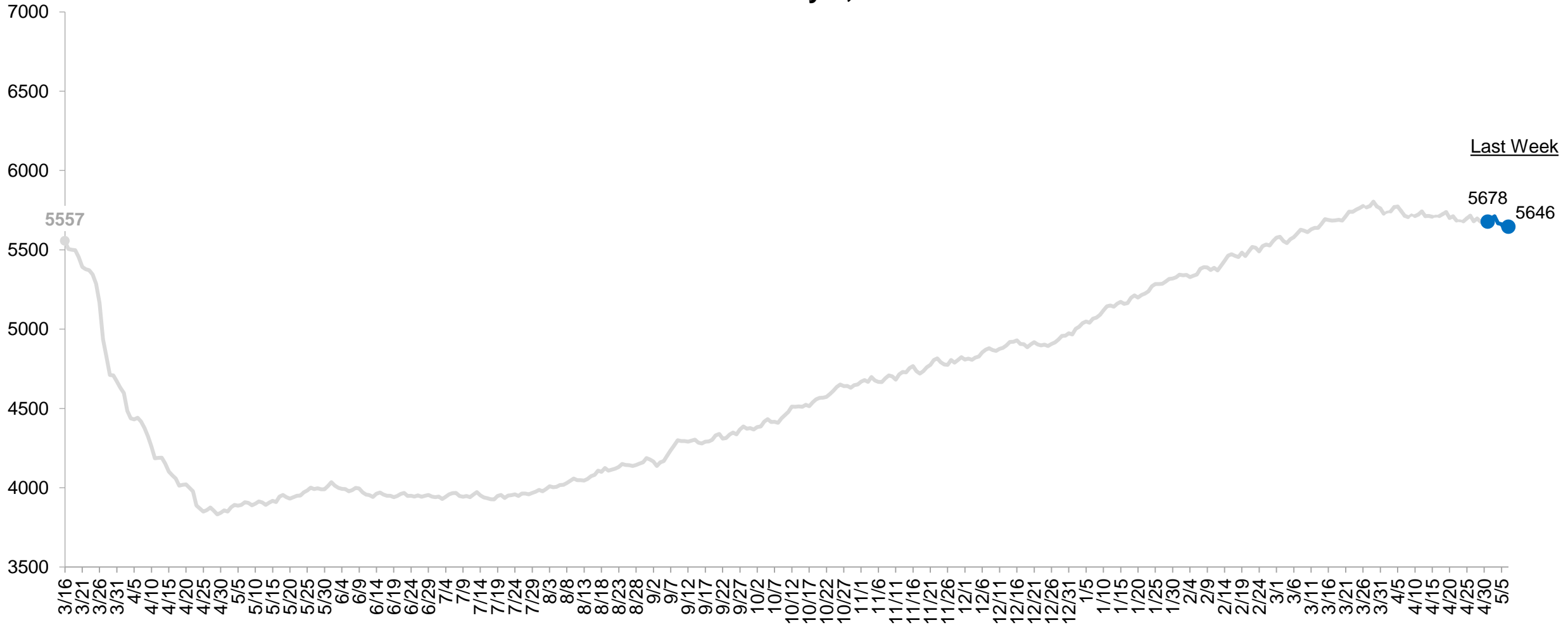

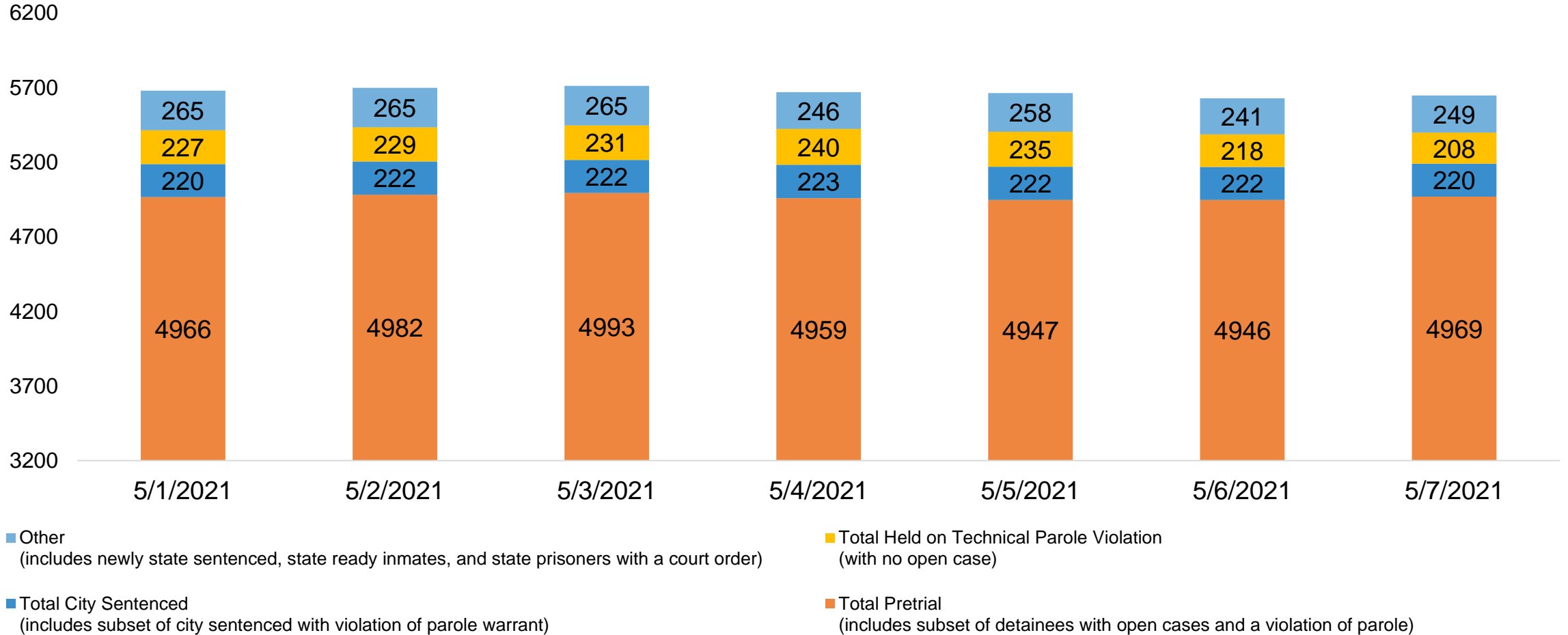
Total Population in DOC Custody March 16 - May 7, 2021

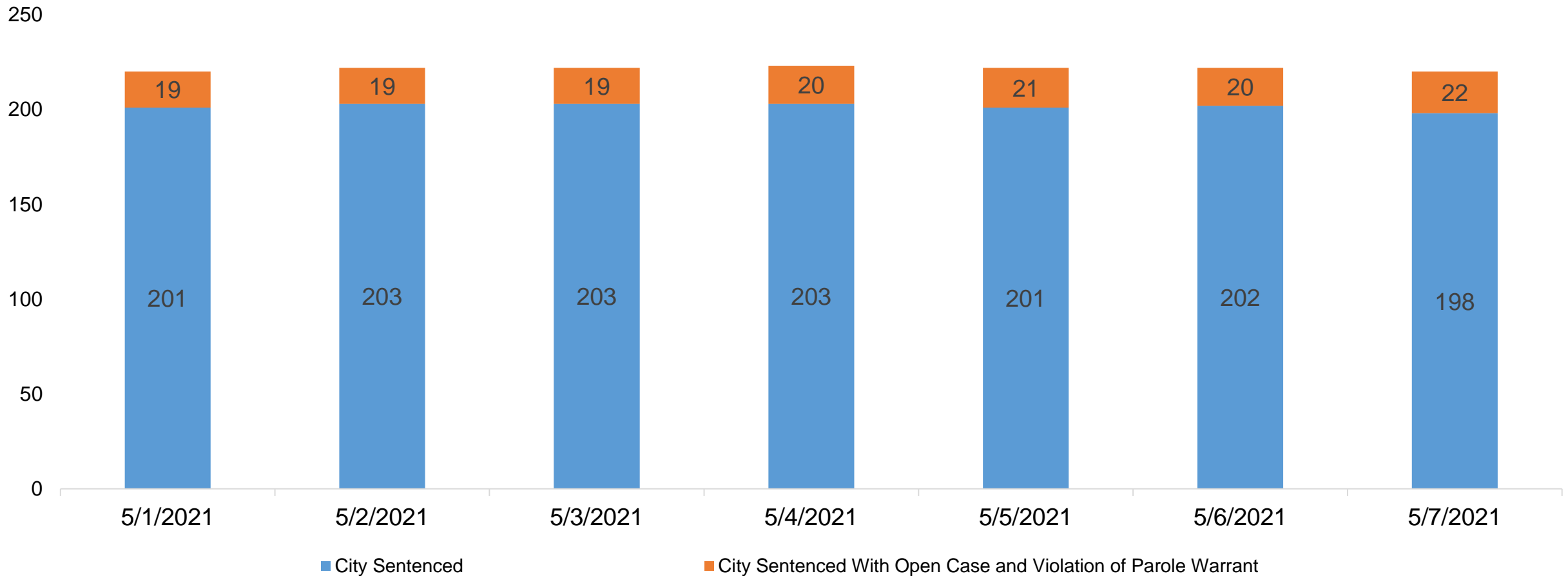

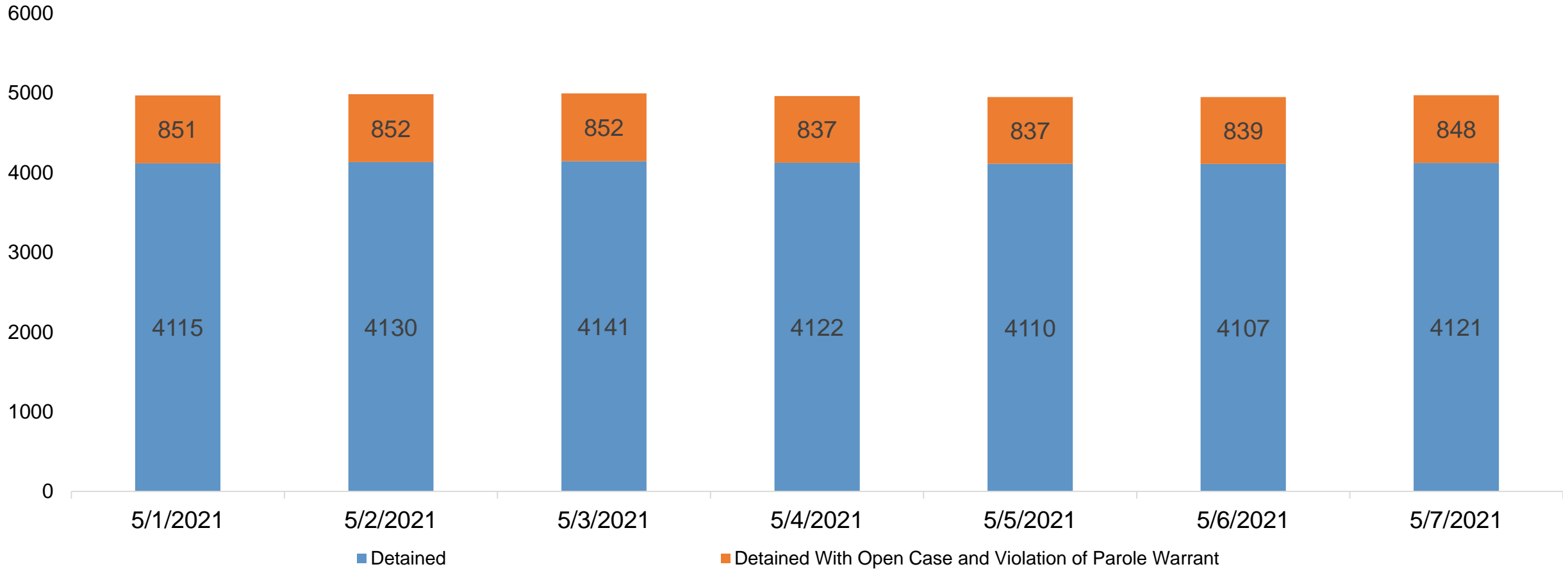
City Sentenced Population by Custody Status, 5/1/2021 - 5/7/2021

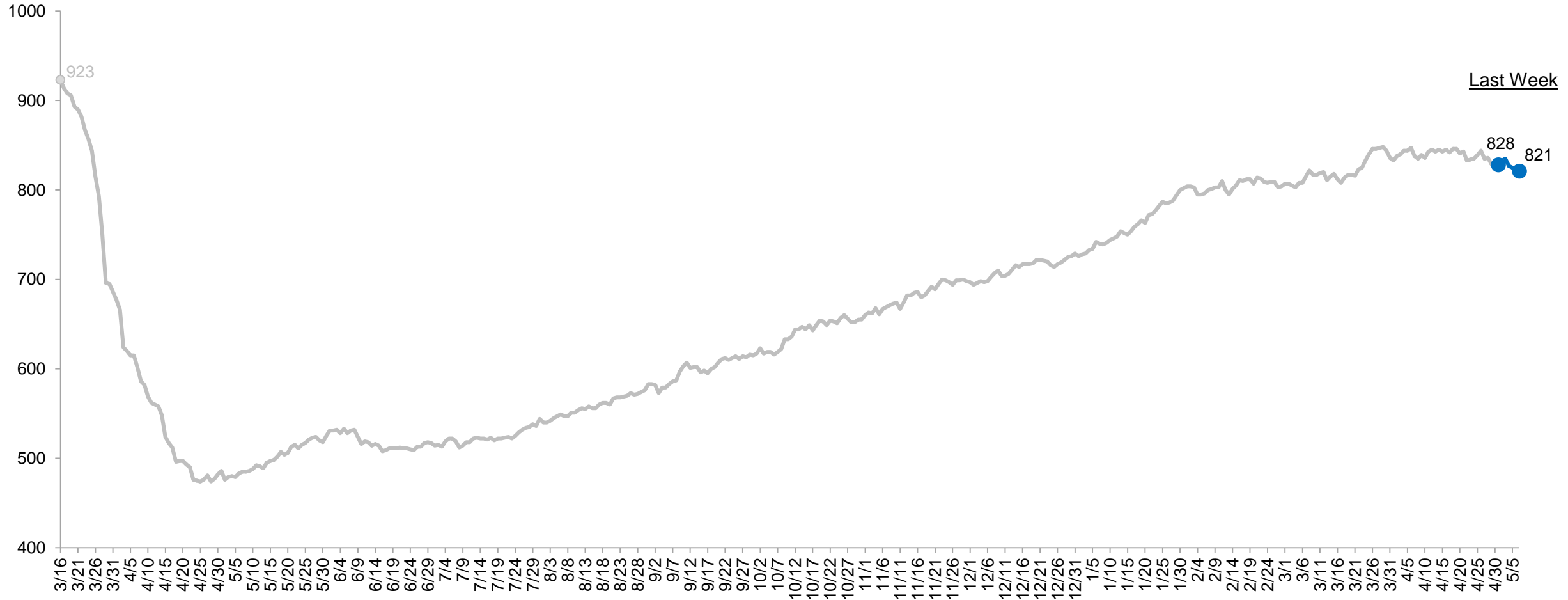

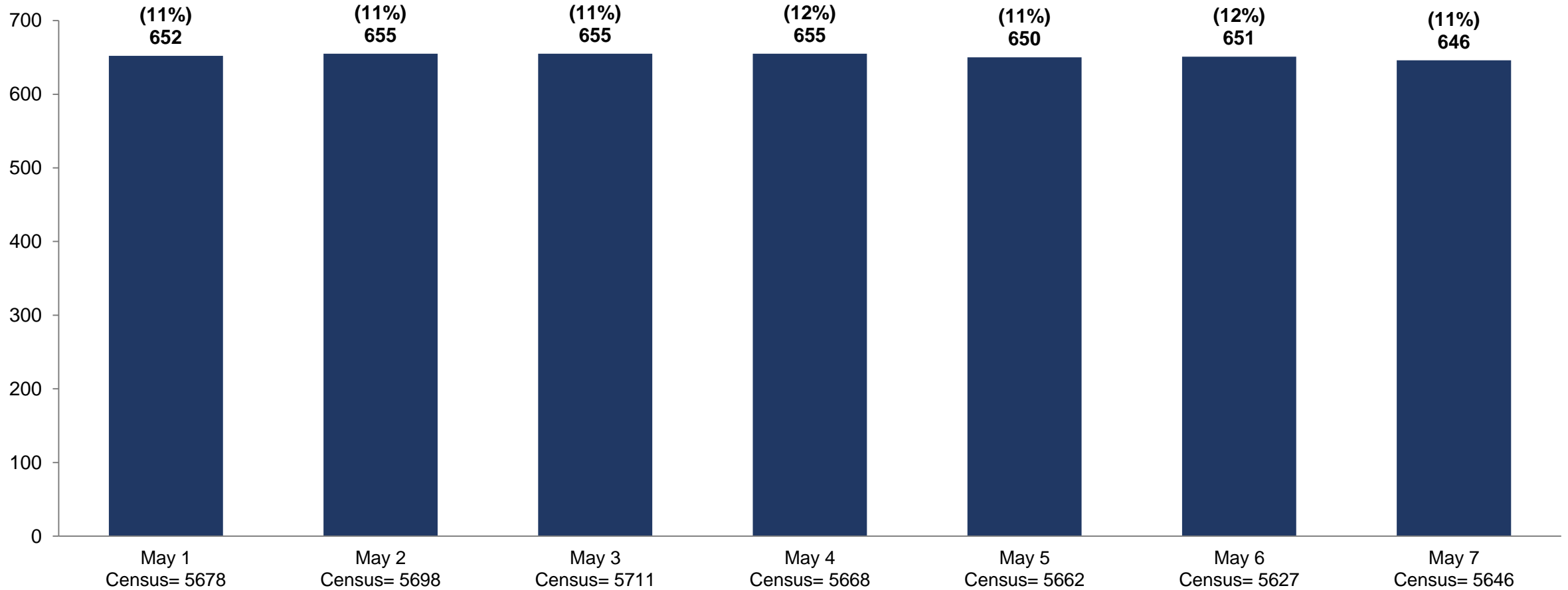

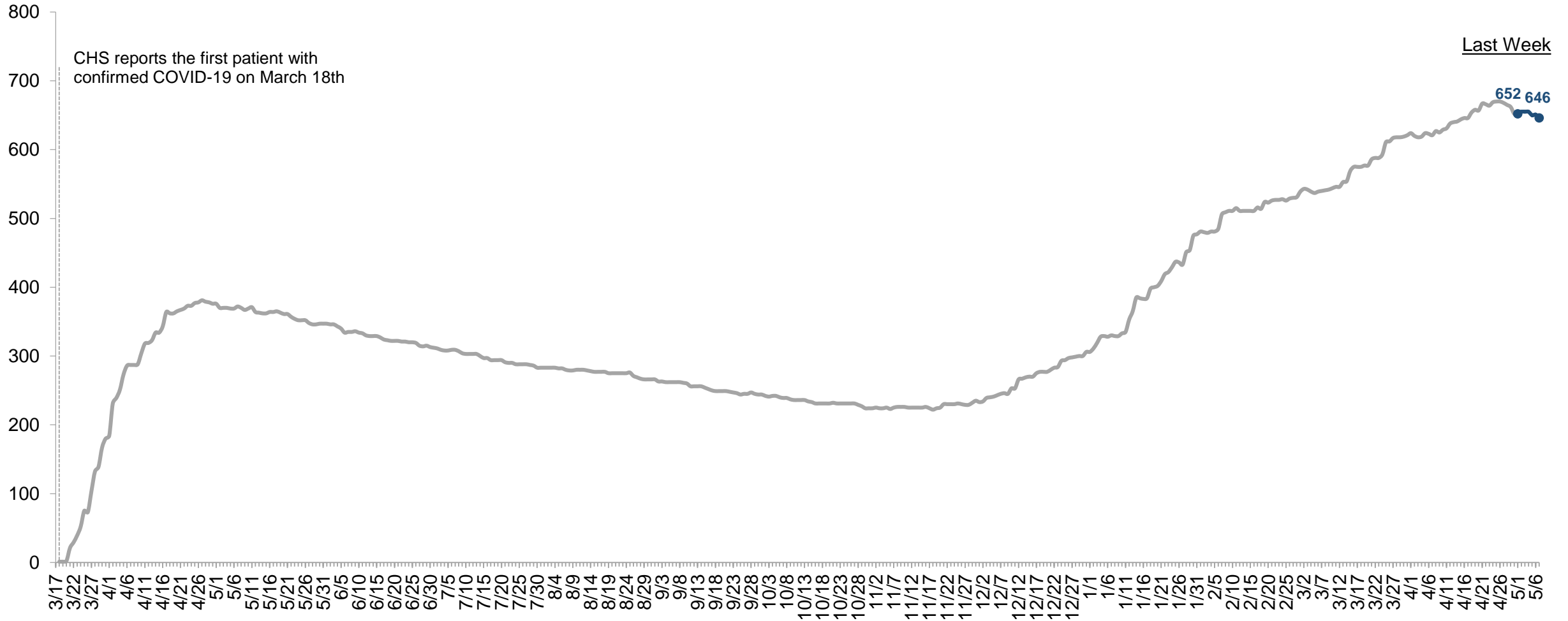
Number and Percent of Patients with Confirmed COVID-19

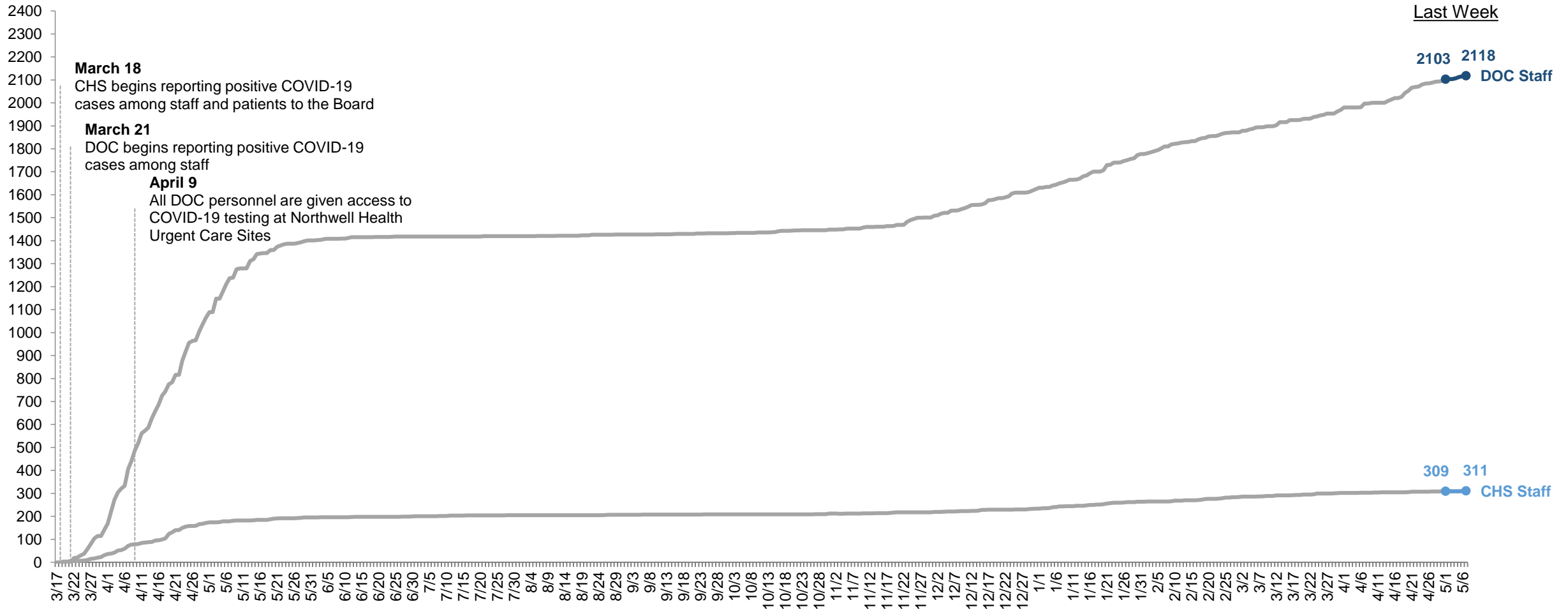
Number of Currently Incarcerated Patients with Confirmed COVID-19

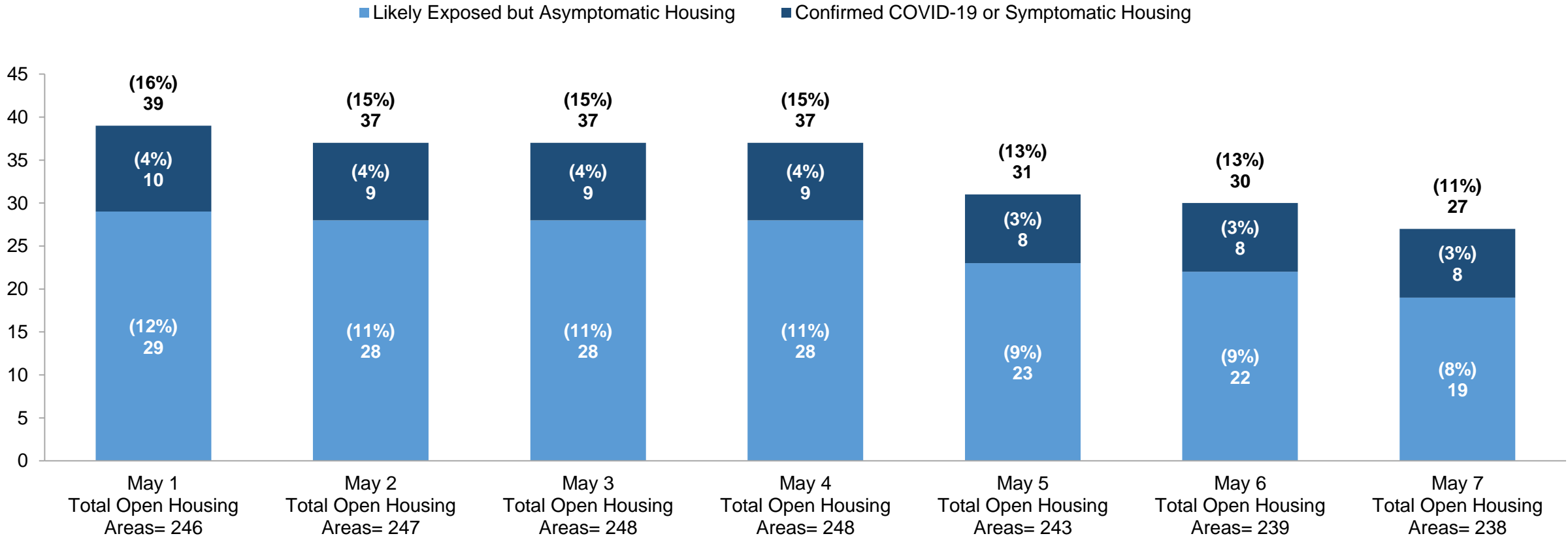

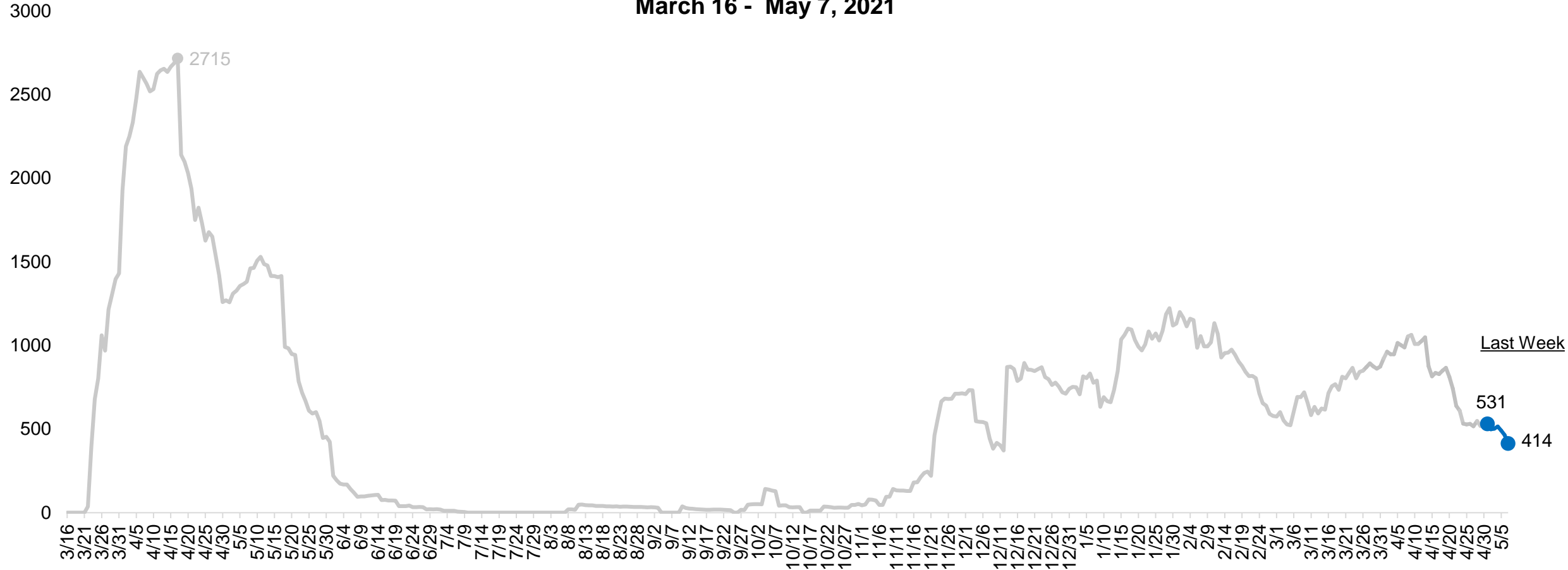

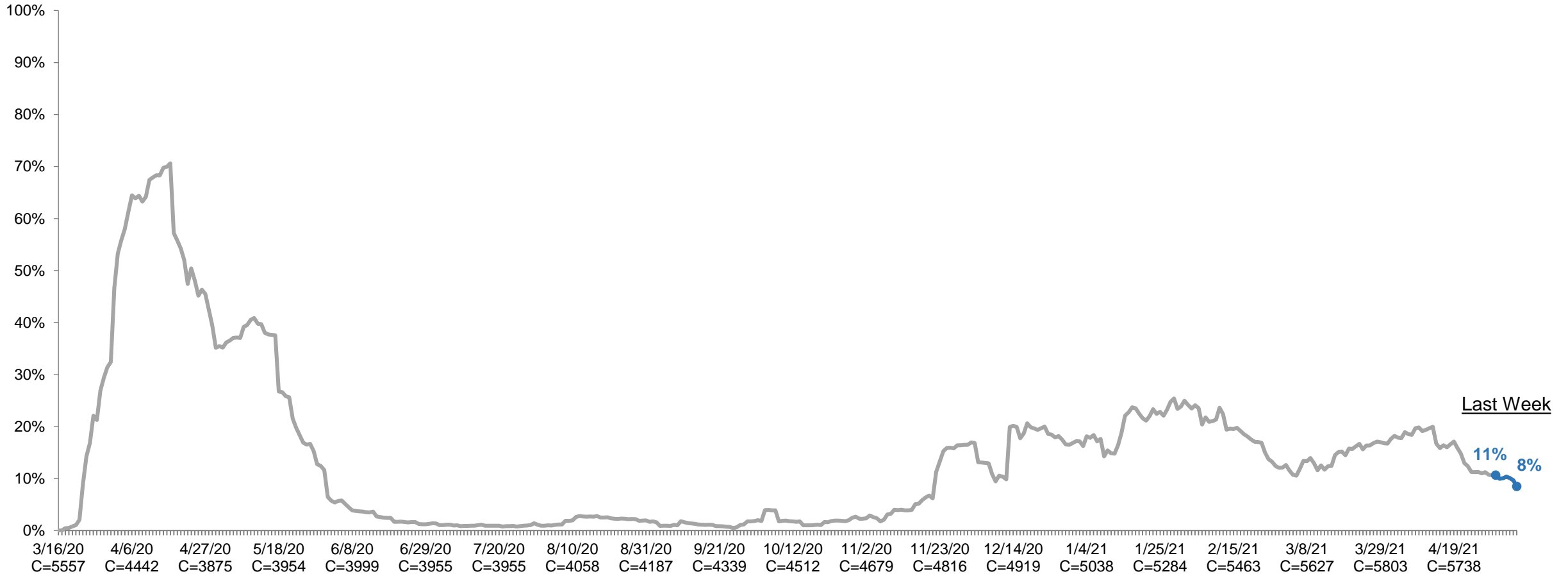

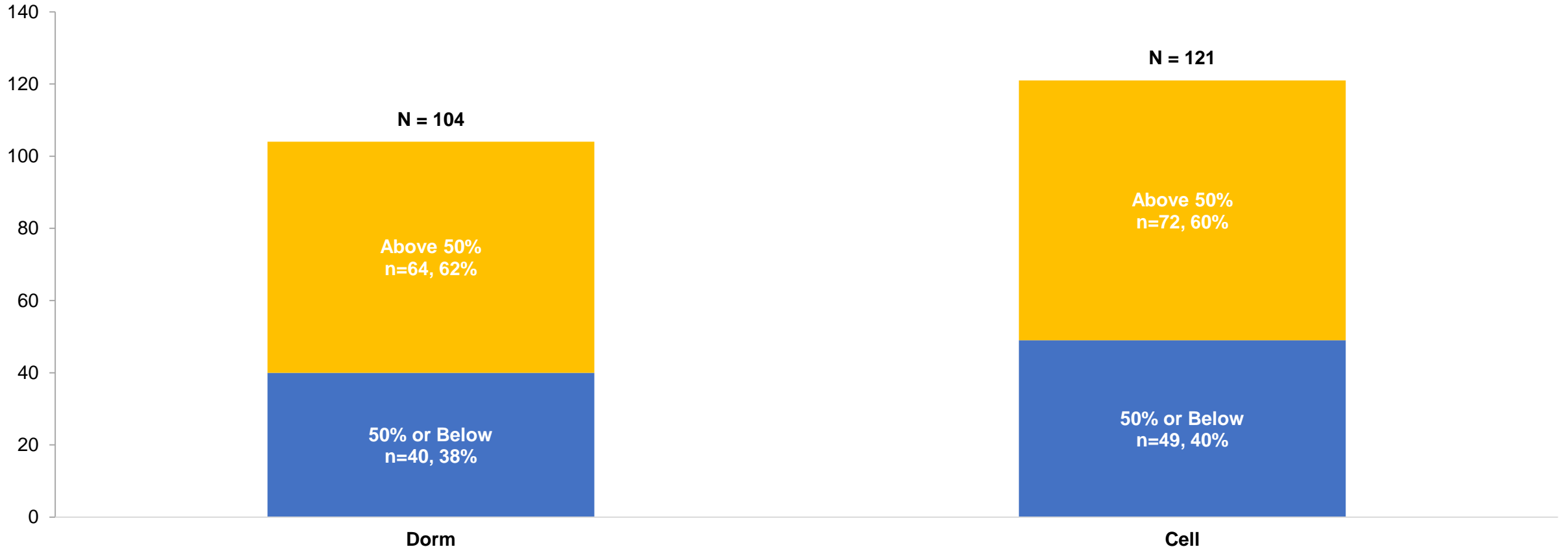

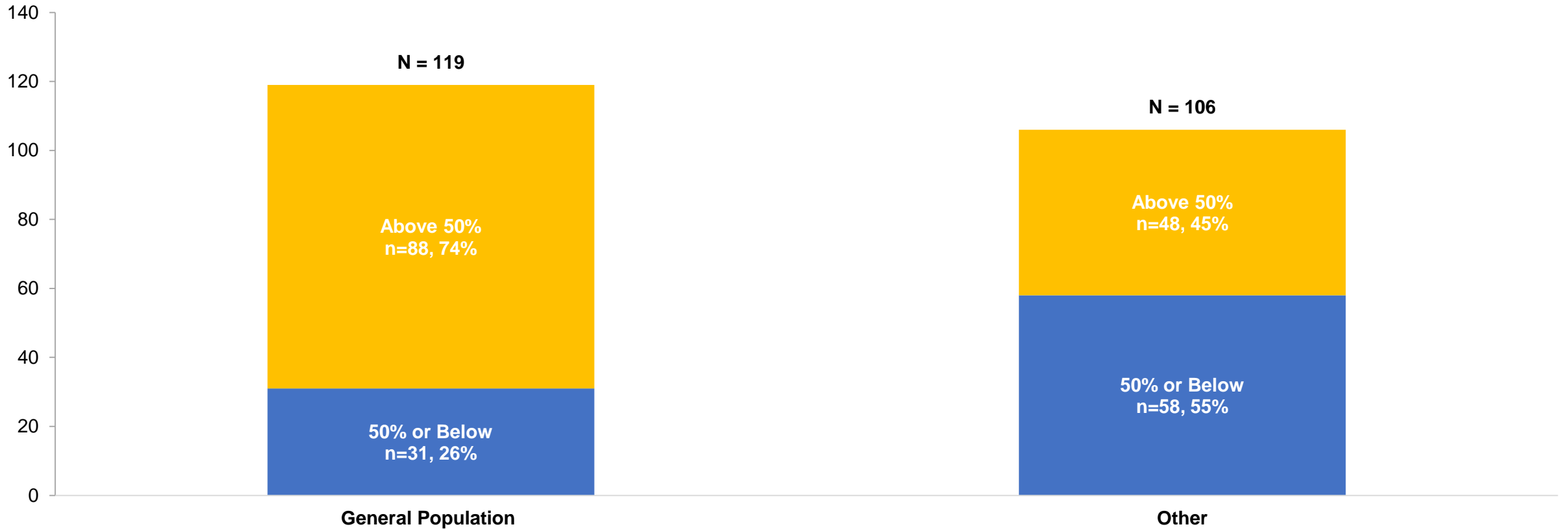

May 6, 2021



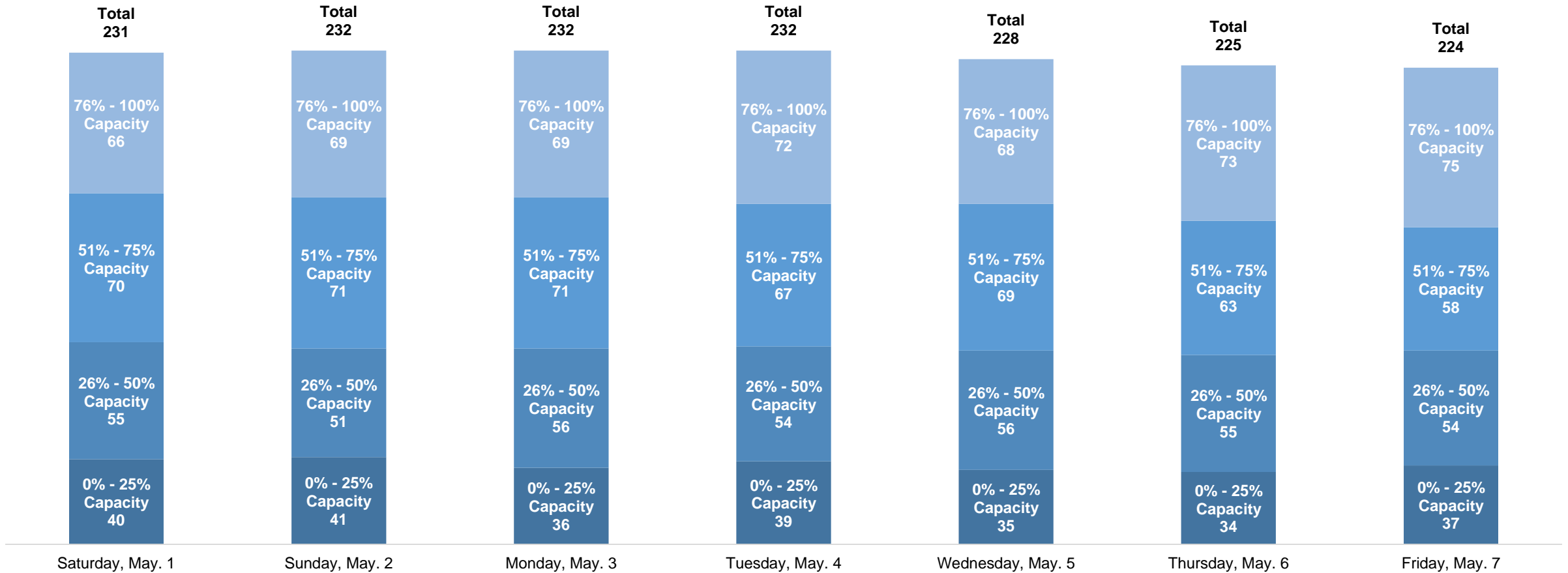
