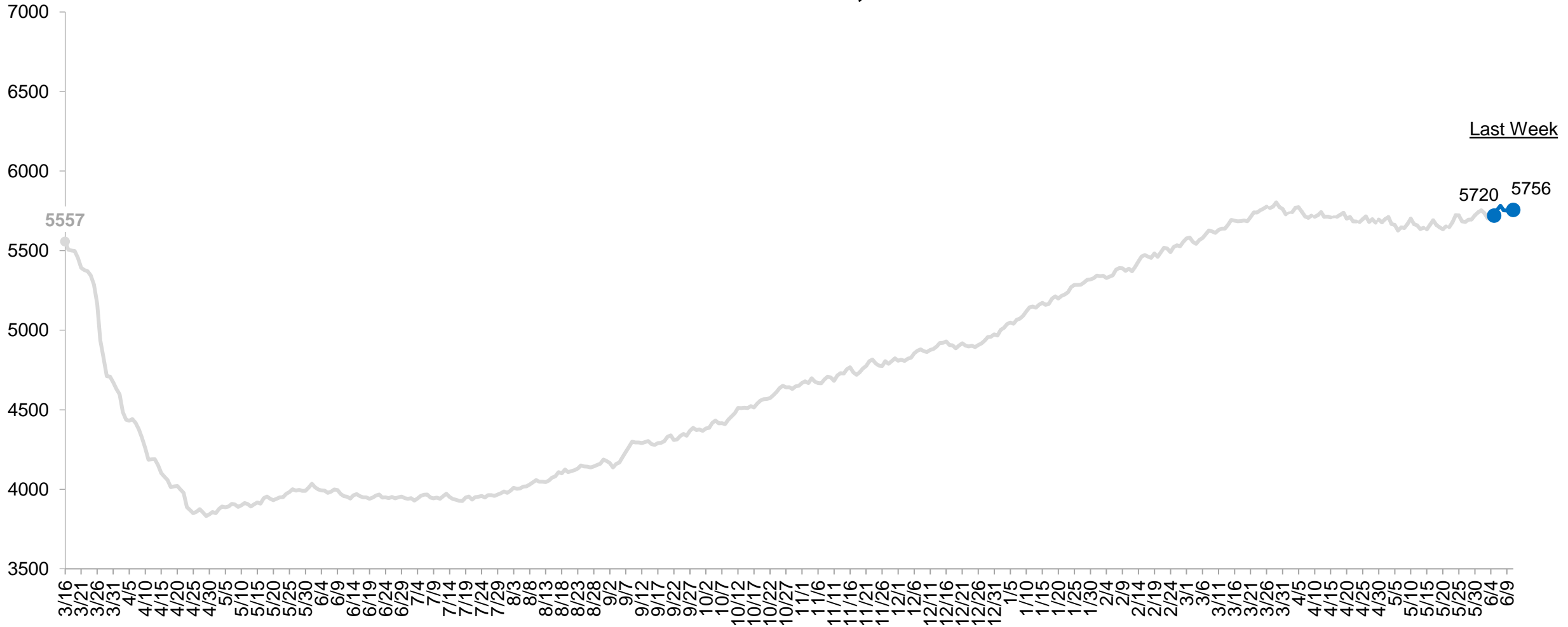

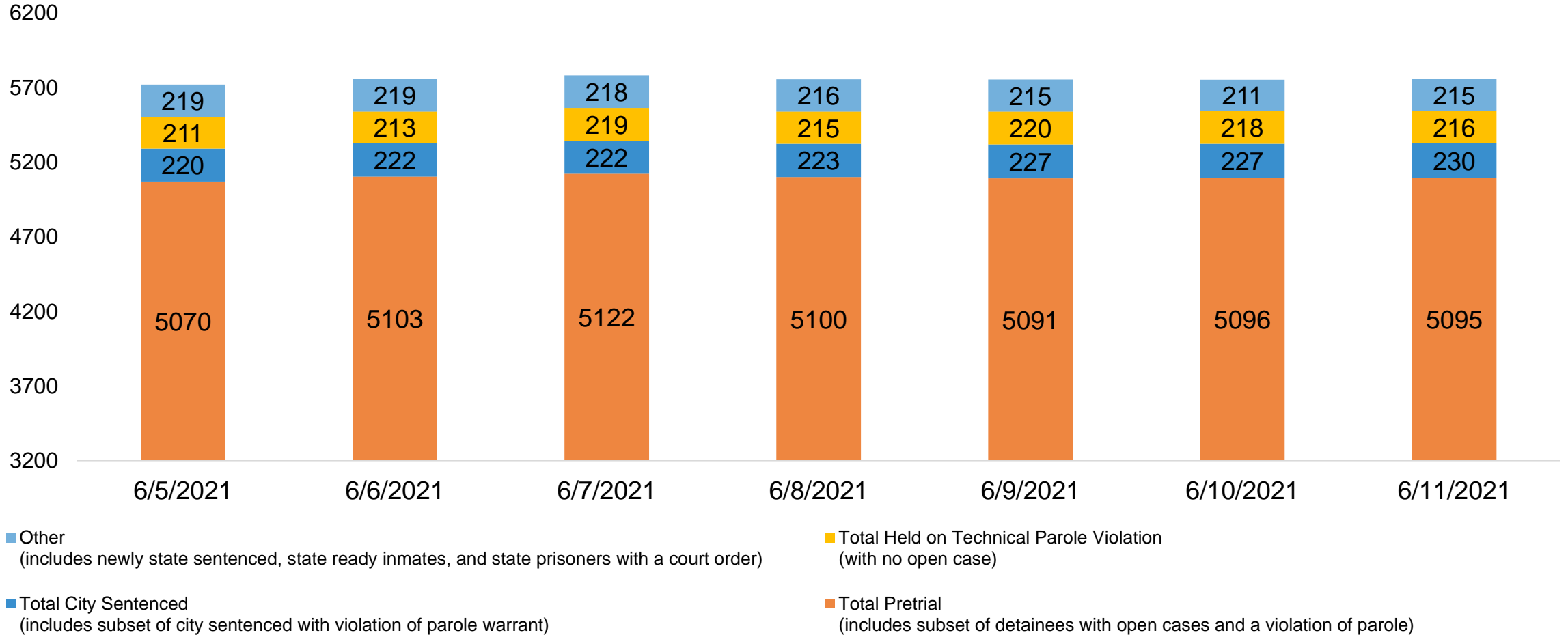
Total Population in DOC Custody March 16 - June 11, 2021

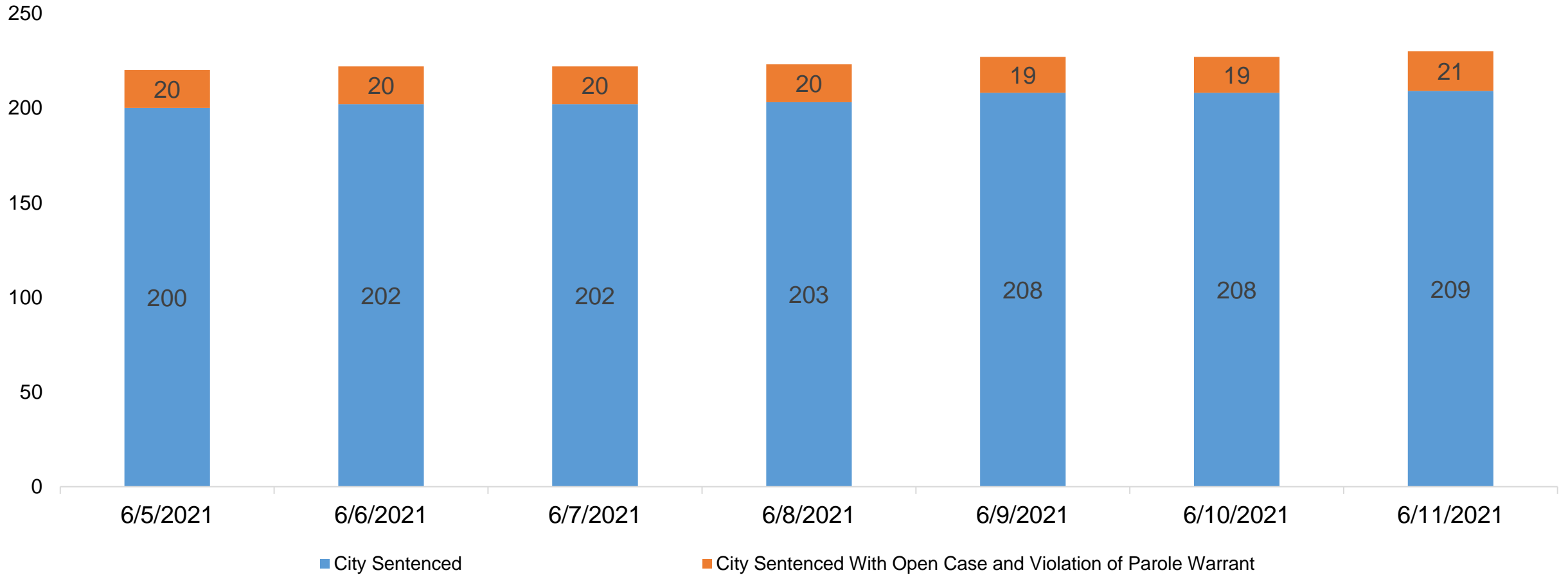

Total DOC Population by Custody Status, 6/5/2021 - 6/11/2021



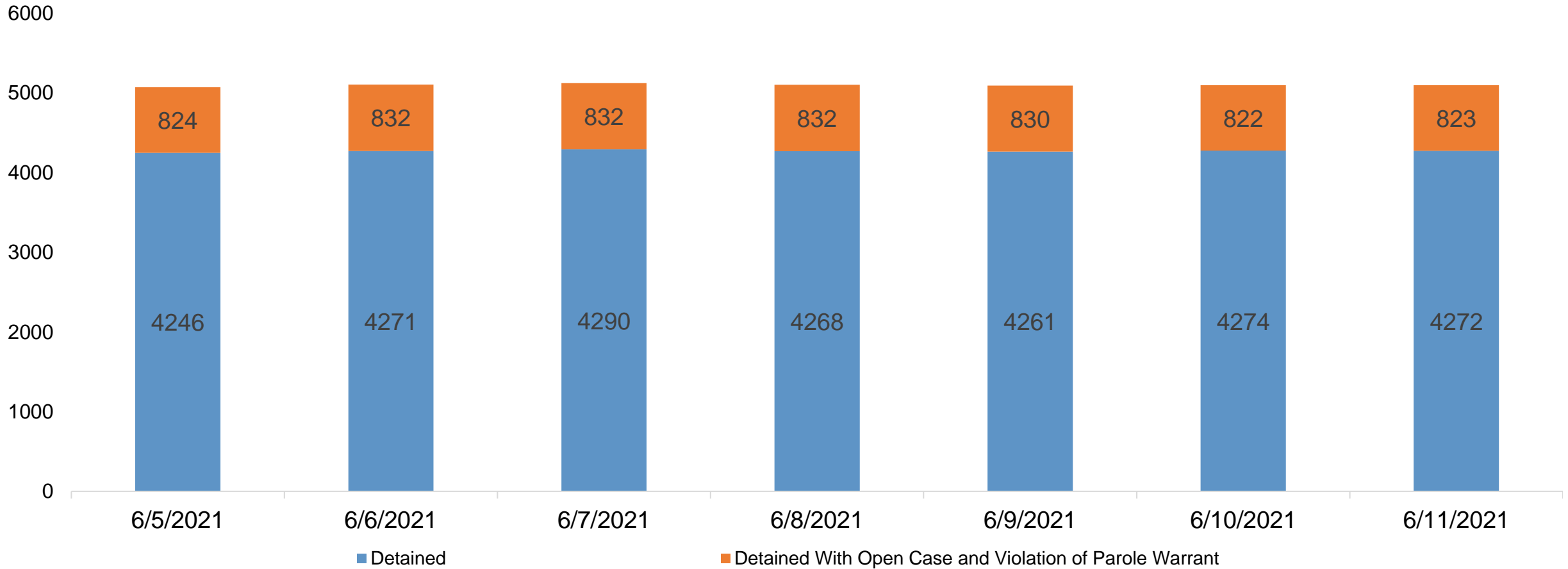

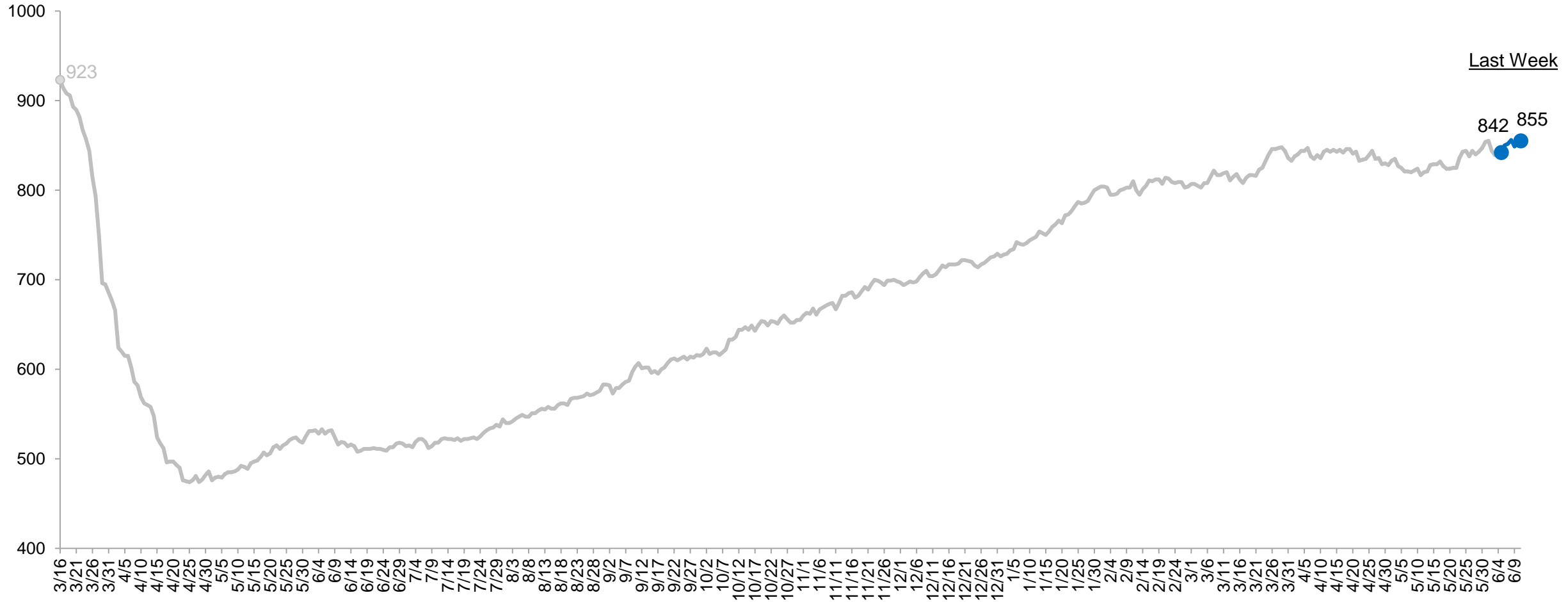

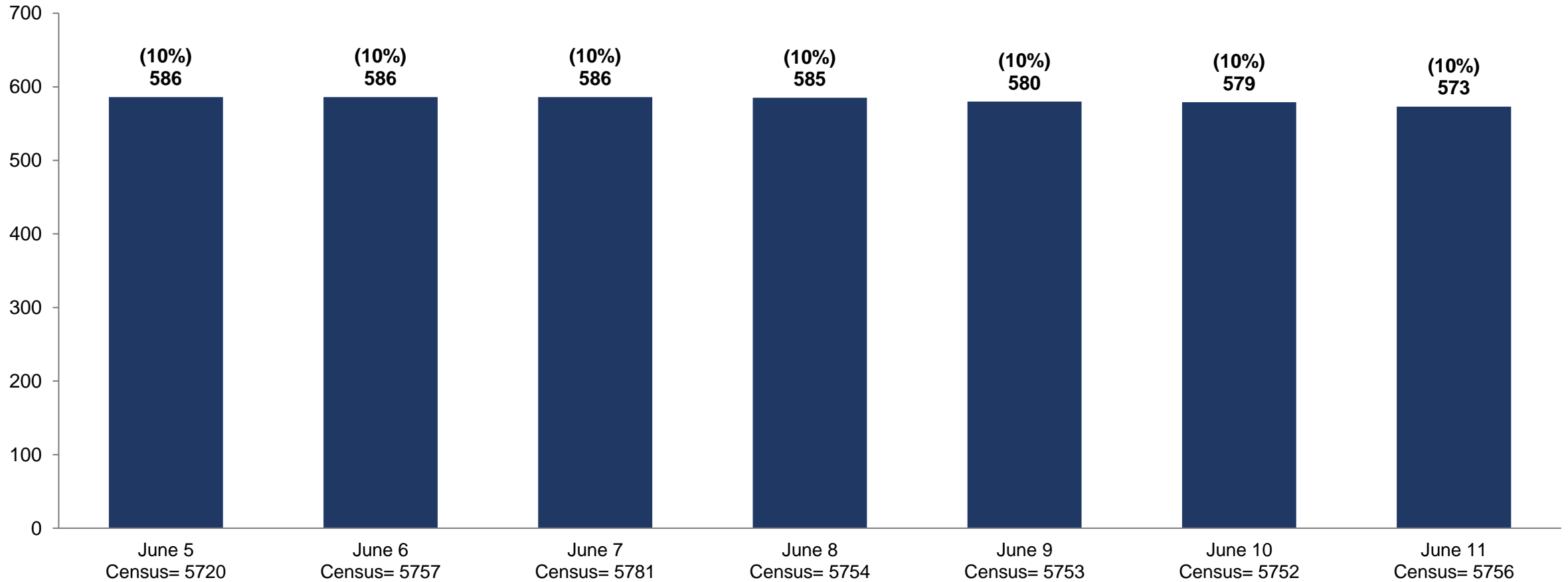

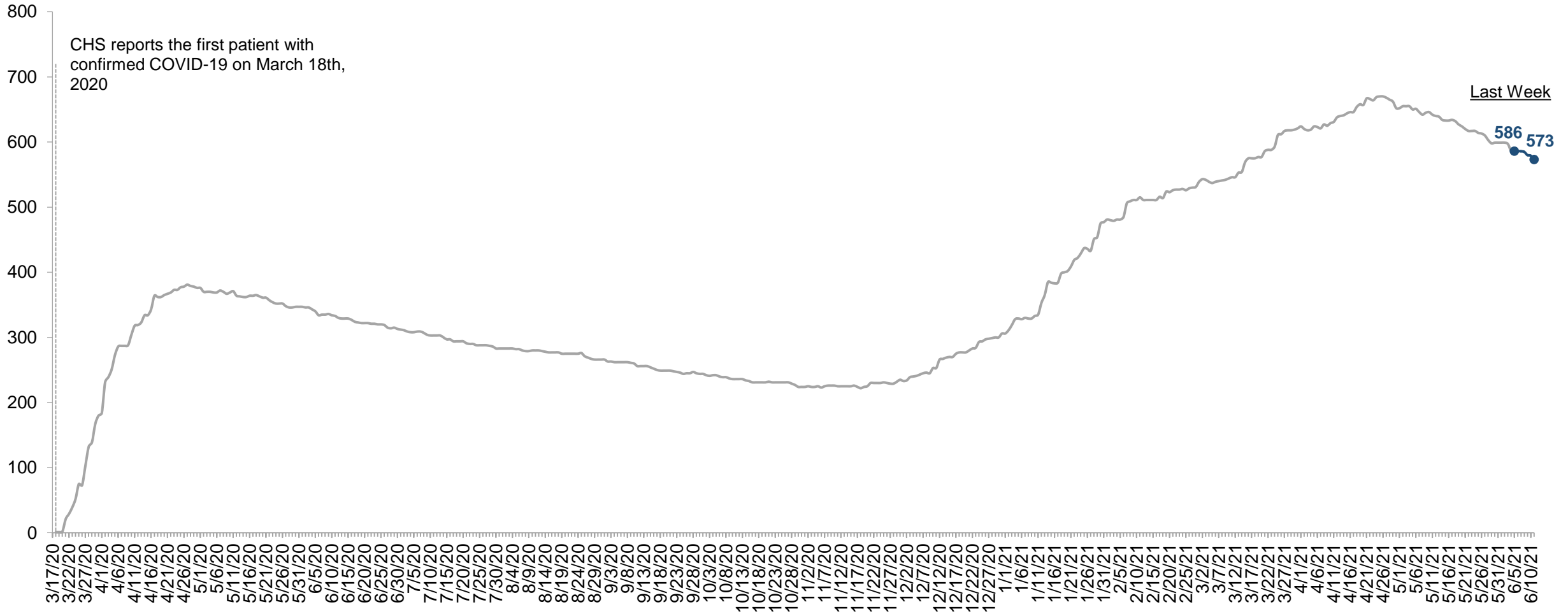
Number and Percent of Patients with Confirmed COVID-19

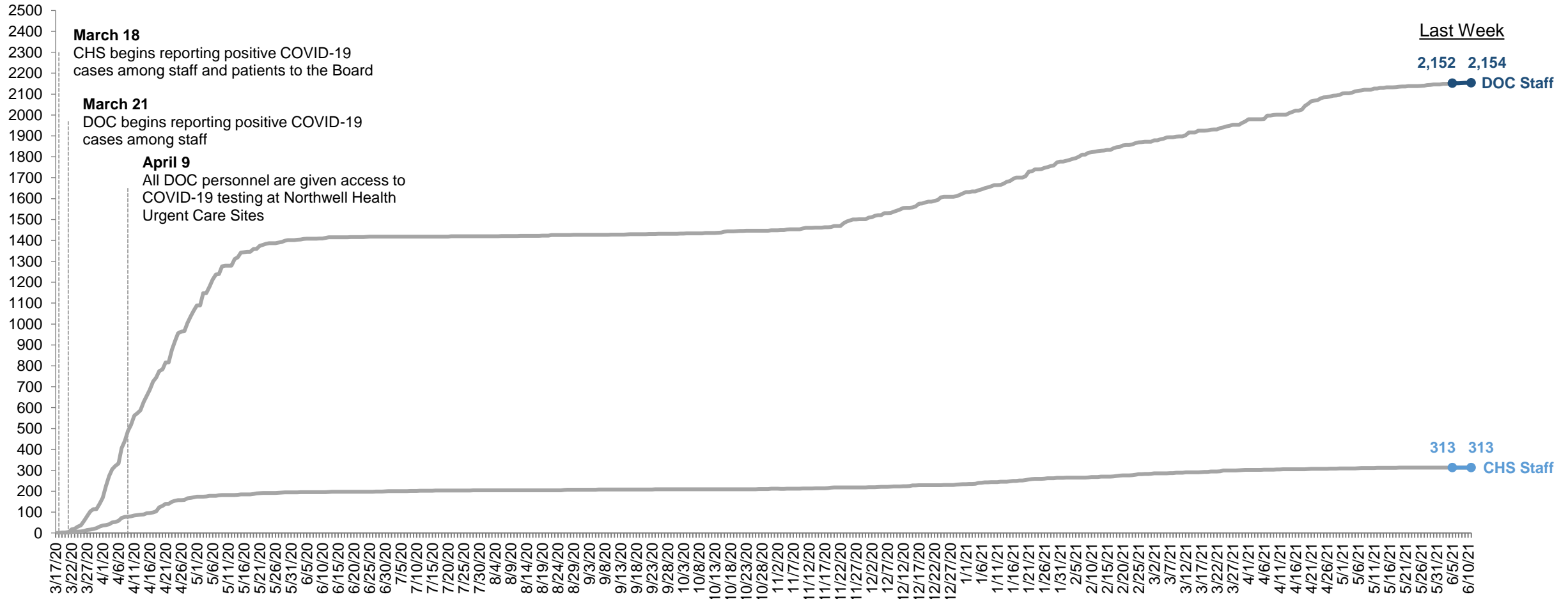
Number of Currently Incarcerated Patients with Confirmed COVID-19

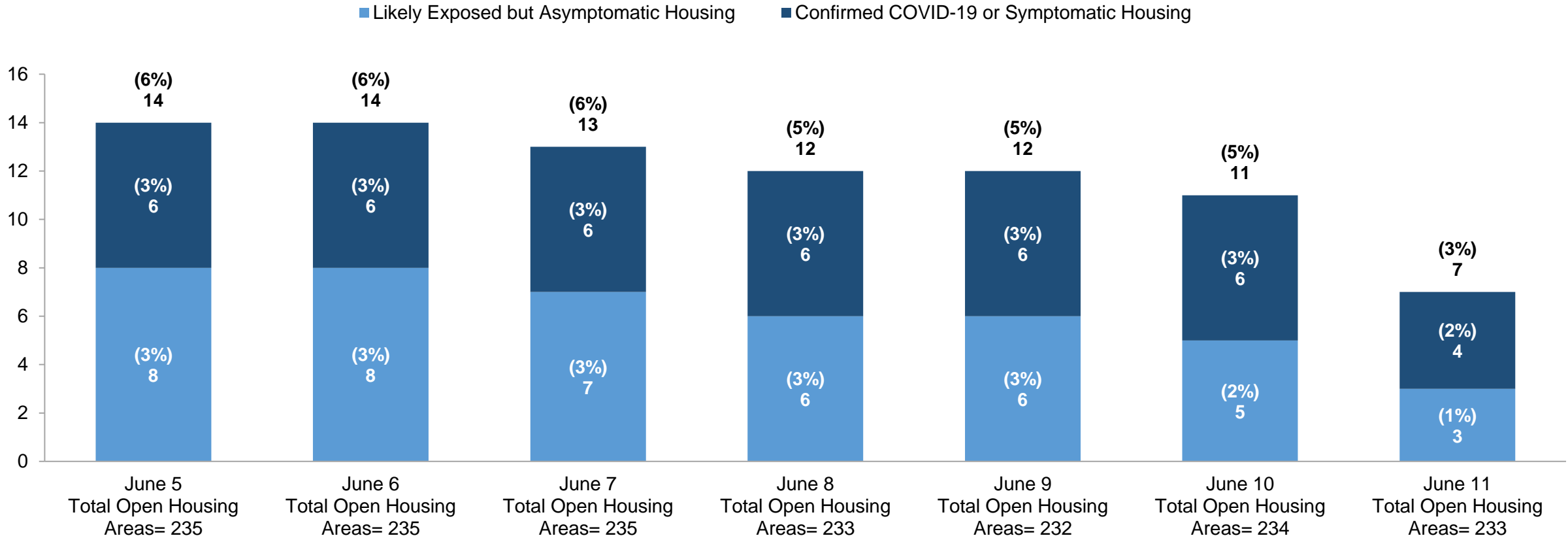

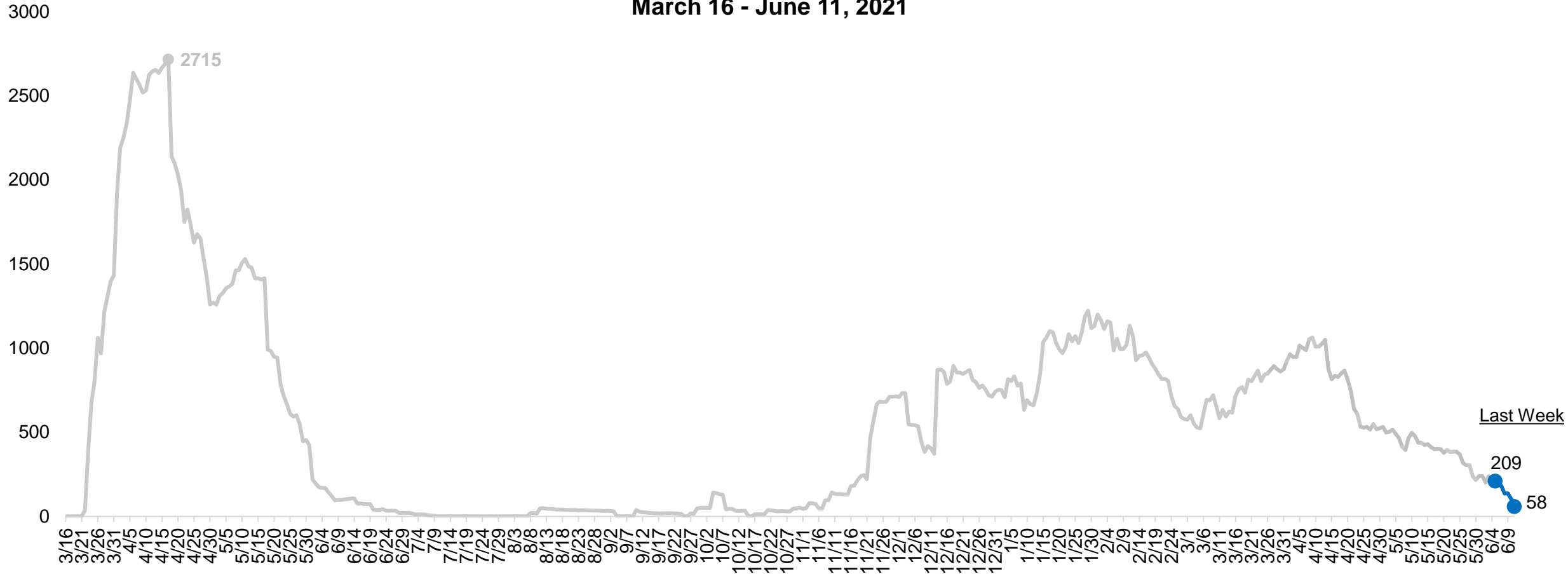

March 16 - June 11, 2021**

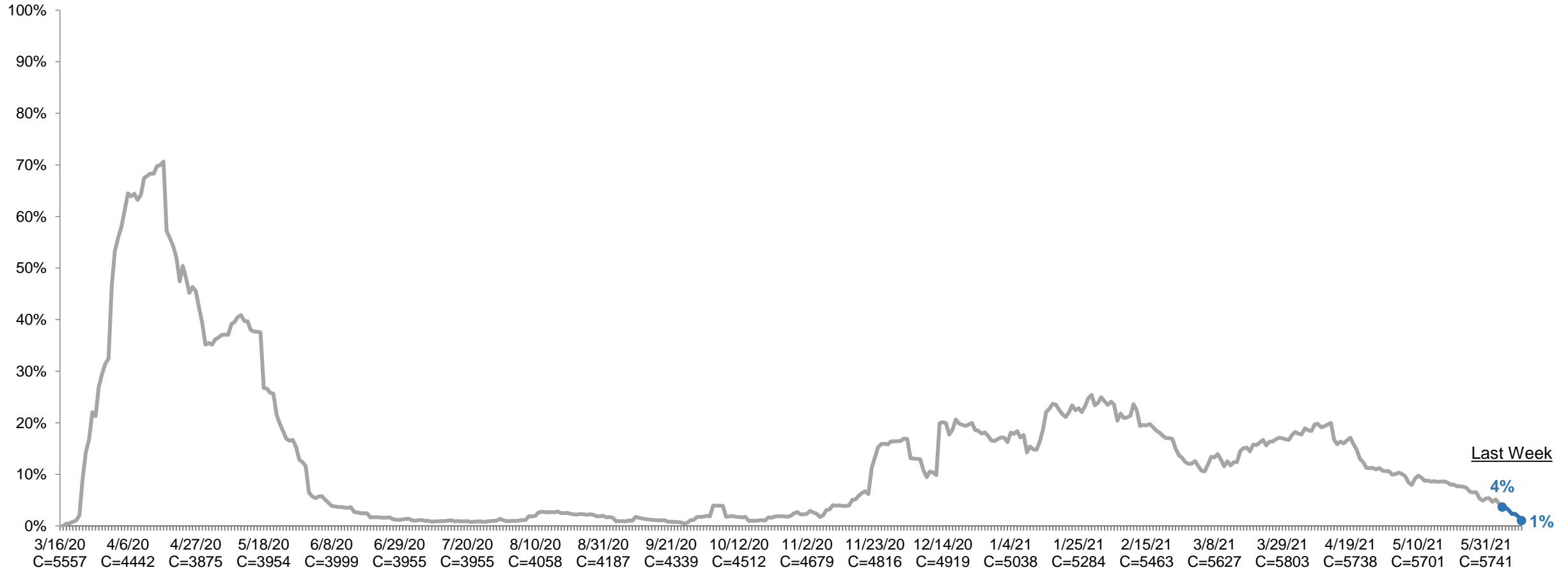

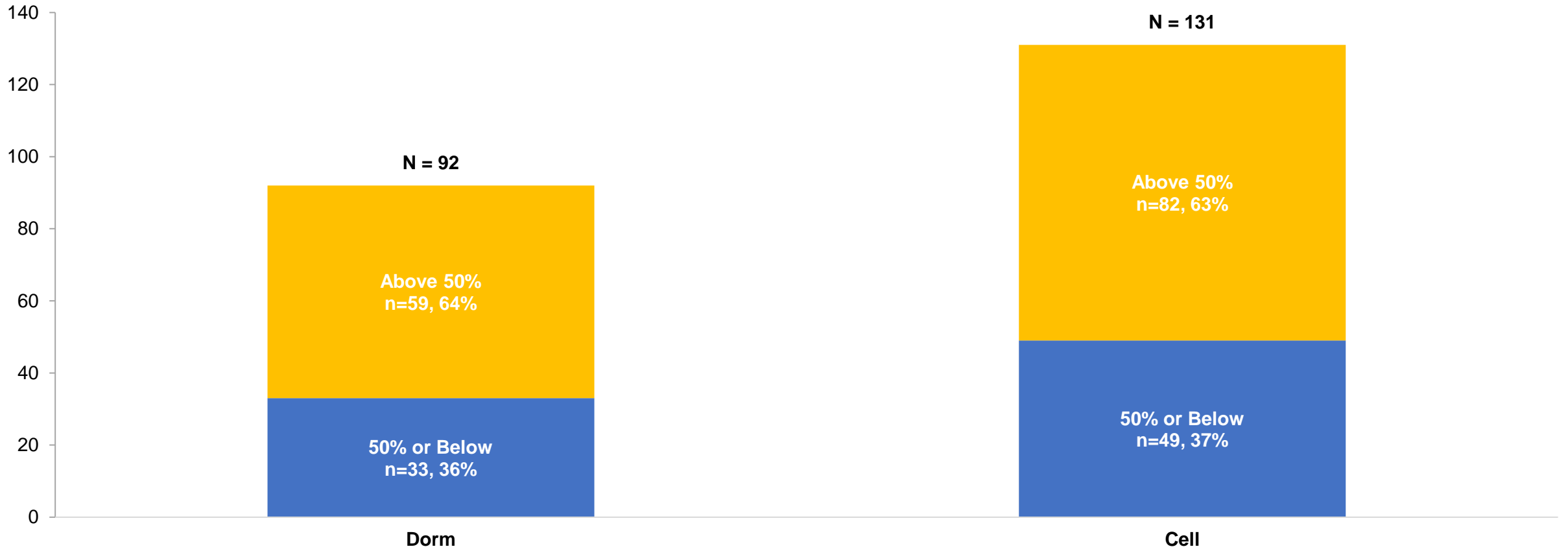

June 10, 2021



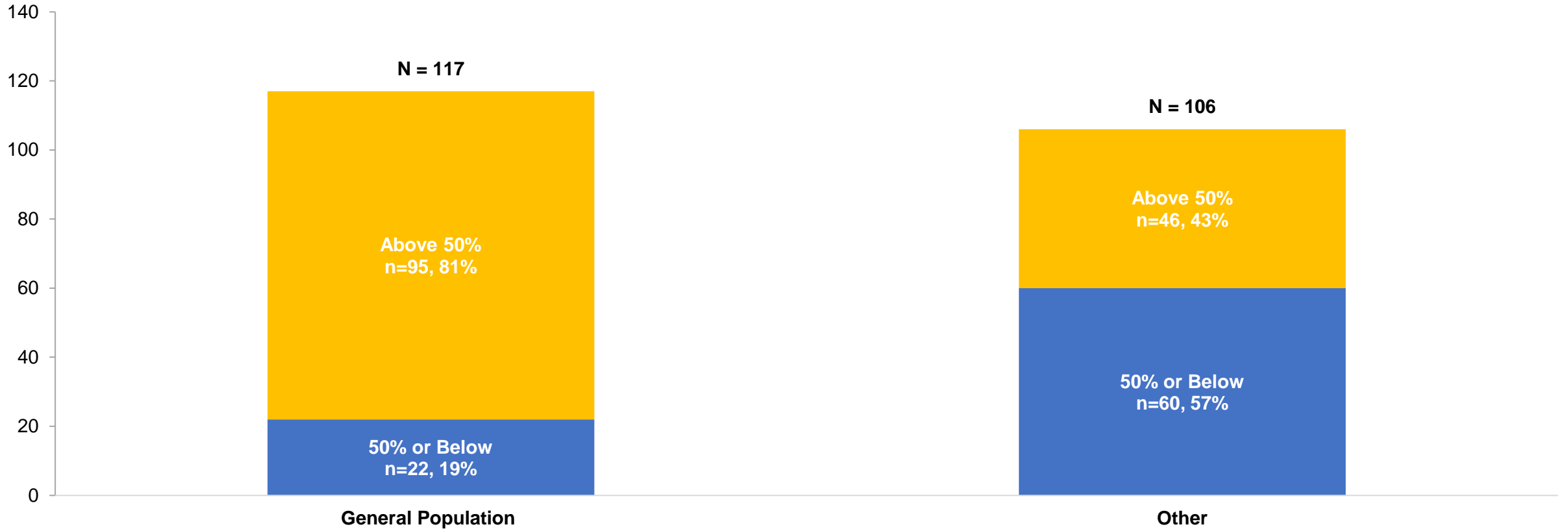

June 10, 2021



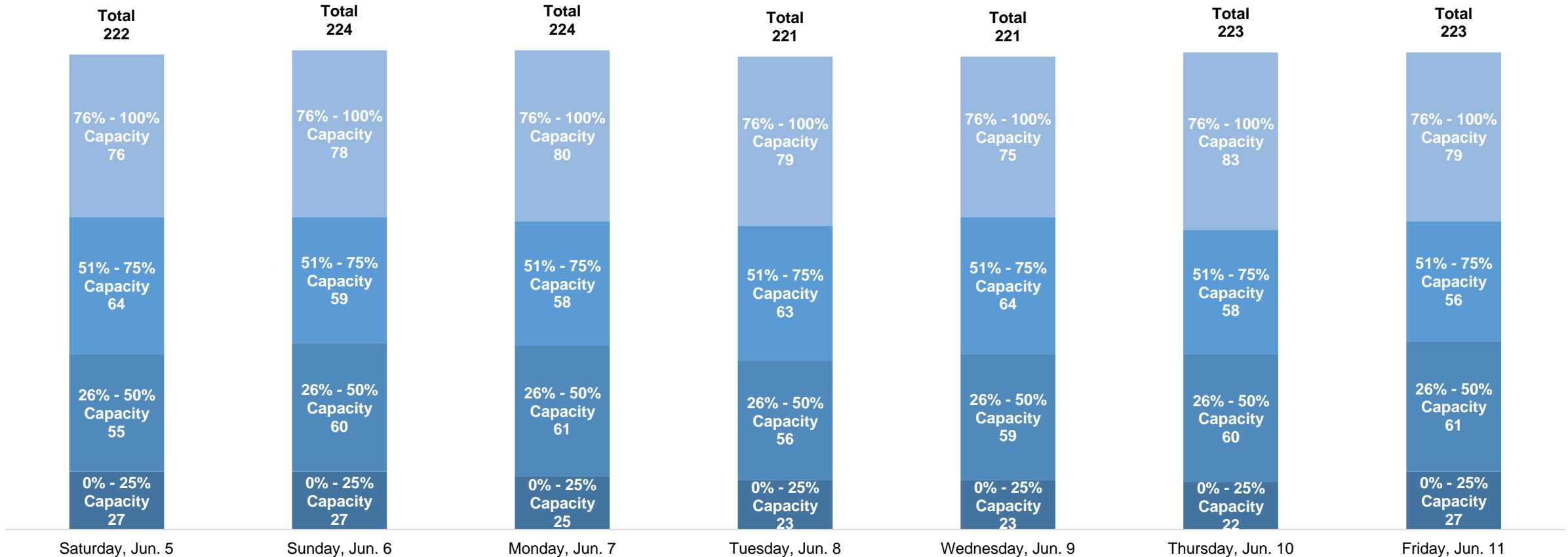
