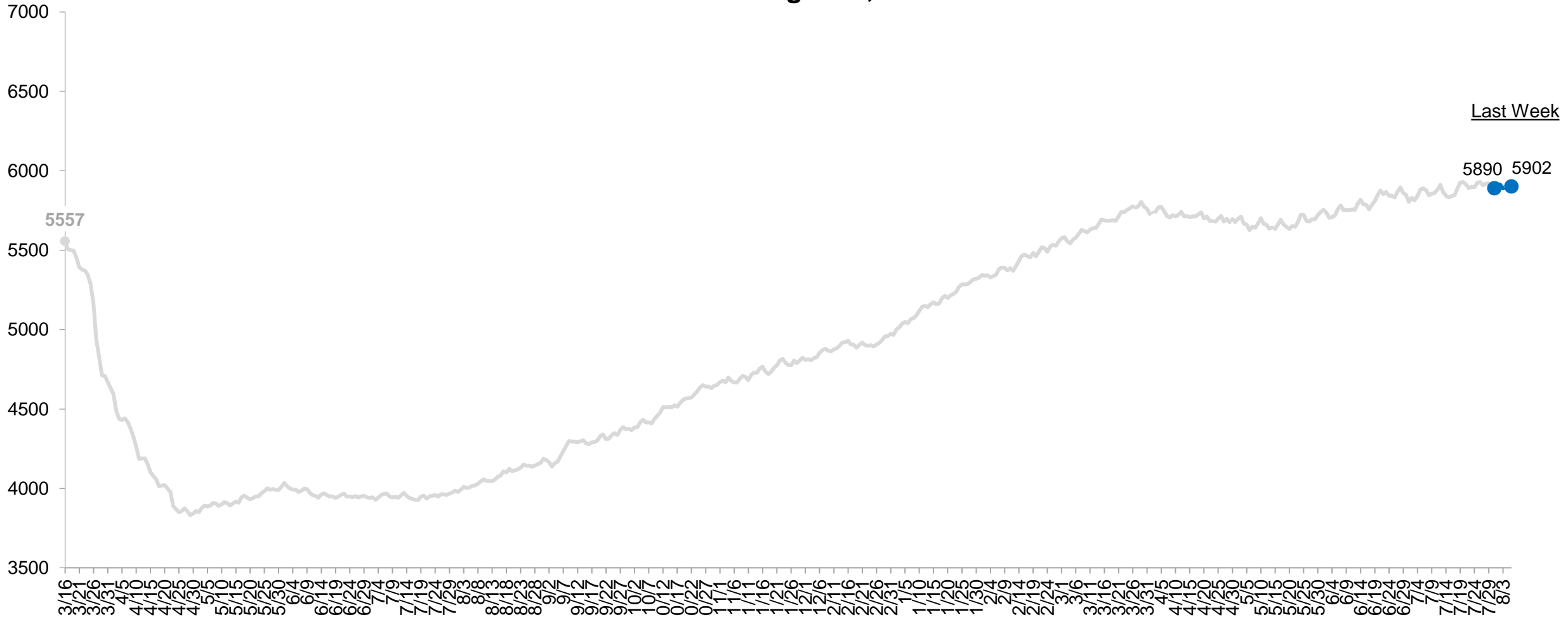

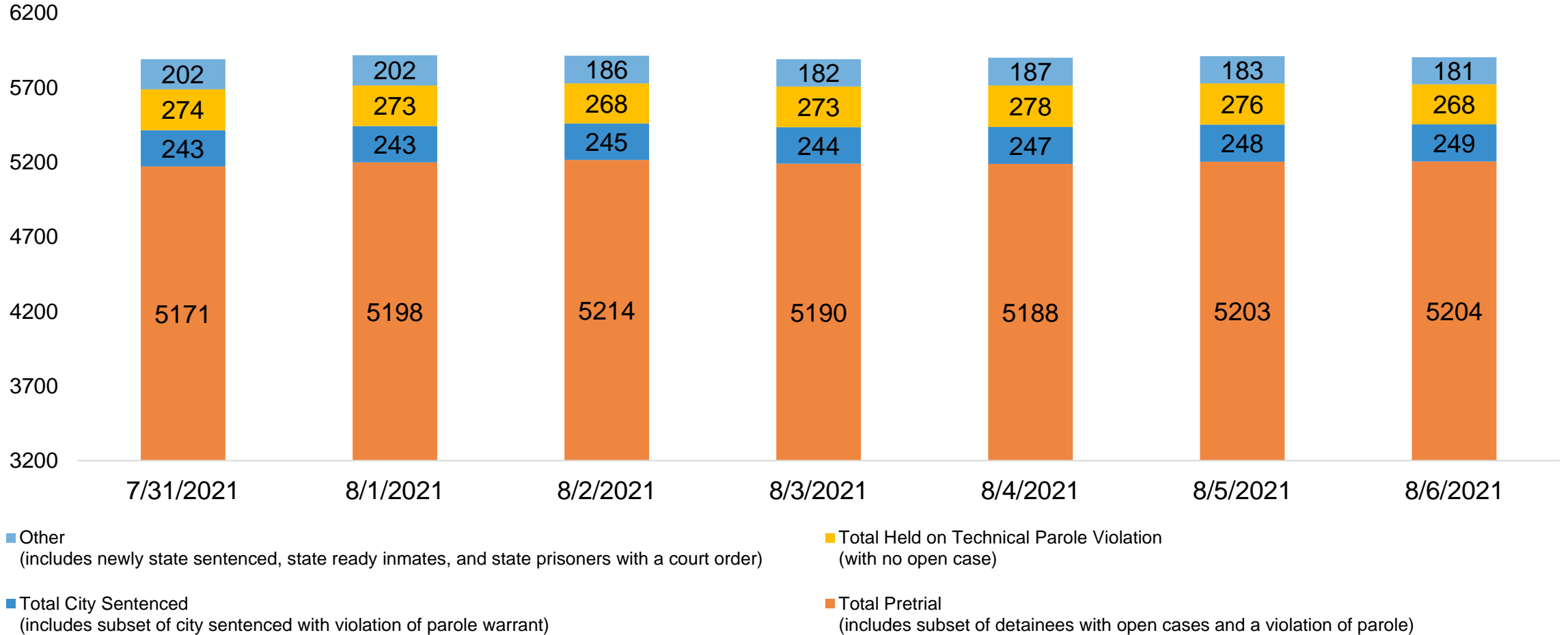
Total Population in DOC Custody March 16 – August 6, 2021

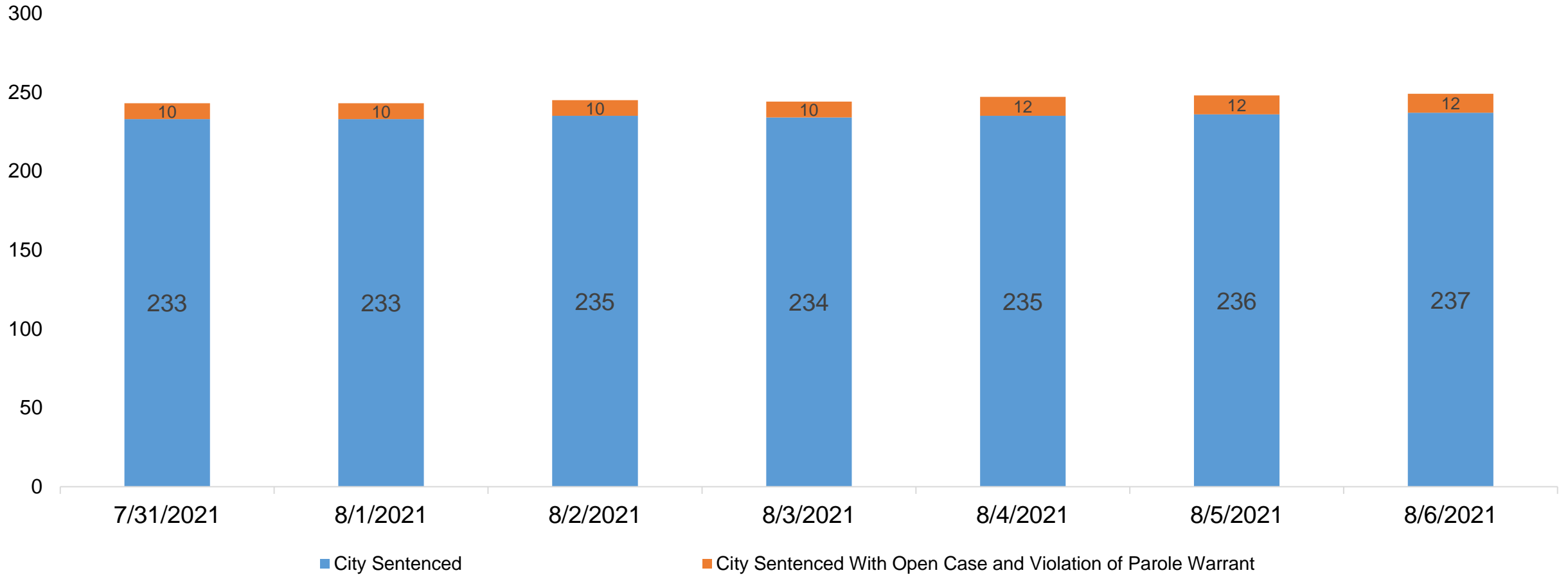

Total DOC Population by Custody Status, 7/31/2021 - 8/6/2021



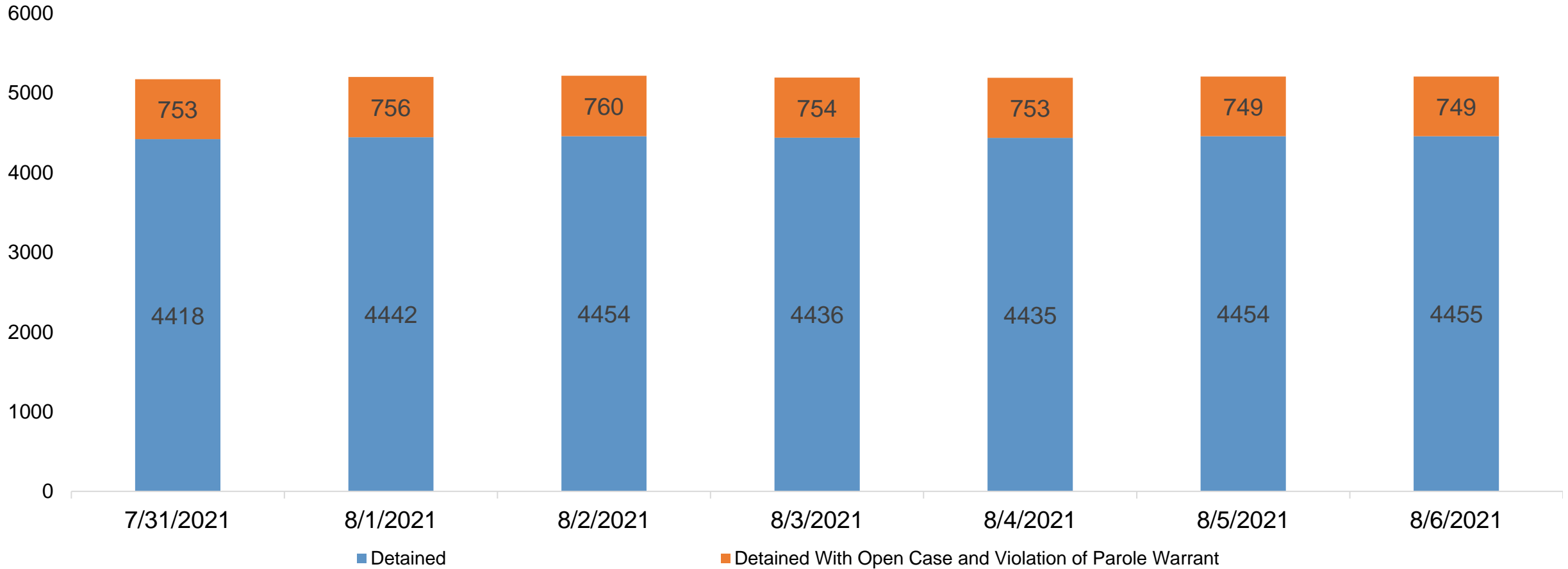

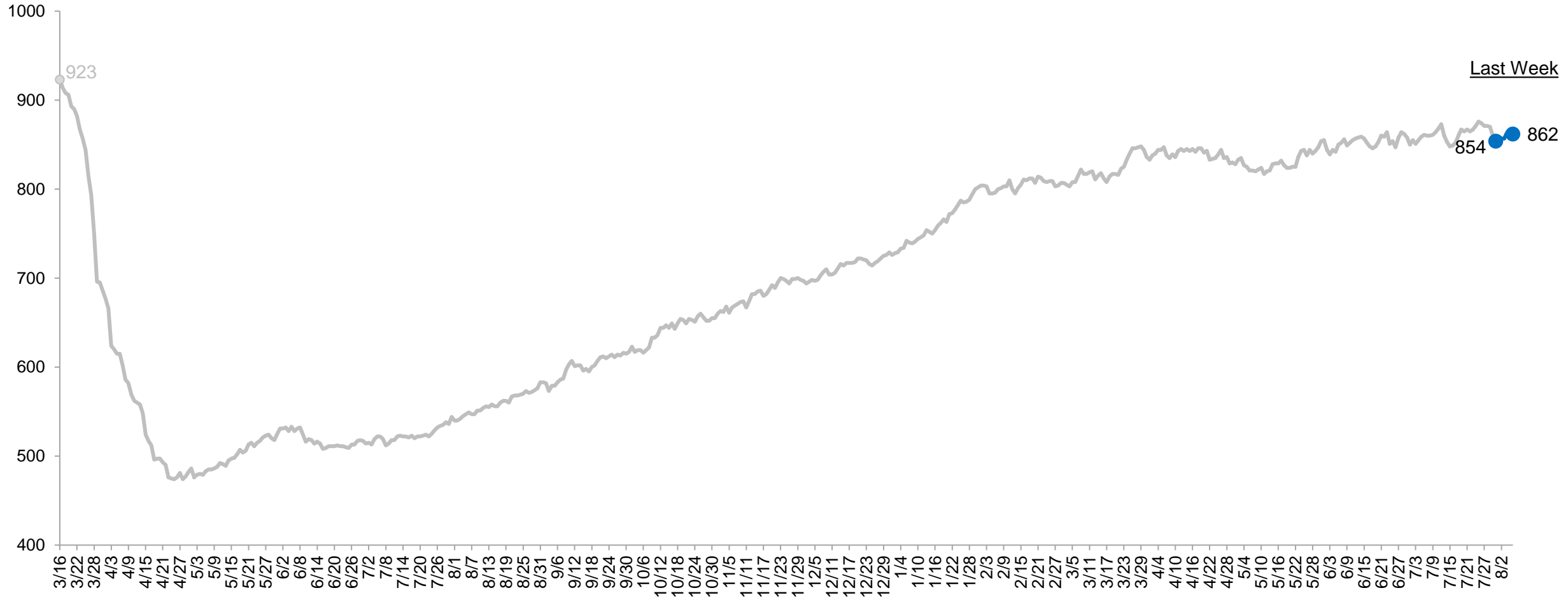

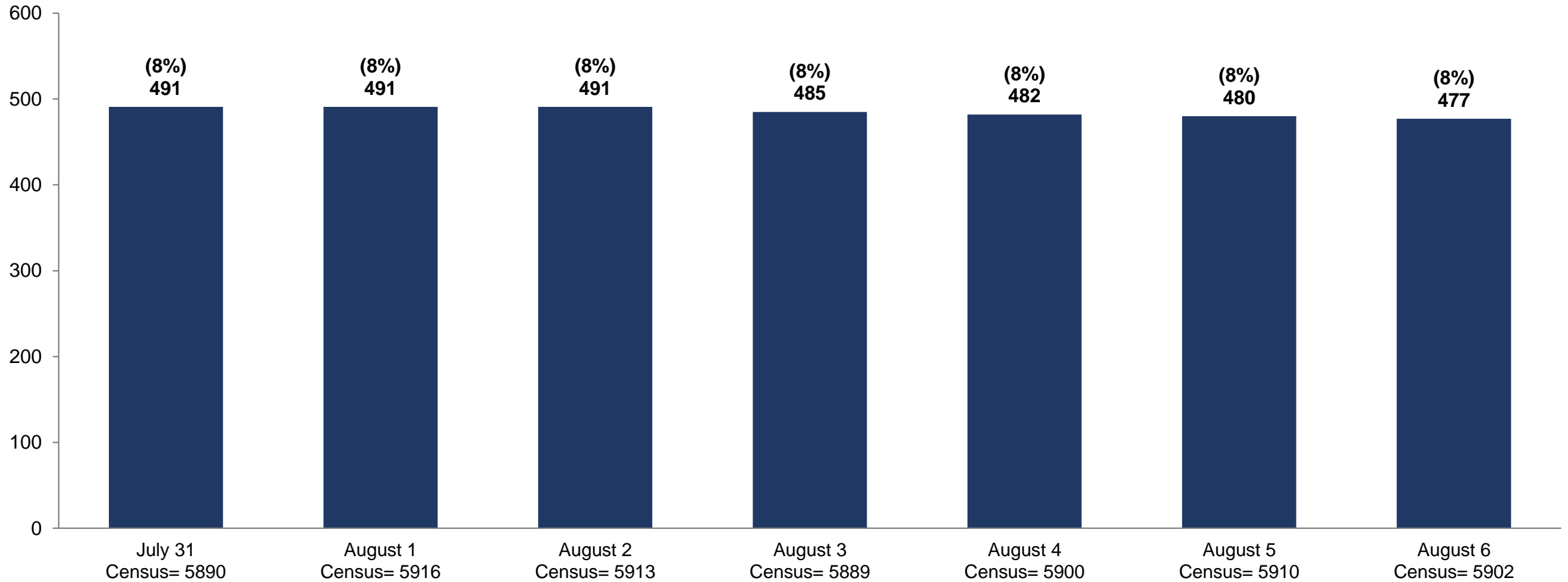

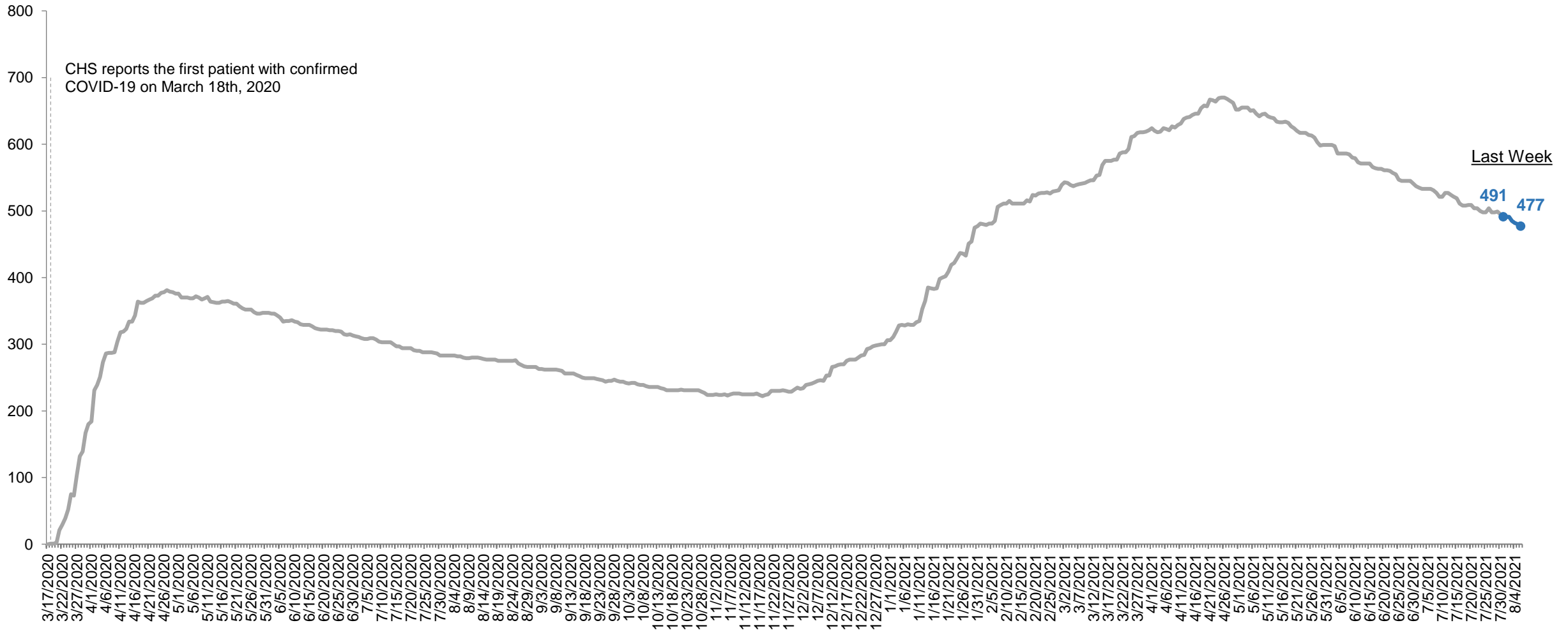
Number and Percent of Patients with Confirmed COVID-19

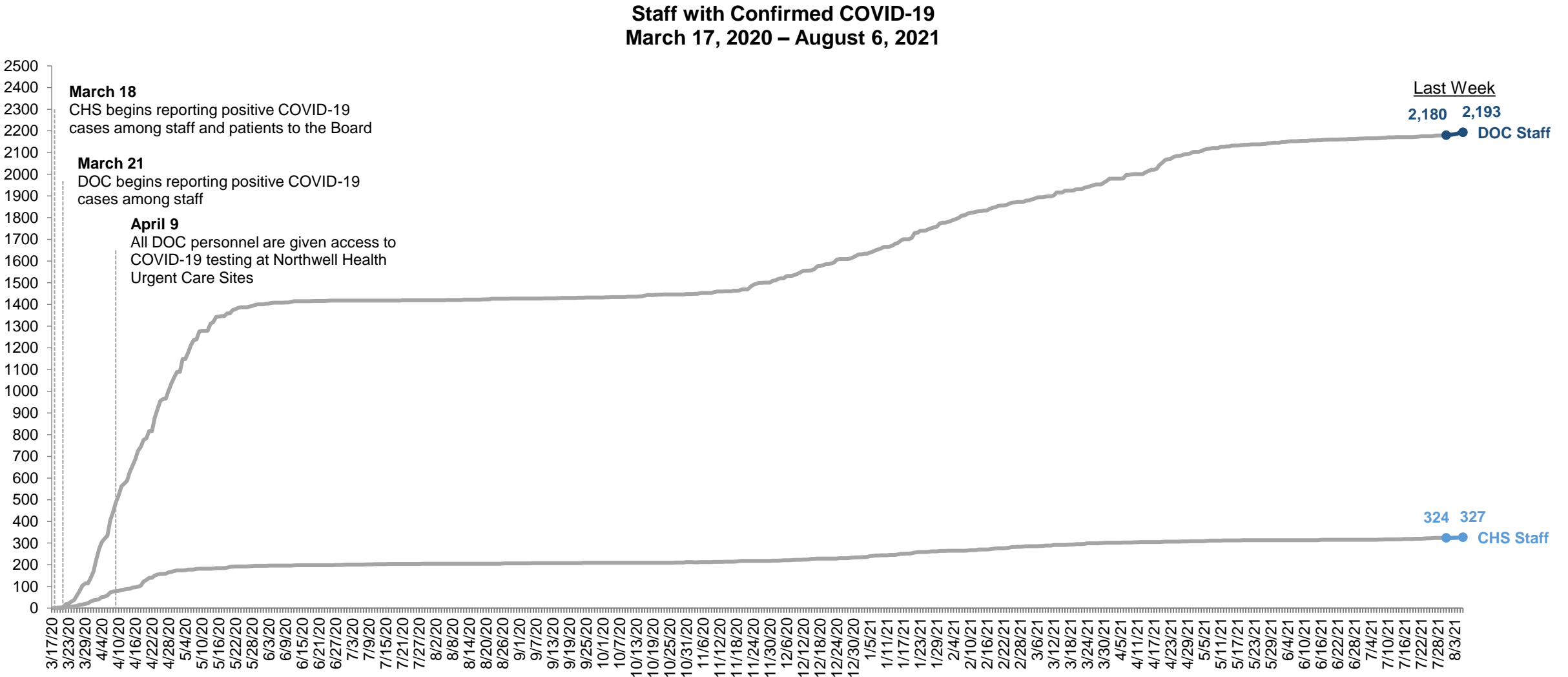

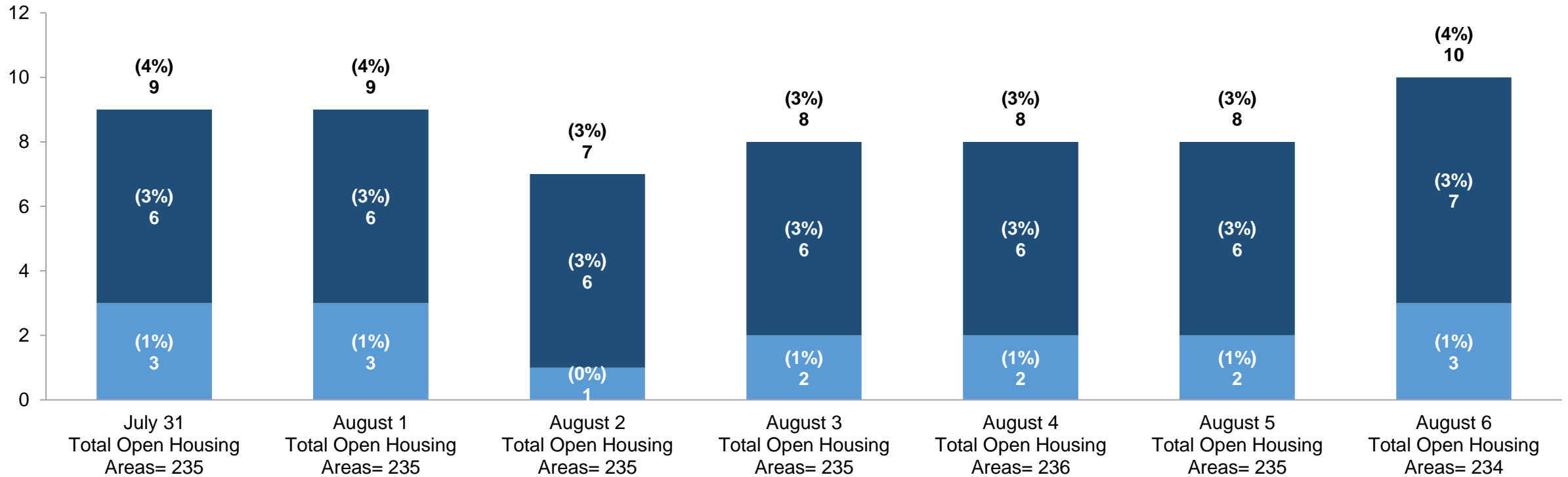

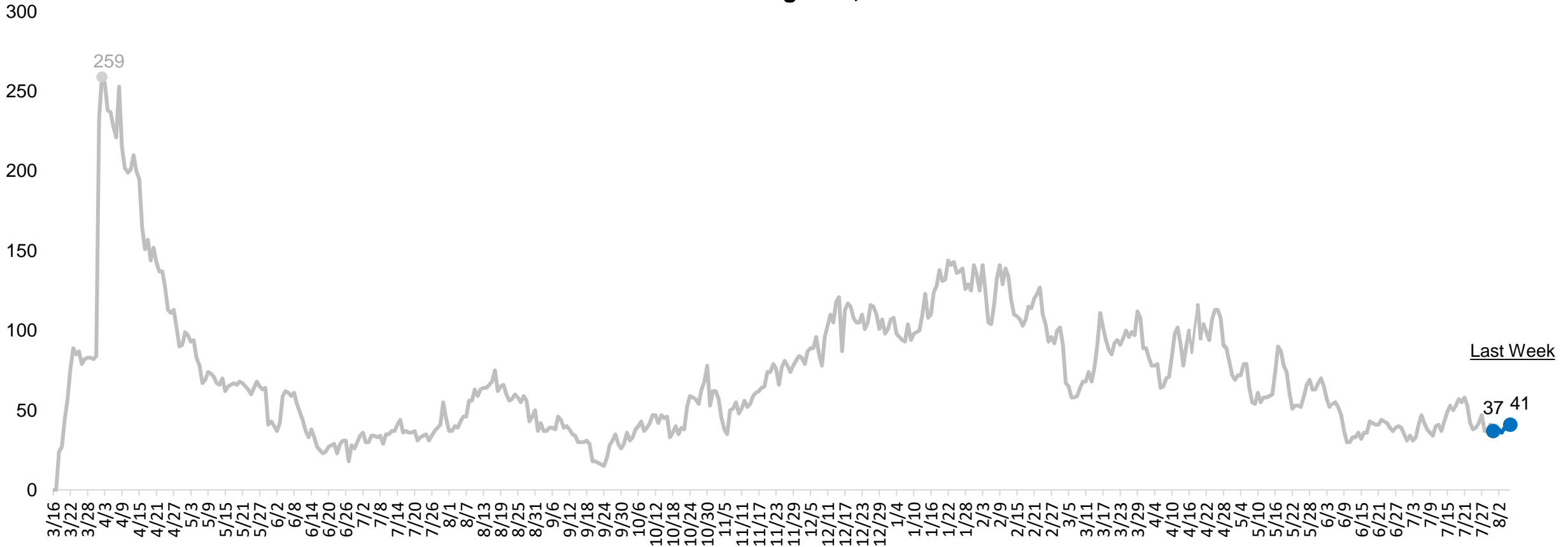

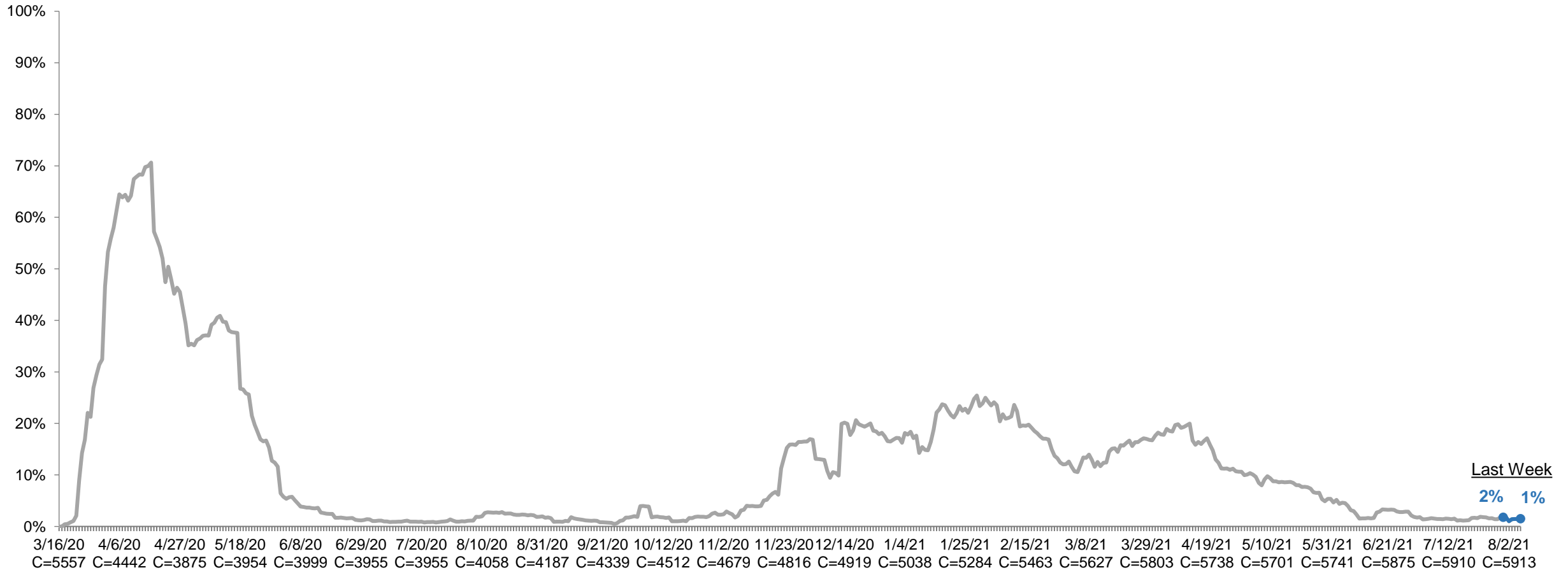

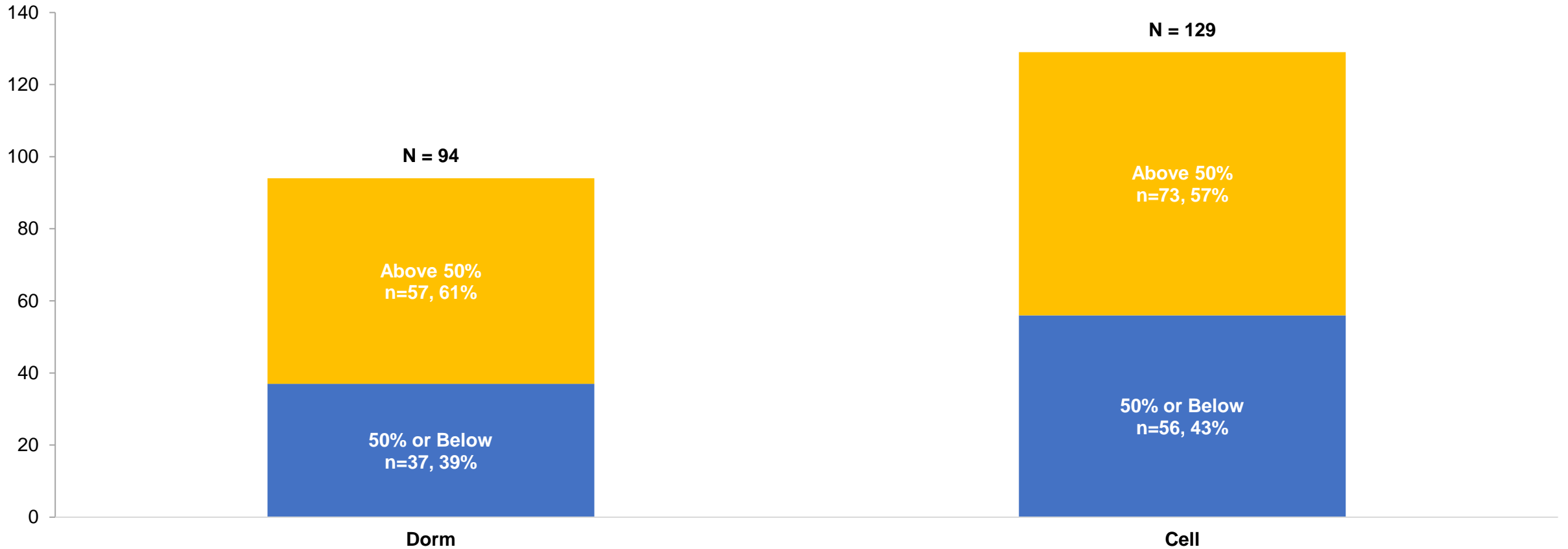

August 5, 2021



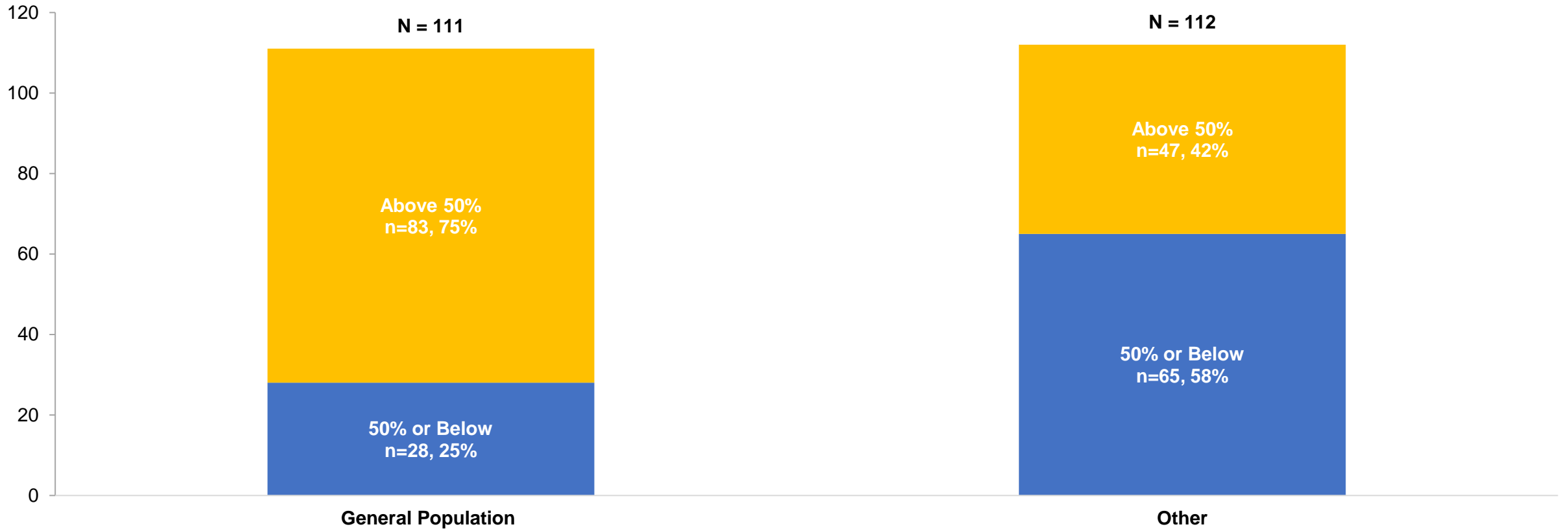

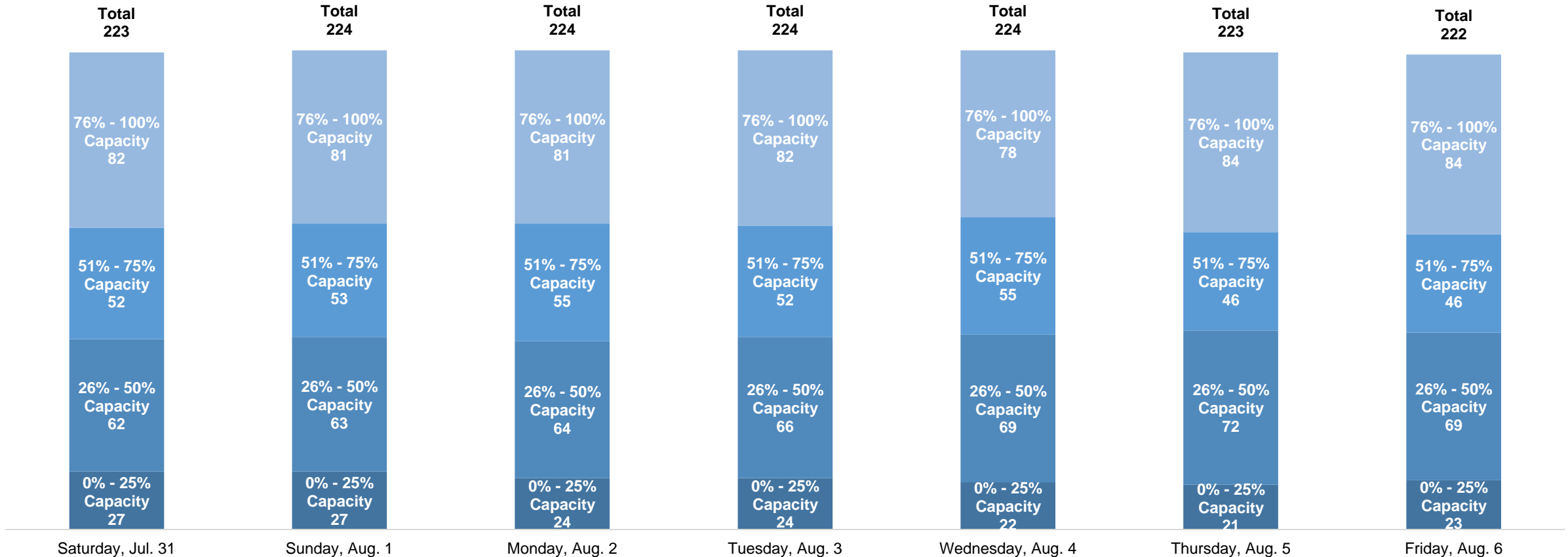
