Notice of Changes to the Board

The Board of Correction ("BOC" or "Board") recognizes and sends its deepest gratitude to former Board Member Dr. Robert – "Bobby" – Cohen for his 16 years of service as a Board Member. Dr. Cohen was appointed to the Board in April 2009 by the New York City Council and concluded his tenure on July 8, 2025.

In addition to his service on the Board, Dr. Cohen worked in and around Rikers Island for over 40 years in various capacities, driven by his passion for criminal justice and jail reform. Dr. Cohen served as Director of the Montefiore Rikers Island Health Service, Vice President for Medical Operations of the NYC Health and Hospitals Corporation, and Director of the AIDS Center at St. Vincent's Hospital. He also represented the American Public Health Association on the National Commission for Correctional Health Care for 17 years. Due to his extensive firsthand experiences in correctional healthcare, Dr. Cohen also served as a federal court appointed monitor overseeing medical care for prisoners in Florida, Ohio, New York State, Michigan, and Connecticut.

During his 16 years on the Board, Dr. Cohen was pivotal in countless projects to create safer and more humane conditions in City jails. He served as a leading voice against solitary confinement, having helped end solitary confinement for juveniles and expand punitive segregation limitations. Dr. Cohen was deeply involved in the creation of Chapter 6 of the Board's Minimum Standards that created a Risk Management Accountability System (RMAS) and restrictive housing rules pursuant to Local Law 42 of 2024, to replace punitive segregation in its entirety.

Dr. Cohen was also crucial in rulemaking to protect people in custody's access to physical contact during visits with loved ones and to discuss people in custody with a person-forward vocabulary. He was central in incorporating national PREA standards into the Board's Minimum Standards. Additionally, Dr. Cohen utilized his correctional healthcare background in many different facets. He helped reform reporting requirements and responses to in-custody injuries, assisted in clinical reviews of deaths in custody, and provided helpful guidance regarding clinical observation of individuals with serious mental illnesses.

Dr. Cohen has been a leading expert on correctional healthcare and an unwavering advocate for equity and safety inside the City's correctional facilities for staff, people in custody, and their loved ones. Dr. Cohen's spirited commitment to the work will be deeply missed.

Current and former colleagues shared personal statements on Dr. Cohen's impact on criminal justice and the humanization of the City's jail system:

Dr. Cohen's example serves as a powerful reminder that meaningful oversight saves lives and demands a commitment to dignity, empathy, and unwavering attention to the humanity of those in custody. His legacy is not just in the policies he shaped, but in the lives he touched through his unseen acts of care and advocacy. Gracias, Bobby."

It's been a great privilege to sit alongside you these past few months and, while I feel deeply saddened that our shared tenure is so brief, I am so grateful for all you've done and wish you the best!"

"I thank Dr. Cohen for his nearly two decades of service as a member of the Board of Correction," said Council Speaker **Adrienne Adams.** "Throughout his time on the Board, Dr. Cohen has consistently demonstrated what it looks like to serve with fairness, humanity, and courage. "It has been an honor to work with and learn from Dr. Robert Cohen. "Since late 2015, when New York City began transitioning its correctional health service from a private contractor to NYC Health + Hospitals, Dr. Cohen and I have worked under the shared belief that providing high-quality health care to the people in custody who need it, is the top priority of the healthcare service. Correctional Health Services, and each and all of our patients, salute and thank Dr. Cohen for his unwavering advocacy for this mission."

"We wish him all the best in his future endeavors," said DOC Commissioner Lynelle Maginley-Liddie.

"Bobby's tenure and leadership on the Board were marked by unmatched perseverance toward reducing harm and improving conditions for people detained and working inside the city's jails," said former Board Executive Director **Martha King.** "His efforts ensured the Board worked harder and smarter to investigate all matters addressed to the Board. Bobby was indefatigable on limiting the use of solitary and restraints, on meeting requirements for, and increasing, access to healthcare and recreation, on investigating deaths and implementing the changes that those investigations showed were needed, and more. He used evidence, logic, common sense, and conscience to challenge dangerous and irrational policies and conditions. I hope his approach and impact at the Board will continue to serve as a model to all of us seeking safety, justice, and decarceration."
