#### b. Overview of comingled programming:

- Internal: DOC-led programming designed to provide group facilitation, individualized counseling and structured leisure time activities promoting critical thinking and positive behavioral change.
- II. <u>External:</u> DOC partners with seven nonprofit organizations to support incarcerated individuals pre and post release. During incarceration, DOC partners run classes on topics such as anger management, parenting, relapse prevention, and job readiness. They also offer vocational training to expand participant's employment opportunities, including industry-recognized certificates in the construction and food industries. After release, they provide
