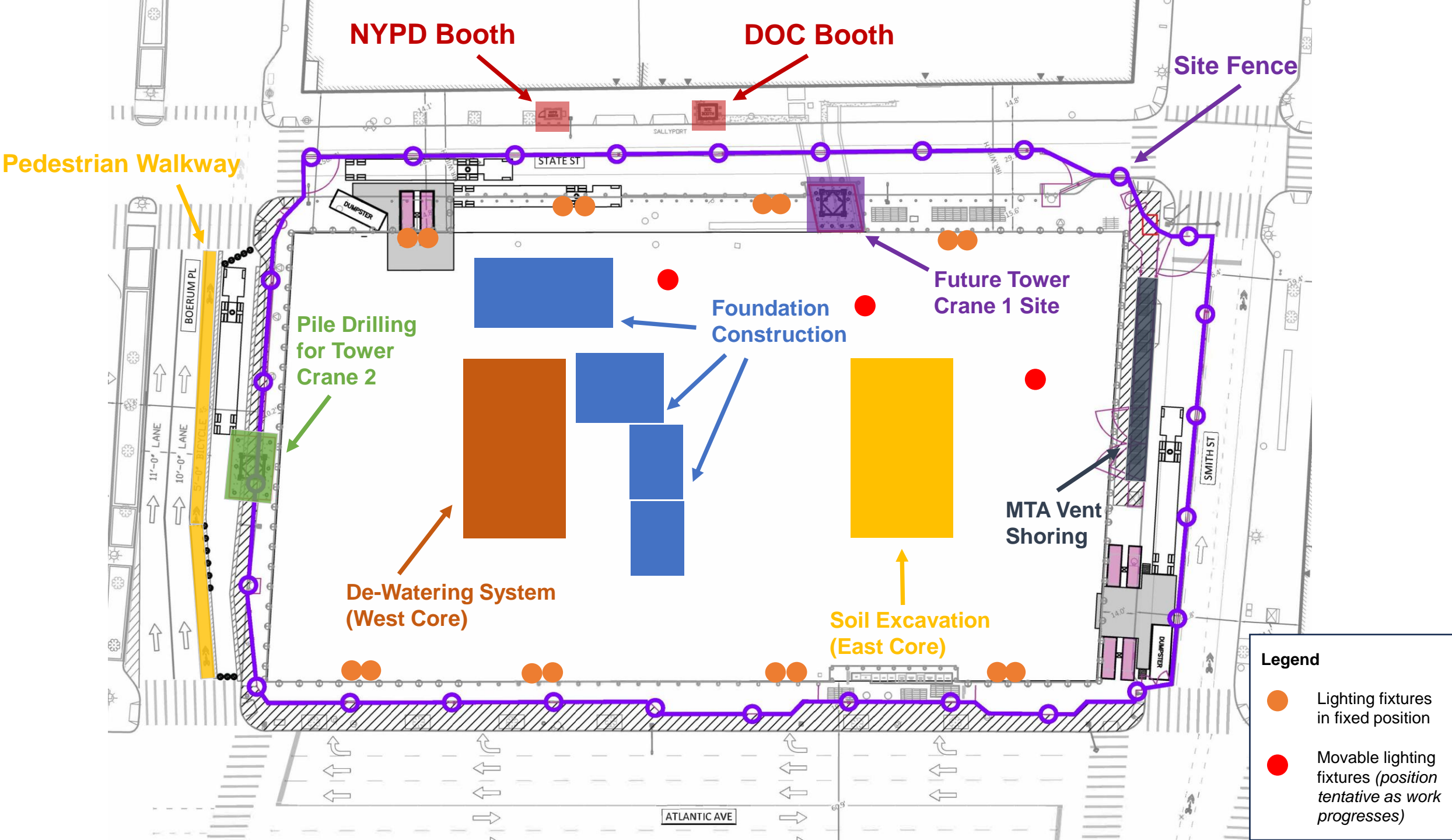

2/3/25 – 2/8/25	M-F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Foundation construction</b> (Noise / Vibrations / Excavating soil and installation of structural, electrical, and mechanical components for the crane and building foundations / Work will take place inside the perimeter fencing with no public interaction)
2/3/25 – 2/8/25	M-F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Pile drilling (Boerum Pl.)</b> (Noise / Vibrations / Drilling within site for foundation and crane structural support piles / Minimal dust expected with mitigation practices to be employed)
2/3/25 – 2/8/25	M-F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Site dewatering</b> (Noise / Site pumps removing underground water from construction site / Pumps will run 24/7)
2/3/25 – 2/8/25	M-F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Debris and waste trucking</b> (Noise / Removal of concrete, soil, and buried building remnants from the excavated site / Flaggers will direct pedestrian and vehicular traffic as necessary)
2/3/25 – end of Feb 2025	M-Sun / 24-hour work cycle	(275 Atlantic Avenue)	<b>Supportive work for Smith St. MTA tunnel shaft</b> (Noise / Work will take place inside the perimeter fencing with no public interaction / Work may take place overnight for subway system safety and operation) <b>Note: Work on Sat, 2/1/25 and 2/8/25, will take place from 7:00 AM to 7:00 PM</b>
