5/12/25 – 5/17/25	M – F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Foundation construction</b> (Noise / Vibrations / Excavating soil and installation of structural, electrical, and mechanical components for the crane and pouring concrete for building foundations / Backfill site floor in prep for slab-on-grade concrete pour / Work will take place inside the perimeter fencing)
5/16/25 – 5/18/25	Fri - Sun / 9:00 pm (Friday) – 11:59 pm (Sunday)	(275 Atlantic Avenue)	<b>Tower crane #1 delivery and installation</b> (Noise / Vibrations / Delivery of tower crane and installation on State St. by use of a Mobile Hydraulic crane. / State St. will be closed to vehicular traffic / Pedestrian access to State St. will remain. Flaggers will direct truck and crane operations and pedestrians / Work will be conducted throughout the weekend.)
5/12/25 – 5/17/25	M – F / 7:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Sidewalk shed construction</b> (Noise / Construction of a sidewalk shed on Atlantic Ave. from Smith St. To Boerum Pl. / Noise, consistent traffic, and vehicular and pedestrian access restrictions. / Pedestrian walkway will be open from 7 am - 10 am with flaggers directing pedestrians as necessary. From 10 am - 6 pm, pedestrians will be directed across the perimeter of the site on Atlantic Ave. to accommodate the TPC work zone for utility tie-in work.)
5/12/25 – 5/17/25	M – F / 10:00 am – 6:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Atlantic Ave. utility tie-ins</b> (Noise / Vibrations / Saw-cutting the roadway and jackhammering to excavate road materials to expose existing utility connections and install new utility tie-ins / Flaggers will direct pedestrian traffic as necessary)
5/12/25 – 5/16/25	M – F / 7:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Debris and waste trucking</b> (Noise / Removal of soil from the excavated site / Flaggers will direct pedestrian traffic as necessary)

(NO PARKING SIGNS: WILL BE DISTRIBUTED/POSTED 72 HOURS PRIOR TO THE TEMPORARY ELIMINATION OF STREET PARKING. PLEASE OBSERVE POSTED PARKING REGULATIONS IN CONSTRUCTION AREAS.
