# Communications & Technology Committee Meeting Minutes January 13th, 2025

## Leslie Lopez Hernandez, Committee Chairperson

#### Old Business: Website and Domain Discussion

- Committee Chair Leslie Lopez Hernandez initiates the meeting and mentions the absence of members.
- Community Coordinator Steven Palmers recalls that Sonyi, the former chair, bought the domain but faced issues with OTI's support.

#### **Exploring Other Community Boards' Practices**

- Community Coordinator Steven Palmers suggests that other boards might use interns or consultants for website design and maintenance.

## Link NYC Displays and Social Media Management

- Committee Chair Leslie Lopez Hernandez mentions the need for social media login credentials and the possibility of recruiting members to help manage social media accounts.
