ECONOMIC DEVELOPMENT COMMITTEE NOVEMBER 6, 2019

The meeting began at 7:30 PM with the Pledge of Allegiance. Mr. Accomando welcomed all in attendance and read the conduct document. Mr.Accomando addressed the attendees and said when your establishment is called state your name, position in the establishment and give a synopsis of the establishment. Mr. Accomando addressed Applebees that was tabled from October's meeting due to several incidents. At the October meeting, the representative in attendance had no knowledge of said incident. Three representatives from Applebee's attended the November the meeting: district manager, new manager and V.P. Ken Feldman. The chair expressed his concerns about the intoxication incidents. The district manager noted they have a three drink maximum policy ineffect; that must mean they are already coming insome what intoxicated. The committee suggested more security be added so that these individuals are not permitted on the premises and that the greeter at the door be better trainedwhenseatingcustomers. It was suggested that they also take ATAPS training as well. The new manager will have meetings with her staff and was going to add more security. The chair also asked the manager to forward to Mr. Caruso the new hours of the added security. The committee was satisfied with the responses from the representatives, and then addressed the remaining renewals. At this time there was a motion to except made by Mr. Popovic and second by Mrs. Acampora. The vote was unanimously approved.
