## Municipal Services Wednesday, November 13 at 7:30 P.M.

The Committee commenced at 7:30 P.M. with the Pledge of Allegiance.

Street Activity Permits were the first order of business. The St. Teresa Feast Street Festival, after discussion, was tabled to December by R. Bieder and seconded by A. Chirico to table and approved unanimously with one recusal. This was due to the need to discuss the outstanding matters with the most recent festival.

Spring Arts Crafts Fair ID #516089 Fall Arts Crafts Fair File #519090 both were passed unanimously and was first proposed by a motion made by R. Bieder and seconded by Raquel Baez. D. Noble recused herself.

Fall Arts Crafts Fair, Sidewalk Sale, September 12, 2020 – September 13, 2020, 11:00 AM – 7:00 PM, including setup and breakdown: 10:00 AM – 8:00 PM, City Island Avenue from Bay Street to Schofield Street, partial sidewalk closure only, Paul Klein."

The MTA NYCT and NYCDOT on Bronx Bus Redesign. Implementation is expected by Summer/Fall 2020 and comments and concerns are still being accepted by MTA. Many members suggest ideas and concerns on individual bus lines throughout the neighborhoods.

There was a motion approved to request a NYC DOT study on Right Turn on Red Light Signage when entering Home Depot on Brush Avenue. The motion was made by R. Bieder and seconded by Raquel Baez. Majority approved with recusal from Denise Noble.

"**Resolved**...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that the request for a study to be conducted by the NYC Department of Transportation for a right turn signal on Brush Avenue into the parking lot of Home Depot be forwarded to the full Board for approval."

The meeting closed at roughly 9:30 P.M. by a vote of adjournment by. R. Baez and A. Chirico and unanimously approved.
