

The meeting opened with the Pledge of Allegiance. Mr. Accomando thanked everyone including the business merchants for attending tonight's meeting. There was a brief discussion on renewal liquor licenses. There were no incidents reported by Officer Souhrada of the 45th Precinct. Mr. Accomando discussed with TAC Foord Service, one of the renewal applicants about attending ATAP training and to make sure that minors are not served; the owner noted that he walks around the outside to check on tables. A motion was made to accept the Resolution for Renewal Licenses by Mr. Sullivan, seconded by Mr. Popovic and unanimously approved by all committee members in attendance.

Mr. Maximo Reyes, SOBRO Business Development Specialist spoke on many services being offered such as OJT program, eligibility and application process, contact and award execution as well as training and reimbursement. He also discussed PTAC (Procurement Technical Assistant Center) which provides a wide range of assistance to business through one-on-one counseling sessions, classes, and seminars.

Council Member Mark Gjonaj spoke extensively on issues hurting small business specifically current laws which are causing small businesses severe hardships. He spoke about a pilot project that is temporarily removing parking spaces away from the front of small businesses in Queens. He is presenting a bill for micro businesses 10 or less employees. Small business is considered to be over 100 employees. Council Member Gjonaj took questions from Board members and guests.

A flyer for the Honeywell Captuvo SL42 Mobile Barcode application was handed out. This device will allow bars to share information from ID scans which in turn may be useful to weed out troublemakers. Additional discussions took place on vacancies in City Island.

Council Member Gjonaj was thanked for attending the meeting.
