## Economic Development Minutes rev. June 5, 2018

There was no quorum of membership at the time of voting, so the Committee could not vote on the renewal licenses. The Committee discussed the licenses and all were in agreement as to each of the renewals. There were no objections.

Mr. Accomando read a letter received concerning the license for Tosca Marquee from the New York State Liquor Authority; NYSLA noted that the establishment was operating according to the precept's of its current license. Tosca's current carting company will change the hours of pick up to those that were followed by the previous carting company.

There was a discussion with the manager of Applebee's Restaurant about the assault that occurred; the Committee was satisfied with his explanation.

Mr. Jaen talked about ID scanners for liquor licensing establishments.
