## MOP (Juke Box, D J, Recorded Music, Karaoke, Live Music, Security Personnel)

Ms. Emily Koh, Director, Launch Services, Division of Business Service of NYC SBS introduced a program for business owners to assist them in navigating local rules and regulations to allow them to open their business sooner, rather than later. The program is called Launch Client Management and works with each business one-on-on, explaining regulations, assist in securing licenses and permits; help prepare for required inspections, ensure utility connections are scheduled and connect owners timely information that helps them manage contractors, plumbers and architects.

The management of Casa Restaurant appeared before the committee to address the circumstances that occurred on September 2. Prior to the committee meeting, Council Member Gjonaj, Assembly Member Benedetto, Chairperson Sullivan and District Manager Cruz met with Mr. Beltron, Casa Lounge owner, at Assembly Member Benedetto's office. The committee chairperson reported that Mr. Beltron apologized at this meeting and explained that this decision was a lapse in judgment. The restaurant maintains that the incident was due to a music video. Casa Lounge management, Carlos Abraham, was apologetic. The committee emphasized that the reason why this issue is of concern is the harm it can cause to the community's quality-of-life and that upholding the community's quality-of-life is to be adhered to going forward. Mr. Abraham remarked there will be no such music video recording at the establishment as long as it is in operation.

There was a motion to close the meeting by Mr. Bieder and seconded by Mrs. Guanill-Elukowich.

The meeting ended at 10:30 pm.
