Department of Health and Mental Hygiene (DoHMH) - K. Johnson, III

There were no announcements other than that Covid-19 infections continue to decrease citywide and boroughwide.

New York City Police Department (NYPD) – 45th Precinct

45th Precinct Community Affairs Officers now report to the Borough Office and were unavailable to attend the meeting but submitted the following report:
On Wednesday, March 15, 2023, late on the Third Platoon, Captain Andrew Johnson conducted an Operation in the 45th Precinct with Section Commander Toro of the Traffic Enforcement Division, to address quality of life complaints from the community by towing illegally parked commercial vehicles in the vicinity of Co-Op City. New York City Police Department (NYPD) – 45th Precinct continued

On Monday, March 13th, 2023, the Patrol Borough Bronx Special Operations Unit and the 45th Precinct conducted a Mobile Cannabis Business Inspection on Bartow Avenue, between Asch Loop and Co-Op City Boulevard, under the supervision of the PBBX Special Operation Lieutenant, Lieutenant Matthew Johnson. Location was referred to Patrol Borough Bronx by the Office of the Chief of Patrol, subsequent to community complaints. The operation was met with positive results. One (1) Criminal Court Summons was issued, and the following were seized:

122 Packages of Alleged Marijuana vouchered it for Arrest Evidence.
20 Packages of Edible Cannabis Products vouchered it for Arrest Evidence.
\$614 USC Vouchered the currency under Forfeiture.
Bus – VA Plate #TXR4651 Vouchered vehicle under Forfeiture.

New York City Transit Police - Det. Burgos, P. O. DeLuna

Lush workers committed three robberies in and near Board 10: Two at Parkchester Station and one in Pelham Bay Station. Pockets of sleeping victims were cut and emptied as they slept. Two arrests were made.

Plain clothes Officers are patrolling stations and the ferry line.

New York City Department of Transportation (NYCDOT) – J. Soto

Mr. Soto was not available to review agenda items prior to the meeting and agreed to follow up with Mr. Cruz in a day or so with updates.

State Department of Transportation (S-DOT) - T. Bayer

Project NYSDOT D264410 continues to progress without issue.

Parking restrictions on Burr Avenue and Pelham Parkway South continue. Also, median work is taking place on Pelham Parkway and may affect traffic. Drivers should use caution when navigating median work

Mr. Bayer indicated that road maintenance in the vicinity of Exit 8C is the responsibility of the New England Thruway Authority, and he is awaiting notification of a contact person. Mr. Cruz indicated that the Board's contact is Todd Gold.

<u>Transportation Dept. – Bridges - A. Zhou, R. Zurita</u>

Westchester Avenue Overpass – Steel erection will require intermittent full closures of the Hutchinson River Parkway and Westchester Avenue through Friday, March 24th.

Unionport Bridge Project – R. Zurita

Summary of work activities completed for Unionport Bridge since February:

Metropolitan Transit Authority (MTA) – M. Molina

Ms. Molina had no updates to report. The request to change the bus stop to Harding Avenue, just off Pennyfield Avenue was denied due to lack of sidewalks.

Department of Parks and Recreation - C. Acosta

There were no agency updates or announcements.

Department of Citizen and Worker Protection (DCWP) - R. Revina

Jurisdiction over street vendors has been transferred from DCWP to DSNY.

The agency is offering paid care outreach presentations concerning domestic worker rights.

Inspectors have not visited car wash vendors noted on the agenda as the agency encountered aggressive mobile vendors in the past and will only visit in conjunction with a NYPD presence.

DCWP is offering free Tax Prep by appointment.

Department for the Aging (DFTA) – J. Melendez

The agency continues to encourage seniors to return to their centers for in-person activities and numbers are increasing dramatically. The agency has been conducting an Anti-Aging Project for the past month which pairs seniors with high

school students to promote mutual understanding. Mr. Melendez requested that additional liaisons be assigned to senior centers to assist with registration for services. Ms. Dowe of the Mayor's Office will work on arranging for additional Department of Finance representative support.

Department of Social Services (DSS) – J. Bennett

1400 Blondell Avenue is on target to open during the third quarter of 2024. 2443 Poplar Street is on target to open during this summer. Mr. Cruz requested that a meeting be scheduled between Molly Parks, the new Acting Commissioner of DHS, the operations manager of 2443 Poplar Street, Ms. Bennett, and himself. Though the facility is not in Bronx Community Board 10, it boarders our community and Mr. Cruz seeks a strong working relationship with the administrators.

St. Peter's Residence – F. Coronado

Mr. Coronado was present but had to leave before delivering his report.

Citizens Commission on Human Rights (CCHR) - O. Torres

The Agency is observing Women's History Month in March and Fair Housing Month in April.
