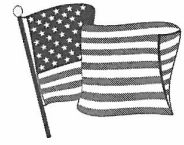

Economic Development Committee Meeting November 6, 2023

Present: T. Accomando, T. Smith, C. Brockington, J. Mondello, L. Popovic, D. Prioleau, M. Hooks, P. Caruso

The meeting began at 7 pm with the Pledge of Allegiance. All attendees were welcomed. Mr. Accomando introduced himself as Chair of this Committee, Mr. Smith as Co-Chair, and the Committee members were acknowledged as well. Mr. Accomando omitted the reading of the conduct document at this time. There were 7 Renewals and only 1 New License, all were in attendance with one exception. Mr. Accomando will touch base with that location and noted that their P.O. Report was in order. Each establishment was called upon separately and the P.O. Reports were reviewed. A discussion between each of the representatives and the Committee took place at this time. The paperwork and the Reports were in order. There was one establishment that was experiencing some difficulties with their business. Mr. Accomando expressed his concern and a discussion between the Committee and the owners took place. The Committee made some suggestions that were well received by the owners and to contact Mr. Caruso in the office for any numbers they made need. At this time Mr. Accomando called for a motion to accept the Renewals. It was made by Mr. Popovic and seconded by Mr. Smith and voted on unanimously.

He was extremely cooperative with the Committee and well presented. His mother stated that she was in the restaurant business before and would be helping out now and then.
