M. Caruso spoke on the NYCDOT property just off the City Island Bridge. There is an impending Con Edison gas line project. The City of New York evicted the squatters and demolished properties in bad repair. The goal is to honor the nautical heritage of City Island and educate the public on the ecological uses of the Long Island Sound. The City Island Gateway, LLC. submitted a maintenance agreement with the City of New York. It was denied due to the impending Con Edison project. There is private interest in purchasing the city property, according to M. Caruso. The Committee took public comment. C. Cebek recommended using the city property as a substation for NYPD and/or emergency services. T. Smith informed the Committee that if a private entity were to purchase the property, then the community would have no say on the matter. T. Kurtz informed the Committee that she is representing the Community Center and that the public-school parent teacher association should be contacted to join any discussion as well. The Committee committed to holding a public meeting when the presentation is finalized.

The meeting closed at roughly 8:10 P.M. by an unanimous vote of adjournment.
