A motion to accept the Resolution for the Outdoor Dining Application was made by Ms. Rosario, seconded by Mr. Accomando, with the following vote: unanimous. **The Resolution passed.**

- 2. Catherine Brady, community resident: alerted the Bord about the disruptive issues occurring every 4th of July on Reynolds; also added complaints about the abandoned vehicles as well as trucks parked alongside Bicentennial Memorial Park.
- 3. Ricky Collado, Leida Velazquez & Leslie Brown NYPL: Library budgets have been slashed; requested community complete funding support letter; all branches have ongoing programs for adults, teens and children.
