PUBLIC HEARING: NYC Department of City Planning's City of Yes – Housing, N240290ZRY

A Public Hearing was held on the New York City Department of City Planning's City of Yes for Housing. Representatives from the DCP office presented the proposal to the Board and community. This presentation was also done at the May 14, 2024 Housing and Zoning Committee Meeting. The Board and community were advised that any vote could include conditions. The Board's vote is due at NYC Department of City Planning by June , 2024

This proposal consists of over 800 pages of information and is broken down into sections: Low Density consisting of town center zoning, transit-oriented development, accessory dwelling units, district fixes; Medium and High Density consisting of universal affordability preference; Citywide consisting of lifting costly parking mandates, convert non-residential buildings to housing, small and shared housing, campus infill; Miscellaneous consisting of new zoning districts, updating mandatory inclusionary housing; sliver law; quality housing amenity changes, landmark transferable development rights and railroad right-of-way.
