ECONOMIC DEVELOPMENT MAY 6, 2025

Present: T. Accomando, T. Smith, M. Hooks, J. Mondello, L. Popovic. P. Caruso

The meeting began at 7 PM with the Pledge of Allegiance. Mr. Accomando addressed all in attendance and stated that he was the Chairman of the Committee and that Mr. Tom Smith was his Co-Chair. No residents were in attendance so Mr. Accomando omitted the reading of the conduct document. At this time, he stated that each of the establishments will be called upon separately. When called upon to state your name, position and what's been taking place there. Mr. Accomando will first address each establishment and then turn it over to the Committee for their questions and comments or any concerns.

Ten establishments were up for Renewal with two not in attendance. One of the establishments not in attendance was also missing a PO. Report. Mr. Accomando informed the Committee that the establishment missing the report was next to and owned buy Mamasushi and we had no problems with Mamasushi who was before us not to long ago. Mr. Accomando stated that he will follow up on both establishments and review the PO. Report when it comes in and report back to the Committee if there's any problem that needs addressing. Each establishment was called upon separately and addressed the Committee. Discussions between the Committee and representatives went extremely well. One establishment noted that their lawyer didn't file in time to receive their liquor license for Memorial Day and asked if we could intervene in the process for her. Mr. Caruso noted we filed for temporaries in the past but it became too much because too many establishments were missing the deadlines. Mr. Accomando addressed the owner and stated that she shouldn't have relied on the lawyer for filing on time. Another establishment had with the same problem. This is your business and you shouldn't rely on anybody to remind you for deadlines when it comes to your liquor license. It was suggested that she tell her lawyer to file for a two day pass so she doesn't miss out on the memorial day weekend and then get another lawyer. At this time Mr. Accomando called for a motion to accept the Renewals. It was made by Mr. Smith and seconded by Mr. Popovic and voted on unanimously.

At this time Mr. Accomando called for a motion to accept the Change in Method of Operations. It was made by Mr. Smith and seconded by Mr. Mondello and voted on unanimously.
