

Economic Development Committee Meeting Tuesday, January 7, 2025

The meeting began at 7:00 PM with the Pledge of Allegiance. Mr. Accomando acknowledged all in attendance and thank them for coming out on such a cold night. Mr. Accomando informed the Committee that there were only two PO Reports missing but the establishments that were missing had no problems in the past. And doesn't expect that has changed but will follow up when reports come in to the committee if there's a problem that needs addressing. The other five establishments had perfect PO reports with nothing that needs to be addressed. Mr. Accomando addressed the establishments present at this time. Each one will be called upon individual and for them to state their name and position at their establishment. And to give a little background on what's been going on and if there's anything the committee can do to help. He will then Address that representative and then turn it over to the committee for any questions or concerns they may have. Discussions between committee and representatives went extremely well. At this time Mr. Accomando called for a motion to accept the Renewals. It was made by Mr. Smith and seconded by Mr. Popovic and voted on unanimously.

The Committee then went on to address the two establishments requesting New Licenses. One has been in business for quite some time and just wanted to add beer and Wine to their present establishment. Mr. Accomando noted that their PO. Report was excellent. The other establishment seeking a full liquor license has another location in Little Italy and this will be their second location. The Committee informed the owner that they were right next to an establishment that had some problems in the past and to be very mindful of who is entering their establishment. Mr. Accomando asked about there are other location and if they intended on bringing over some experience staff members to the new location. They said yes they were bringing some staff members over but when asked if they were ATAP trained they replied no. Mr. Accomando stated that his staff must take the ATAP training course and explained the benefits as well. And that they can get all the information from Mr. Caruso at the office. The Committee noted the hours of operation we're OK and discussed last call time for serving alcohol. At this time Mr. Accomando called for a motion to accept the New Licenses. It was made by Mr. Popovic and seconded by Mr. Prioleau and voted on unanimously.
