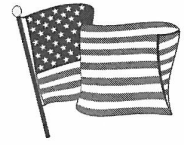

The Committee asked that the Captain continue to focus on illegal parking, illegal commercial parking, smoke shop enforcement and quality-of-life concerns throughout the community district.

Borough Commissioner Effie Ardizzone presented to the Committee. Borough Commissioner Ardizzone shared information on how to better equip homes and communities with storm resilient technologies. The City of New York Department of Environmental Protection is currently installing porous pavement, "blue belts", and flood net sensors.
